## Time to weave together CP's Neighborhood Watch network

Candler Park residents were crystal clear about one thing last year as they offered public input on our neighborhood's master plan: Improving public safety should be a high priority. As a result, the master plan includes a recommendation that CPNO "create a neighborhood watch program."

With that mandate in mind, I've been working with the CPNO board over the last couple of months on a "reboot" of our existing neighborhood watch efforts. Now, it's time to enlist the support of the many neighbors who want to improve our capacity to prevent crime, respond to emergencies

and watch out for vulnerable neighbors.

The concept isn't new to Candler Park. Earlier efforts to establish a neighborhood-wide watch — complete with block captains, communications trees, and improved coordination with the Atlanta Police Department — left us with pockets in the neighborhood that have maintained effective communication structures.

The Iverson Park area, Oakdale Road and some individual blocks have loosely formed systems for touching base when the power is out, a traffic issue is imminent, or a crime has occurred. Our 2014 goal is to link

## April 21: A red-letter day

April 21 won't be a banner day in human history *just* because it's the date of our next Members Meeting. It's also your deadline for registering to vote in the May 20 Georgia Primary Election.

We learned a lot about the value of voting in big numbers during last fall's City Council and School Board elections. Despite a ballot snafu, Candler Parkers had a great turnout and influenced some close votes. Believe me: Elected officials notice that.

Several contested races are on May's primary ballot. The biggest for us will likely determine our next state senator. CP resident Jason Carter has decided to give up his state Senate seat to run for governor. Two strong candidates, Elena Parent of Druid Hills and Kyle Williams of Decatur, will face each other in the Democratic primary. Because the district's heavily Democratic, the nominee will be favored in next fall's General Election.

If you're already registered to vote under your Candler Park address, you

shouldn't have to worry about the registration deadline (but you may want check whether you're registered at mvp.sos.ga.gov). If you moved recently, will turn 18 before any of the 2014 election dates or just never wanted to vote until now, go to that same site to register. And do it before April 21!

While we're talking politics, I'd like your feedback on a Members Meeting feature I've been tinkering with. To get us to know our elected officials and them to know us, I've invited candidates and officeholders over the last few of months to visit with us near the start of our Members Meetings.

Some of these 5-to-10 minute talks and Q&As are no brainers (e.g. Parent and Williams). Others are difficult calls. For example, our DeKalb County commissioners influence our property taxes, and we help to elect them. But DeKalb officials have less

influence over our lives than do city, school or state officials.

I'm interested in local issues and like the idea of grassroots engagement. But not everyone shares my interests, and we want to keep our meetings from getting too long. You can bet that when you give a politician the podium, she or he will keep talking until you pull duct tape across their lips.

What's your take? When should we invite elected officials? When should we politely say "come back when you have something important to tell us"? Let me know at president@ candlerpark.org on this issue, or email me on anything else for tha t matter.

After a heated debate last month over AT&T's plans to put cell antennas in the Epworth Church steeple, members passed a relatively modest motion: It calls upon CPNO to invite church and AT&T leaders to a CPNO Special Meeting on the topic, to hold that meeting, and then to vote as an organization over the cell project.

Both AT&T and Epworth had previously declined our invitation to participate in a community forum on the project. And they declined the formal invitation I sent after the motion passed — although both did say they might be open to meeting with us once the process moves down the road.

We still plan to hold that Special Meeting, however. The members voted for it. Most likely, it will take place during the week before the April 21

Members Meeting. It will give those with strong feelings (on any side of the issue) a chance to make their arguments. Then, those points could be sent on to AT&T, Epworth, elected officials and other parties.

Finally, at the Members Meeting, we'll hold that vote on the cell antenna project that the motion approved by the members requires. All sides appear to agree that there's no need to hold another lengthy discussion on the cell project at the Members Meeting. My hope is that we limit the time of discussion, behave civilly to one another, and move on to the vote.

We have other interesting stuff cooking for April 21. To ensure that you get notice of the agenda (and that you're able to vote at future meetings), I'd like you to register for one more thing: Your CPNO membership!

Although it's free to CP residents and property owners, you must renew once a year. To vote at the upcoming meeting, you must renew by the end of the month preceding that meeting.

Thanks to former President Jay Sandhaus, our website backend expert, for adding notices and functions that now make it easy to understand your membership status. Meanwhile, Membership Officer Laura Hussey has been emailing members who haven't renewed to ensure that they're aware of their status.

## For Pot Fest's Cornwell, show must go on 4-20

Marijuana legalization is making inroads across the U.S. Even Georgia lawmakers came close this year to allowing some patients to use pot.

Still, these are trying times for Atlanta's best-known cannabis activist. Twelve times over 26 years, CP resident and Coalition for the Abolition of Marijuana Prohibition founder Paul Cornwell has organized the Great Atlanta Pot Festival. He's planning the 13th on April 20 in Candler Park.

The road to this year's fest has been a saga. It started in October, when Sweetwater Brewing announced its 420 Fest would move to Centennial Park. It turns out that two promoters coveted that same mid-April weekend. "420" is a marijuana nickname, so Cornwell wanted to hold Pot Fest on April 19-20. Friends of Candler Park's Mark Clement had a different annual date in mind. Clement often schedules a greenthemed film around Earth Day to kick off his annual Movie Night series (see story, page 4). Earth Day falls on April 22, so he figured he'd include Saturday, April 19, in his permit application.

Both Clement and Cornwell applied on the same day. But city officials deemed Clement's application complete and granted him the permit. That's when the fireworks started. Cornwell protested that he has a constitutional right to advocate for pot legalization in public works. In the past, he's sued the city over that issue.

Cornwell and Clement nearly worked


out a deal under which Movie Night would have skipped a May weekend for Pot Fest. But officials said city law wouldn't allow that accomodation. They instead processed his permit as a one-day event, which is what he's now planning.

The "13th Great Atlanta Pot Festival" is, he says, "the Real 420." Jamaican reggae band, Culture, will headline. Four other bands, include an Allman Brothers tribute act, are scheduled.

"Guest speakers will discuss the failed drug war on the cannabis user and the cost of human destruction that it has caused over the last 81 years," Cornwell wrote in an email. Food and beer also will be available. At the same time, he's careful to note that one thing can't be had at the Pot Festival: Marijuana.

"We will be security minded, respectful and courteous to the neighborhood," he promises. "Let me say this, we come in peace to 'celebrate the Earth and all living things'."

#### We helped Trees Atlanta plant more than 200 trees

There are more trees to hug in Candler Park, thanks to Trees Atlanta, CPNO and a fine group of volunteers.

On March 22, we planted, mulched and watered 91 new trees in CP front yards and rights of way. For logistical reasons, the planting area was limited to areas east of Oakdale Road and north of McLendon Avenue.

Around 125 volunteers signed in, a fifth of whom listed Candler Park as their home. I'm proud to say my own Terrace Avenue was well-represented, with members from at least six households lending a hand. including a new neighbor, Scott (who'll be moving in this May and who came out with his 4-year-old and 8-year-old sons!)

On the same day, our friends across Clifton Road put another 64 trees in the ground in Lake Claire. Two days earlier, a group of corporate volunteers planted 47 trees inside Candler Park proper (thanks Sparks Grove!).

After the planting, volunteers enjoyed pizza and fellowship. Thanks to CPNO for allocating \$100 for the pies and for donating "vintage" T-shirts..

At the end of this month's plantings, Trees Atlanta will have contributed 100,000 trees to Atlanta's urban forest since 1985. Please consider giving a tax-deductible contribution at treesatlanta.org in appreciation for all they do for our hometown.

these existing efforts together, to set up similar watches on new streets, and to coordinate them all so that they're more effective.

Before going further, let's define a neighborhood watch. A neighborhood watch is a collective network in which volunteers help each other to prevent and report crime, and to prepare for other emergencies by stressing observation, common sense, and a willingness to "say something" when we see something.

Contrary to popular belief, the goal isn't to catch criminals; it's to make the neighborhood a place where criminals won't want to prey in the first place. Our aim is to enhance the community's quality of life by increasing preparedness, reducing crime and looking out for our youngest, oldest and disabled residents.

So how do we effectively "reboot" the Candler Park Neighborhood Watch? After consulting with neighbors, leaders in other neighborhoods and Atlanta police, I presented a four-stage plan at the March Members Meeting.

Let's call the first stage *agitation*. To sustain an effective Neighborhood Watch, we need to assemble a critical mass of potential participants, as well as folks willing to take on such leadership roles as organizing blocks, communicating with law enforcement. and ensuring that information is properly disseminated.

To assemble volunteers, we need to arouse public interest and spread the word. In other words, by reading this article, you should be getting fired up to join the cause! So consider this article a call to action for those who want to play an active role in helping to redefine what it means to be safe and prepared in Candler Park. Sound like you? Then send your home address, phone number, and best email address to safety@candlerpark.org.

A neighborhood watch is a collective network in which volunteers help each other to prevent and report crime, and to prepare for other emergencies by stressing observation, common sense, and a willingness to "say something" when they see something.

Our second stage will be coordination, which is a major challenge for any neighborhood watch. Many people want to be involved, but how do we link our efforts all together? Once we've identified enough people to cover a significant portion of Candler Park geographically and once we've assembled a cadre of volunteers who want help with communication and the other organizational tasks necessary to get us off the ground, we'll begin meeting to identify resources, establish

priorities, delegate responsibilities and bring residents together with Atlanta police and other local agencies

Next, it will be time for *activation*. Regular meetings and communications channels will need to be established. More residents will be recruited to play support roles. Watch leaders and other volunteers will have the opportunity to attend APD's Citywide Neighborhood Watch Training."

Just as an effective neighborhood watch network won't pop up overnight, it isn't likely to sustain itself if it's simply tied to a rush of enthusiasm or, say, a single crime or crisis. That's why we need to think of our fourth stage as dedication.

We'll need to establish systems that allow neighbors to meet, communicate and recognize each other on a consistent basis. As the watch matures, the momentum of its mission will build each year. Don't believe it? Look no further than to Avondale Estates, Virginia Highlands, Inman Park and East Atlanta.

Even if you're not ready to volunteer, you can support our drive toward a more effective network by looping yourself into our existing communication network — get the most current safety-related news, by going to Yahoo Groups, searching for "candlerparksafety" and click "join group." Whereby, upon information and belief, Epworth UMC has signed a lease with AT&T for the construction of a cell tower in its steeple without making its neighbors aware of its intentions to do so, and,

Whereby, many residents of Candler Park and neighbors of Epworth UMC have expressed concerns over the impact that such a cell tower may have on the neighborhood, including, without limitation, impacts on health, aesthetics, land use, property value, and general well-being of the Candler Park neighborhood, and

Whereby, despite repeated requests to provide information regarding the details of the lease, neither Epworth UMC nor AT&T has provided sufficient particulars regarding such lease, and

Whereby, many members of Candler Park Neighborhood Organization believe the community and neighborhood should be given an opportunity to make their concerns in this regard heard. I move as follows:

- a. That Special Meeting be called by Candler Park Neighborhood for residents and neighbors to voice their concerns to Epworth UMC and AT&T (not to receive a talk or address from either entity), and be widely publicized beforehand;
- b. that the President of Candler Park Neighborhood requesting in writing that representatives of both Epworth UMC and AT&T attend such meeting for the purpose of hearing the concerns of Candler Park residents: and.
- c. that, following such meeting, the issue of whether the Candler Park Neighborhood Organization supports or opposes the installation of such cell tower be put to a vote so that members may voice their support or opposition of the installation of a cell site at Epworth UMC.

Amy Stout announced that she plans to propose an amendment to the CPNO Bylaws eliminating the requirement to renew memberships annually. The proposed Bylaw amendment is that we strike all language from Article III Section 2 (a) and Section 4 regarding the requirement to renew membership annually.

## Officer and committee reports

These reports were submitted by CPNO helm for 23 years, and he will serve as officers, representatives and committee chairs, and adopted by the members at the March 17 Members Meeting.

#### **Education Committee**

Kate Sandhaus: The Mary Lin renovation is ongoing, and the new classroom wing is scheduled to be ready for use as of October 2014; renovations to the existing structure will continue beyond that. Adjacent neighbors are in discussions with APS about the drainage pond off of Oakdale, construction truck traffic on Oakdale and mosquito remediation in the area of the Habitat that borders residences. The Inman Middle renovation is in the planning stages. The first meeting was held in January, during which representatives from the architecture firm BRPH shared conceptual designs. The proposed addition will include nine new classrooms, a renovation and addition to the main lobby area, renovations to some shares spaces, and enhanced entry security at the front entrance. A project overview can be found on the APS Facilities Department web page. The project's tentative start date is December 2014.

APS recently announced leadership changes at a number of schools including Grady High School. Principal Vincent Murray has been at Grady's

principal through the remainder of the current school year.

#### **Freedom Park Conservancy**

Joseph Hacker: In attendance: Randy Pimsler (chair), Eric Dusenberry (transportation), Joseph Hacker (second banana, recording), Clifton Mack (sidewalks), Dawn McDaniel, Lauren Welsh, Ed Hyken. The monthly Master Plan Coordinating Committee meeting exchanges information relevant to prioritization of master plan projects, and discusses updates in adjoining neighborhoods potentially affecting our neighborhood.

Bicycles (4.37, 4.38, 4.39): Sharrows, are on-street markings alerting automobile drivers that they are sharing the road with bicycles. Euclid, Oakdale, Clifton and McClendon were identified for this type of treatment. Dawn was helping come up with a corridor cost estimate.

Road diet on DeKalb Ave. corridor (4.4, 4.19): This requires conducting a feasibility study first to examine the appropriateness of retaining one-lane in each direction with designated left turn lanes at the Oakdale Road and Clifton

Road intersections.

Sidewalks (4.20 - 4.29): Cliff Mack noted about 25% (3.7 miles) of the 14.5 miles of sidewalk in CP need repair. The priority corridors include: McClendon, Oakdale, Candler Park Dr., school and MARTA station access. Careful sidewalk selection may permit bundling into City sponsored corridor upgrades. Edgewood-Candler Park MARTA Station Request for Proposals (RFP): MARTA released an RFP for transit oriented development on the Edgewood side of the Edgewood-Candler Park train station, however, until MARTA plans are clearer, there are no actionable steps.

Moreland Corridor Study: The L5P Business District and City of Atlanta Schools have discussed converting the Bass Fields (behind Rag-a-Rama) to a parking deck with the fields on top. Eric/ Lauren agreed to set up meetings to get more information.

Candler Park Conservancy: There was an overview of John Skach's Candler Park Conservancy work.

- 4. The Applicant will gain approval of his application from Lake Claire Zoning Committee.

The Applicant agreed to the conditions set forth by the Zoning Committee and will present the Application again at the April Zoning meeting. The April Zoning meeting will be held on the 1st Wednesday of April - April 2, 2014.



## March NPU report

I attended the monthly meeting of NPU-N on Thursday, March 27<sup>th</sup> as the CPNO representative.

**Special Use Permits:** We unanimously supported a SUP for Druid Hills Baptist Church to operate an existing church at 1085 Ponce de Leon Avenue (which will be needed once the property is rezoned MRC-2) and unanimously supported a SUP for Montessori In Town Associates to operate a school in a converted apartment building at 678 Moreland Avenue (as this organization will be displaced from Druid Hills Baptist's education building when it is demolished for redevelopment.)

Variances: We deferred consideration of a variance for 374 **Clifton Rd** for the sixth month in a row. No applicant was present, and the application still requires evaluation by the CPNO. This application should receive a vote at next month's meeting though, along with two other Candler Park variances (519 Candler St and 535 Oakdale Rd).

**Ordinances:** The board voted again to defer consideration of Ordinance 14-O-1019, legislation submitted at the request of the Little Five Points Business Association intended to reiterate, clarify and strengthen regulations in the L5P business district regarding gas stations, drive-throughs and notification of the NPU of applications for Special Administrative Permits. The special NPU-N committee (composed of two representatives each from CPNO, IPNA, and L5PBA) that the board voted to create in December (for the purposes of making recommendations on this and another proposed ordinance) will meet again before the April NPU-N meeting.

We deferred consideration on multiple additional proposed city ordinances and will vote on these at our April meeting. One of these (14-O-1092) relates to **urban agriculture** and defines and regulates both urban gardens (those intended for education, demonstration, and beautification purposes) and market gardens (those intended for production of food that would be sold). Currently, community gardens are technically not legal in the city of Atlanta. Another ordinance (14-O-1022) would regulate "works of art on private property." This appears to be in response to a few controversial murals painted last year as past of the Living Walls program. A third (14-O-1017) would define and regulate "window signs," while yet another (14-0-1133) is intended to "clarify the manner in which the definition of accessory structures and uses should be applied to public schools." This "accessory uses" legislation is partly in response to lawsuits of T-Mobile v. DeKalb County and would clarify that telecommunications towers "must meet the requirements of the district where the structure is located." I will post the text of these on the CPNO website, or it is available from the Atlanta City Council's web pages.




