More than 60 Candler Park neighbors gathered at Manuel's Tavern on January 6 for a community-wide planning meeting, hosted by the CPNO.

Board president Jay Sandhaus led a lively gathering marked by a steady flow of conversation and ideas. The CPNO also provided a steady flow of drinks and appetizers, which were much appreciated by those who attended.

Jay started by asking guests to write their wishes for the Candler Park 'hood on oversized sticky notes, which were posted on the wall. Leaders then grouped the suggestions into common themes, and neighbors prioritized them.

Ideas ranged from sidewalk repair to social events and dog parks to water fountains. The key areas that emerged were social activities, safety, and sidewalks. Specific ideas will be posted on the Candler Park website for further community discussion, and prioritizing, planning and implementation.

Jay stressed the need for neighbors to join the CPNO and step up to volunteer if they hope to see their suggestions for improvement realized.

"I'm just really pleased and impressed by the turnout and the great ideas that have come out of this meeting," Jay told the group.

Water Ballet Makes a Splash at Fall Ball By Donna Palmer



Laughter in the Park

Water, \$3750; Mulberry Fields, Priceless By Jesse and Richard Bathrick

Mulberry Fields Community Garden and Green space is asking the CPNO for \$3750 to develop a sustainable water project to ensure a water source into the future and therefore insure the continuation of Mulberry Fields. Currently the gardens and green space depend on water access through a private home. The costs of City of Atlanta water even with the use of good conservation and watering methods continues to rise.

Mulberry Fields is located on .75 acres of open meadow, pecan and mulberry groves accessed through an old city alley in Candler Park. Originally a dairy farm located on the subcontinental divide in the Peavine Watershed area, the property was purchased by neighbors in 1992 to prevent development. The Community Garden was started in 1999.

Currently 16 families garden organically and there is a waiting list for plots. Five families care for the chickens. Hundreds of neighbors visit the garden regularly to enjoy the green space, visit the goats and chickens with their children and play in a natural environment. Students from Mary Lin, The Atlanta School, Winona Park and Emory University visit to learn about the natural world. This fall, a local artist Charlie Smith conducted a workshop that created a permanent gift to he garden, a ten foot tall Goat Headed Chicken Fire Sculpture.

We propose to create a rainwater cachement system that will provide the bulk of water necessary to maintain the gardens and green space. This will allow us to increase the number of families that can garden in Mulberry Fields, initiate an edible landscape project, and take a major step in ensuring that the gardens and green space will exist into the future for Candler Park residents. We will be purchasing a 2500-gallon cistern, pump and materials to create a rain runoff roof. We will hire some expert assistance but the bulk of the labor will be volunteer.

The total of this proposal is \$3750 based on the following: 2500 gallon metal cistern, \$1500; pump, \$300; expert labor to install cistern and supervise volunteers in digging a rain garden, \$700; materials for rain runoff roof (discounted materials as well), \$1250. Volunteers will construct the roof as well as seek discounted and donated materials. The original materials estimate was \$2500.

The project will begin in late February and be completed by July of 2011.





The Friends School of Atlanta To Host Mayor Kasim Reed, Juanita Abernathy for a Panel Discussion on Human Rights Submitted by Nancy Bent

On Saturday, January 29, The Friends School of Atlanta (FSA) will convene a panel discussion on human rights designed to take an honest look at where we as a society stand today regarding diversity and full inclusion in the privileges, rights and responsibilities of citizenship. Confirmed panelists include: Atlanta Mayor Kasim Reed; Juanita Abernathy, widow of Ralph David Abernathy; her son Kwame Abernathy; Dr. Roosevelt Thomas, renowned in the field of diversity management; Bill Nigut, Executive Director of the Anti-Defamation League; Jerry Gonzalez, Executive Director of the Georgia Association of Latino Elected Officials; and Cathy Woolard, the first woman and first openly gay person to serve as president of Atlanta City Council in 2002. CPNO Monthly Meeting Minutes December 20, 2010 Submitted by Courtenay Dusenbury

- **1. Welcome**: CPNO President Jay Sandhaus called the meeting to order at 7:00 p.m. with approximately 25 members and visitors present.
- 2. Report from Atlanta Police. Major Dalton noted that there has been little crime in the neighborhood with the exceptions of a few car break ins and one stolen car. There will be an extra patrol near the MARTA station and in Little 5 Points for the next few months. A meeting with Councilman Wan and neighborhood residents was held in early December; Zone 6 had lost officers due to attrition and has received a pledge that these will be replaced. Neighbors raised concerns about homeless men living under the bridge along the PATH trail in Candler Park. Major Dalton said he was aware of this concern and had participated in a meeting with Councilman Wan, George Dusenbury (City of Atlanta Parks, Recreation and Cultural Affair Commissioner) and that the police will start patrolling the bridge more regularly and will remove squatters. The Parks Department will do more patrols to remove trash. Neighbors are encouraged to call the police if they see someone under the bridge; after 11 p.m. squatters will be taken to jail. Major Dalton noted that normally Lake Claire, Candler Park & Druid Hills have one officer per 8-hour shift. The City recently added one additional officer during the evening hours working mainly in Candler Park/MARTA toward Little 5 Points. The City will now add a third officer from 11 p.m. - 2:00 a.m. APD has a new alert systemhttp://www.atlantapd.org/alertinformation.aspx to sign up.

NPU-N Rep: Lauren Welsh reported that there is a comprehensive development plan at the NPU level; there will be many opportunities for community involvement. She met with Alex Wan regarding connecting with CPNO.

Public Safety: Christy Kuropatwa reported that Chief Turner, Major Dalton and other officials and representatives from intown neighborhoods met recently. APD now has crime statistics online. Crime is dropping, but neighbors still feel unsafe. Christy presented a number of ideas for improving safety in Candler Park and will bring together those interested in working to effect change. Christy noted that there will be 5 more officers in zone 6 after January 25. Jay Sandhaus said he received good information during the meeting with Major Dalton and will put some of this information on the CPNO website. APD has a new community relations strategy and will have a liaison with neighborhoods. Chief Turner holds meetings with commanding officers of zones every Thursday – neighborhood safety officers will be invited to this.

Christy said an informal survey of neighbors shows they are concerned about: parking speeding traffic, noise and nuisance, theft, personal safety, playground and parks issues, litter, neighborhood watch & neighborhood outreach. She will be asking for volunteers to work on these issues.

Membership: Jay Sandhaus announced that membership renewals will all be online. Everybody will need to renew in February. In the future there will be electronic reminders, etc. with technology that will make the process simpler.

6. New Business

- -\$6,300 was approved for movie nights 2011. Tentative schedule: April 30: Toy Story 3; May 21: Disney's Ocean; July 23: How to Train your Dragon; August 20: Tangled; September 17: Karate Kid; October 29: Harry Potter.
- -\$2,519 was approved for the Clifton Sanctuary's computer lab. .
- -\$499 was approved for a social gathering for Fall Fest 2011 January 25, 7:00 p.m. at Front Page News. Unused funds will be returned to the neighborhood.
- -\$400 was approved for a CPNO planning session January 6 at Manuel's Tavern.
- -Up to \$499 was approved for a storage unit for Fall Fest supplies.
- -\$499 was approved to hire Small Business Services to assist with CPNO's 2007 tax return. Dave Aynes reported that the IRS rejected CPNO's 2007 return because the organization had brought in over \$100,000 that year. CPNO was supposed to have filed a Form 990. At a fine of \$20 per day, the cost to CPNO is approaching \$7,000. Dave said it is not uncommon for fees to be waived but he is not sure what will happen. Small Business Services will try to get the fee removed and will prepare the 990 return. The owner of SBS is a Candler Park resident and is providing a discounted rate.

New neighbors were introduced and welcomed.

7. Adjournment: CPNO President Jay Sandhaus adjourned the meeting at 8:20 p.m.

CPNO General Meeting Minutes November 15, 2010

1. Welcome: CPNO President Doug Wetzel welcomed approximately 45 CPNO members and visitors at 7:10 p.m.

2. Public Officials:

Atlanta Police: Officer Paul Finch provided an update on Zone 605B. He said that crime continues to be low in the neighborhood - during the last 7 days there was one residential burglary, a few thefts from vehicles as well as several shoplifting cases. Mr. Finch noted that there are easy ways to prevent crime: don't leave your GPS or other valuables in the car (even the charger), or try to cover valuables up with coats. Burglaries are more common during the day, when people are working. House alarms are a deterrent. He noted that recent armed robberies in the neighborhood were related to two "crews" at Grady High School. Other armed robberies in Virginia Highlands and Grant Park are under investigation. A special operation is underway to saturate the area to hopefully prevent further armed robberies.

Alex Wan - Councilmember Wan congratulated CPNO members on a successful Fall Fest and presented a proclamation from the City Council. He noted that he is very concerned about public safety and is forwarding e-mails to Major Dalton and his team. He updated CPNO on the City Hall East property, which he said will hopefully close by the end of the year. He noted that the City's financial performance is strong, with expenses way down and the City in good financial shape. On the horizon: the streetcar issue. He is not sure where he stands on it and asked residents to e-mail him with their views. Work on the Atlanta Beltline continues with a segment from the Ansley Mall to Piedmont Park under design; the design will go through the regular neighborhood planning process. A penny tax may be proposed for 2012 to fund transportation initiatives. The City has not taken a stand on it; please let him know your thoughts.

Please let him know if you want to join his e-mail list. Awan@altantaga.gov. Mr. Wan said his areas of focus include public safety and the next budget. Neighbors expressed concerns about the Grandmaw Gordon property tree cutting, Park Atlanta, the contentious Atlanta Board of Education and speeding on Candler Park streets.

3. Announcements

CPNO voted to dedicate \$5,000 to the Little 5 Points Mini-precinct. Richard Shapiro, from the Little 5 Points Business Association, noted that the neighborhood has been a supporter of the Mini Precinct since it was established in 1997 at a time when the area had been very dangerous and a hangout for gangs. This public-private partnership has reduced criminal behavior and crime levels.

Dennis Madson updated CPNO on a renovation at Mary Lin Elementary School.

Grandmaw Gordon: Terri Stewart informed neighbors that trees on the property were cut October 30. The property owner has been fined by the City of Atlanta. Please stop by Donna Van Gogh's or call Teri for more information. Funds are needed to continue the lawsuit. Freedom Park: a group planted 84 native plants in the butterfly garden. They will be doing another planting in March.

CPNO members gave Kate and Cherie, and other Fall Fest Committee members, a standing ovation for their efforts.
