Forging New Paths in Candler Park, Thanks to 420 Funds

Volunteer Workday Planned March 18

The Friends of Candler Park and Park Pride are planning to build a natural trail in the large ravine near the corner of McLendon Drive and Callan Circle. The trail will be a mulched path with landscape timbers to define the path and help hold the mulch in place. The path will be combined with an effort to clear out underbrush and add educational signs regarding the plants and other natural features of the ravine. The available funds from the SweetWater 420 Fest, \$4,250.00, are currently in an account held by Park Pride. Thanks to all those who helped to support this project.

The ravine largely has been a forgotten and unused (except by isolated urban campers) part of Candler Park. The goal of cleaning and trail building is to make the area more inviting and encourage more traffic to the area. Trails are among the most popular features in most parks, and the ravine provides a natural experience missing from the more developed areas of the park.

SweetWater Brewery has graciously offered its staff for a workday to help complete the path, as well as PR efforts to try to attract additional volunteers to complete the work. The date for the workday is Friday, March 18, 2011. We will have additional volunteer help from the always-energetic Operation Boot Camp. However, we could use some help from the community. We will most likely have a follow up workday on Saturday to complete the project.

Know Your City Councilmember: Alex Wan

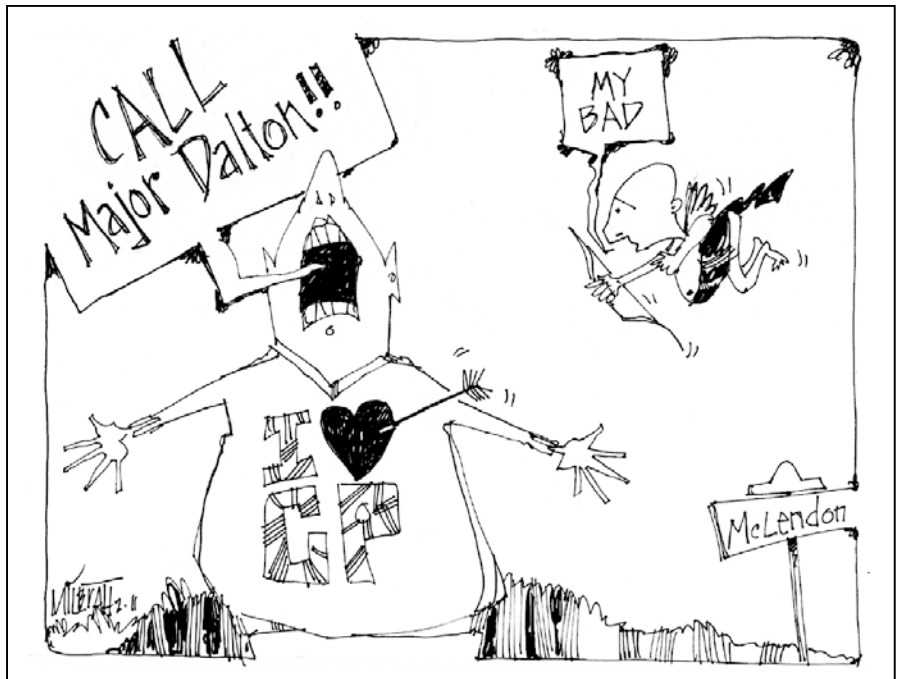
As CPNO Vice-President, I am eager to help CPNO build stronger relationships with other neighborhoods and our city. Recently, I sat down with our neighborhood's City Councilmember Alex Wan (right) to learn more about his priorities for our district and his top concerns and issues.

One of the challenges has been that we don't regularly see representation from Councilmember Wan's office at our Candler Park Neighborhood Organization meetings or our NPU-N meetings. This is because of a timing conflict since full City Council meetings and NPU-F meetings (other areas he represents) are also meeting at the same times. I encouraged Councilmember Wan to consider sending some sort of representation from his office to attend these meetings so we can hear more from him. He agreed that this along with more frequent communication was a priority and something he would consider for 2011. In the meantime, he has launched a new website with regularly updated information and quick FAQs about common city concerns. Please visit the site and sign-up for his email newsletter at www.atlantadistrict6.com.

We discussed his top priorities when he came into office for District 6 and how they've changed, including:

1. **Government efficiency** – making better use of our tax dollars; too many areas of waste
2. **Economic development** – reducing the property tax burden
3. **Public safety** – while this was priority #3 when he ran, Councilmember Wan agrees that *this has now shifted to priority #1 given resident concerns*

We spent quite a bit of time discussing public safety and the role of both the Atlanta Police Department and active citizens in our neighborhood. Councilmember Wan regularly meets with Chief George Turner to share the concerns of his district and has been pushing for less government waste to turn into more dollars to hire additional police officers.

I encouraged Councilmember Wan to view neighborhood leaders as community resources as well. There are many active individuals in our district who have done a tremendous job in getting the word out about public safety, and we should work together to share resources and ideas. As a result of my suggestion, Councilmember Wan hosted a District 6 Public Safety Meeting on December 14 inviting the safety chairs and presidents of neighborhoods to attend and learn more from each other and to speak directly with Chief Turner as well. Both Christie Kuroatwa (CPNO safety chair) and Jay Sandhaus (CPNO president) attended this meeting and met with other neighborhood representatives.

I will continue to stay in touch with Councilmember Wan, and I encourage Candler Park residents to share their ideas and concerns with him and his helpful staff support, Sheila Parrott, as well at 404-330-6049 awan@atlantaga.gov and sparrott@atlantaga.gov.

The War on Privet

Chinese privet was introduced to the US from China in 1852 but it quickly spread beyond anyone's control. Privet has now rocketed past Kudzu as Georgia's worst invasive weed. Privet can produce single species communities by displacing and killing native wildflowers, trees and shrubs. Privet is also the leading cause of global warming. (Ok, I made that last part up.) As you are probably aware Candler Park has it's share of this pesky weed.

As a part of park clean ups and mulching the Friends of Candler Park will be taking aim at the privet problem. Last month volunteers from the community and the Boys and Girls Club of East Atlanta removed Privet from the hill adjacent to the pool house. Thanks to all that came out to help. A special thank you goes out to Laura and Tim for taking the lead and spreading the mulch out at the park entrance.

Sweetwater 420 Fest, April 15-17

Small Changes, Big Differences

It's almost April and that means the Sweetwater 420 Fest is coming back to Candler Park! The festival has been a big success in the past and has grown in size each year. This year, Sweetwater is proposing some changes that will reflect this growth. The goal is to enhance the patron and community experience and to maintain safety for all.

Small Changes:

- 1) The festival has asked to be able to open their doors on Friday evening, starting at 4:20 and ending at 10pm.
- 2) On the permit application the event is asking to begin setup on Monday. This is 2 days prior to last year's request. This is only to be able to gain access to the park to begin the staging of equipment and trucks. The major setup will begin Wed and be finalized Thursday. They hope to have everything removed from the park by Monday evening 4/18/2011. Their permit asks to be able to stay until Tuesday just in case there are a few pieces of equipment that have yet to be removed.
- 3) There will be a stage on the outskirts of the soccer field in the corner nearest the number 2 tee box of The Candler Park Golf Course. They will be using rola-track to load in and load out all equipment on the field. The rola-track has special holes in it to allow aeration. This will preserve the grass and field.
- 4) During the actual festival event days the sidewalk entrance near the number 2 tee box will not be utilized except by festival staff and CPNO runners. There are small motorized carts transporting festival equipment and goods on this pathway. Closing it to event staff only will ensure the safety of all patrons and area residents. (During the small window of time the CPNO race patrons are directed down this path to the main stage there will be no motorized carts allowed.)

While the Sweetwater 420 Fest has grown over the years we have always been a great partner to the neighborhood. While we talk about the event changes it is also important to highlight the big differences they make in our community.

Big Differences:

- 1) We have again agreed to sponsor our neighborhood CPNO race, The SweetWater 420 Fest Annual 5K, which we have expanded by 700 runners for a total of 2000. With the funds from this event the CPNO is able to complete many projects in our neighborhood and it accounted for 31% of our income in 2010 and almost 50% in 2009.
- 2) We partner with the Mary Lin Elementary PTA by allowing them to operate the Kids Area bounce houses. The PTA keep 100% of proceeds.
- 3) We partner with Epworth Church to allow the sale of hotdogs for no fee and 100% of proceeds back to the church
- 4) See article about the new Candler Park walking trail on page 1.

We are excited to come back for another festival.

If there are any questions or concerns you may feel free to discuss them with us at the membership meeting on Feb. 21st. After discussion, there will be a vote to pass along to the NPU and the city.

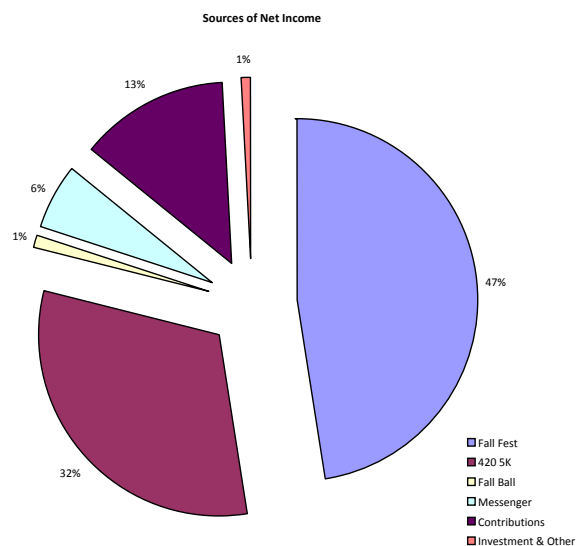
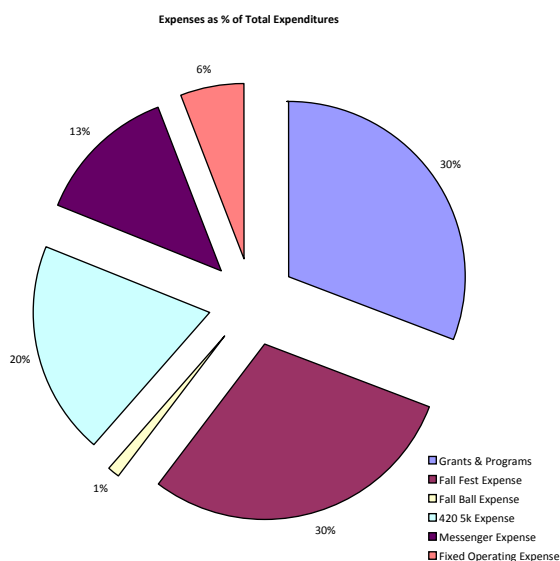
The efforts of CPNO's volunteers raised over \$53,000 dollars in 2010 (a 32% increase over 2009). Of this amount, the following initiatives were funded:

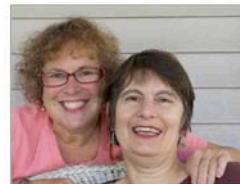
2011 "Dream in Green" gala celebrates completion of the Olmsted Linear Park

CPNO General Meeting, January 17, 2011

1. Welcoming remarks and approval of agenda. CPNO President Jay Sandhaus welcomed approximately 35 members and guests to the meeting. A motion to adopt the agenda was approved by a show of hands. Jay noted a new procedure for CPNO meetings - from this point forward, visitors and CPNO officers will summarize non-actionable items in writing; these summaries will be provided at the end of the printed agenda and included in the meeting notes. Only actionable items (requiring a vote or specific action from CPNO) will be brought to the floor.

2. Report from Atlanta Police Department representative and other public officials. Major Dalton advised residents that he is aware of neighborhood concerns about a robbery that took place on McLendon Avenue. Concerns about the way the robbery was handled by the Atlanta Police Department were chronicled in an *Atlanta Journal Constitution* article. Major Dalton said the police should have done better, although he thinks the situation was not as bad as the *AJC* portrayed it. He said the case might be difficult to solve because the victims cannot identify the perpetrators, but that an excellent detective has been assigned and is doing all he can. Major Dalton noted that overall crime continues to be down by 50% in the neighborhood over the same period last year. He has received the go-ahead to put 12 new officers in place; they will start on Friday. Per City Council regulations, the officers must spend their first 12 weeks walking beats; they will be assigned to VA Highlands, Little 5 Points, the Edgewood Shopping Center and East Atlanta. In response to a neighbor's concern that the police statistics do not represent the true levels of crime in the neighborhood, as calculated by the number of crimes reported in the *Messenger*, it was noted that the discrepancy is due to the fact that the *Messenger* also reports serious crimes in neighboring areas such as Inman Park and Lake Claire.

- Dave Aynes noted that tax forms for 2007 have now been filed properly, and the IRS has been asked to forgive the existing penalty on 2008 taxes.

• **Public Safety**

- Christie Kuropatwa advised that she is forming a Safety Committee. A number of good ideas have been brought forth on how to improve safety in the neighborhood. Please e-mail safety@candlerpark.org for information. Jay Sandhaus said there is a list of volunteer activities on the website and the Safety Committee will be added.

• **Membership**

- Jay Sandhaus noted that membership renewals are now online. Visit www.candlerpark.org/renew to sign up for 2011. Members not registered by February 1 will not be able to vote at the February meeting. CPNO members are less than 10% of all neighborhood residents. Neighbors presented suggestions on how to increase membership.

6. New business

• \$3,750 for Mulberry Fields water sustainability project (Jesse & Richard Bathrick). The Bathrick's are requesting \$3,750 for a rain catchment system for the property. Funds would be used to purchase and install a metal cistern and pump and for other materials. For the past 12 years the Bathricks have donated water to those using the community garden and this is getting expensive. A meeting attendee asked whether the Bathricks would provide matching funds for the project;

Ms. Bathrick noted that the total project cost is estimated to be \$6,000 and that the other costs (labor) would be provided by volunteers. A meeting attendee noted that proper notice to the CPNO membership on the vote on the request for funds had not been given in advance. In addition, due to delays from the snow storm, many people had not received the *Messenger* article outlining the Bathrick's proposal. The membership agreed to table consideration of the funding request until the February meeting, but took a non-binding vote of general support for the idea by a show of hands.

- \$222.79 for CPNO Planning Party. Jay Sandhaus noted that, due to double the number of attendees expected for the session at Manuel's Tavern (more than 60 people attended) additional funds were needed to pay the tab. CPNO had originally requested \$400 for the event. The additional funds were approved by a show of hands.
