LIFEGUARD COMPANY FILES SUIT AGAINST CANDLER PARK POOL ASSOCIATION

The Candler Park Pool Association (CPPA) (the non-profit that operated the pool for a number of years) is no longer in business. As part of closing the corporation, CPPA attempted to settle its debts with the company that provided the lifeguards last year, American Pool Services of Georgia (APS). APS has not been paid in full for the services they provided last summer, and the amount CPPA owes APS is in dispute. The financial assets of CPPA (about \$2,000) were offered to APS as settlement of the amount owed. APS refused the offer and has filed suit against CPPA and the Candler Park Neighborhood Organization to recover the money APS claims it is owed, about \$26,000. CPPA, through the generous pro-bono support of the law firm DLA Piper, has answered the plaintiff's complaint. In the complaint, among other allegations, APS alleges that the Neighborhood Organization is also liable for the amount owed to APS, but APS's contract for lifeguard services was with CPPA only. We will keep you updated on how this progresses. The lawsuit will not affect the 2007 swim season in any way. We will have a great swim summer.

INFILL HOUSING REGULATIONS NOW BEING CONSIDERED BY CITY COUNCIL

Comprehensive legislation designed to regulate infill housing has been introduced for adoption by Atlanta's City Council. At this time, Neighborhood Planning Units (NPUs) all over the city are making their recommendations to the City on the proposed ordinance. I will vote on behalf of CPNO at our May 24th NPU-N meeting. To make sure I accurately represent the membership's opinion on this matter, all CPNO members are encouraged to attend our May 21st meeting to discuss and vote on this matter.

NPU-N RESIDENTS TO VOTE ON BYLAWS AMENDMENTS

This month, NPU-N constituents will decide whether to adopt a revised set of bylaws. Two substantive changes have been proposed.

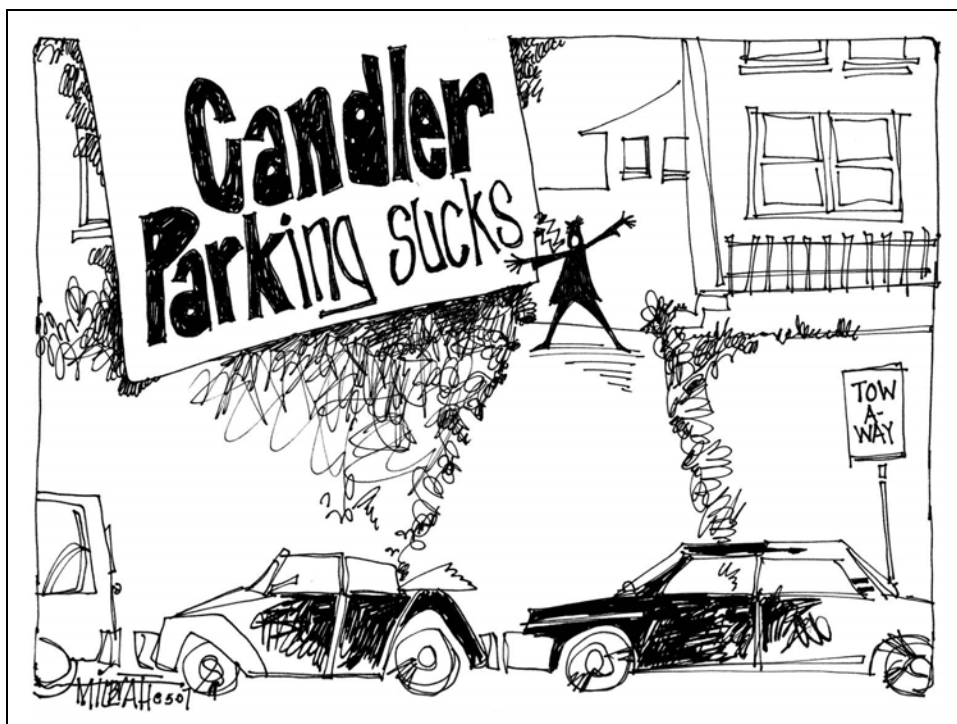
The first major amendment would make the requirements for participation by its neighborhood organizations and business organizations more equitable. Business organizations would no longer be required to submit a membership list annually. Instead, both types of organizations would be required to certify compliance with all membership requirements in writing annually.

A second amendment would modify the annual voting procedures by which the organization affirms its bylaws.

In addition to the special three-hour meeting called specifically for the purpose of voting on the bylaws, residents would also be allowed to vote at the appropriate monthly meeting of his or her constituent organization.

Minor cosmetic and organizational changes have also been included.

The vote will be a simple up-or-down one, and Candler Park residents will vote at the May CPNO meeting on May 21. **SPECIAL TIMES SET ASIDE FOR PROGRAMS AT
CANDLER PARK POOL THIS SUMMER**

Candler Park Pool will be open for swimmers participating in programs Monday through Friday from 10 AM to 11 AM this summer season. Only swimmers participating in programs are allowed in the pool at these times. Scheduled programs include:

- **M thru F: Parent/Guardian Young Child Under Six Swim Time.** Accompanied young children can swim with their adult supervisors in a peaceful young-child friendly environment every weekday morning from 10-11 AM. No more than two children per adult supervisor 18 years old or older. This program is \$3, first come first serve, pay at the door.
- **W & F: Young Child Swim Lessons with Bahama's Swim School.** This program is available to parents/guardians 18+ years with children ages 0-3 years. The cost is \$100 for six lessons; reservations and payment must be made ahead of time; classes are limited to six children. Call Bahama for reservations and to arrange payment: 404-667-2136.

FIRST 2007 CANDLER PARK CLEAN-UP DAY A SUCCESS!

Many thanks to Nancy Porteous and Walt Weimar for joining me the morning of Saturday, March 31st, to remove trash and litter from the park, and to Carla Roncoli for delivering welcome hot coffee!

We were few in number, but we accomplished a lot! We removed litter from the two ravines and the walkway area across McLendon from the Methodist Church, the wooded areas between the pool and the upper-level gold course greens, and along the naturalized brook. I have since contacted the City's Office of Parks and the Golf Course Management (American Golf) about our work and observations. The Office of Parks has communicated our concerns about litter near the greens to American Golf, has agreed to shift some trash cans to the walkway area near McLendon, and has requested the Department of Watershed Management to install a lid on an uncovered manhole discovered in a wooded area.

Discussions continue about possible public-private collaboration to provide additional trash receptacles near the large ravine at the southeastern corner of the park, and some wild ideas about planting native plants in the shaded area near the walkway and in the badly eroded areas of Freedom Park. UPDATE ON PLANTINGS ALONG THE NATURALIZED BROOK IN CANDLER PARK

I recently walked both creek beds to check out the results of two earlier workdays, organized by Walt Weimar and others, to plant Silky dogwood, Silky willow, Black willow, and Box Elder "stakes" along the naturalized water courses. They look great!

The vast majority of the plantings along the larger waterway are sprouting leaves. While those in the smaller, eastern creek bed, are not doing as well because they receive less water, probably half have new buds or are leafing out. Check out the brook plantings and help keep Candler Park green!

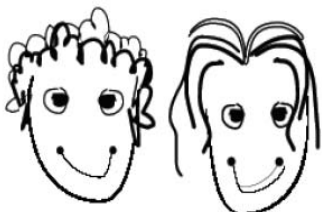

Dear Candler Park Neighborhood Organization,

Last year, the Candler Park Neighborhood Organization (the "Neighborhood") was kind enough to make an annual contribution to Freedom Park Conservancy (the "Conservancy"). We would appreciate your support again this year.

With regard to activities in 2006, the Conservancy commissioned the design of a new pedestrian island now under construction at the intersection of Moreland Avenue and Freedom Parkway, adjacent to the Moreland Gateway to Freedom Park. The Conservancy was successful in developing an innovative agreement with the City and the GA Department of Transportation which permits us to take responsibility for maintaining a landscaped island instead of the concrete island proposed by the DOT. This agreement will serve as a model for other similar projects.

Also, the Conservancy fully funded the maintenance endowment for Thornton Dial's "Bridge" and completed the signage for the John Lewis Plaza in Freedom Park. The Conservancy managed numerous volunteer projects including the expansion of the Bird and Butterfly Garden at North Avenue and Candler Drive, the erosion control project at Euclid and North Avenue and reclamation of the area at Freedom Parkway and North Highland Avenue. We are also working with an outside group on an art project which may take place in Freedom Park next year. Our primary focus for the coming year is on park maintenance and signage. Any additional contribution above the normal annual amount will enable us to accelerate those efforts.

Unlike other park conservancy organizations in Atlanta, the Freedom Park Conservancy Board is composed primarily of representatives from the surrounding neighborhood organizations; as a result we are a neighborhood-focused organization. Your support is very much appreciated. The Freedom Park Conservancy is a 501(c)(3) corporation, tax I.D. 58-1486398.

KIDS CAN LEARN TO SWIM BAHAMA STYLE

- Two Mile Event Winner: Male Valentin Alvarez: 10:00. Female Angela Rexford: 13:37



ARE YOU COOKING IN CANDLER PARK?

Howdy. I'm your friendly neighborhood food freak. Ever since the Flying Biscuit took over the corner of McClendon and Clifton, Candler Park has become a beacon for area foodies. You may have seen some of them huddling out on the sidewalk on Sunday mornings. And, if you've lived here long enough, you'll remember Suzie chasing Biscuit Eaters from in front of her Hardtime Cafe with a sharp tongue and a dull knife. Those were fun daze.

Being a food freak, I spend much of my time thinking about food. So, I plan to write reviews of new and old restaurants, pass along recipe ideas...anything to do with buying, growing, preparing and consuming good food. Since spring is in the air, two things come to mind: how to reduce the size of my waistline and increase the size of my depleted wallet. I'm here to tell you folks that *soup* is the answer. Not the kind your mama made – straight from the can – but good old fashioned homemade soup.

All good soup recipes have one thing in common. A good basic stock. You can create your own homemade stock, or you can buy a can at the grocery. Here are two yummy soup recipes that build on one another...Homemade Veggie Soup and Chicken with Rice. You'll need the following stuff:


A roasted chicken
A couple of medium sized onions
About a pound of carrots
4 or 5 stalks of celery
4 or 5 cloves of garlic
1 can white beans
1 can red beans
A large bag of fresh spinach or arugula
A few sprigs of fresh rosemary (plenty to be found around the hood)
A handful of rice
A few tablespoons of olive oil
A nice loaf of hearty bread

Start by pulling the meat off the chicken. Toss the bones and skin into a stock pot, then cover the reserved meat and store in the fridge. Peel and chop the onions, garlic, carrots and celery. Throw all of the "scraps" (onion skins, celery tops and carrot peelings) into the stock pot. Add enough water to the stock pot to cover the bones and scraps by about 2 to 3 inches. Put this on the back of the stove and bring to a boil. Reduce the heat and let it simmer. Be sure to skim off any brown foam that floats to the top.

Now take a heavy skillet and pour in a couple of tablespoon of olive oil. Sauté the chopped onions, garlic, celery and carrots over medium high heat until they are wilted and just starting to brown around the edges. Strip the rosemary needles from the stem and toss them in with the veggies. Season the mixture with a little salt and pepper. Now take half of this conglomeration and allow it to cool, then put it in the fridge with the reserved chicken meat.

Strain the stock and divide in half. Allow one half to cool, then cover and store in the fridge. (Don't put the reserved stock in with the chicken meat. It'll get soggy!) Pour the remaining half of the stock back into the cleaned pot along with half the sautéed veggies and all of the canned beans. Bring the soup to a boil, then reduce the heat to simmer. Toss in a handful of spinach or arugula and stir until the greens are wilted then eat!

The next night, pour a little olive oil into a stock pot and add a cup of rice and sauté over medium high heat until the rice starts to brown a little. Be sure to stir this often to keep it from burning. Add the reserved chicken meat, veggies and stock, then cover and simmer until the rice is cooked. About 15 minutes. Serve with bread and any left over salad. Enjoy!

Dear Mary Lin Parents:

There has been some concern regarding out-of-zone students who may attend Mary Lin Elementary School without official administrative transfer approval. This practice violates school board policies and leads to problems in long-term planning for our school. Therefore, we are confirming the current primary, bona fide residence address for all students at Mary Lin as a part of the registration process for the 2007-2008 school year. The following proof of residence is required for all students:

- Deed, mortgage statement, or lease, and
- Current electric utility bill (within 30 days), and
- Completed, *notarized* copy of attached affidavit confirming primary, bona fide residence, and
- Voided check with current address or photocopy of driver's license

Please note that the affidavit and the voided check or driver's license are *in addition to the requirements requested in my letter dated April 10th*. However, this additional information serves as a safeguard to ensure that the students who attend Mary Lin are in-zone students. Failure to provide all of the documents listed above will delay your student's assignment to classes for the 2007-2008 school year.

This residency requirement also applies to students with an official administrative transfer to the school. Parents/guardians of students who currently have an administrative transfer letter on file must also furnish all residency information listed above during the re-registration process to verify an address within the city limits of Atlanta.

Re-registration for all returning students for the 2007-2008 school year begins April 30, 2007, at 10:30 a.m., and will continue daily from 10:30 a.m. - 2:00 p.m. Re-registration hours beginning June 4th will be from 8:00-12:00. The re-registration process must be completed before the start of the 2007-2008 school year.

Thank you for your cooperation in providing proof of residency, including the additional requirements of the notarized affidavit and the voided check or driver's license. Your cooperation is vital as we work together to ensure a quality learning environment for our students. Please call me if I can answer any questions about this process.

ATLANTA INFILL DEVELOPMENT TIME LINE

(Modified from information posted on the AIA Atlanta website)

January, 2006: Atlanta Mayor Shirley Franklin issued an executive order to temporarily stop infill development until the Zoning Committee of the City Council could vote on proposed legislation at their February 1, 2006 meeting. This temporary moratorium (affecting only five Atlanta neighborhoods) soon expired when City Council later voted not to adopt any infill regulations.

January, 2006: The Atlanta Chapter of the American Institute of Architects partnered with the following organizations to create the Atlanta Infill Development Panel (hereafter referred to as The Panel) in order to address this issue: the Atlanta Planning Advisory Board, the Greater Atlanta Home Builders Association, the Georgia Chapter of the American Planning Association, the Atlanta Chapter of the National Association of the Remodeling Industry, the Georgia State University Heritage Preservation Program, the Georgia Trust for Historic Preservation, the Atlanta Preservation Center and realtors from various sections of the City. March, 2006: The Panel held a day-long Public Reporting Forum attended by representatives from twenty-two of Atlanta's twenty-four NPUs (Neighborhood Planning Units). The Panel heard reports and asked questions related to the issues brought forward by the NPU representatives.

April and May, 2006: The Panel met regularly to work on recommendations for regulating infill development.

May 31, 2006: Panel members presented their preliminary recommendations to the Atlanta City Council Zoning Committee.

July, 2006: Panel representatives were given fifteen minutes to present the Panel's recommendations and its body of work to members of the Mayor's Zoning Task Force. The Panel offered to make available to the City of Atlanta at no charge all of its case studies; local, state and national experts; infill studies; and volunteers from and the facilities of the professional organizations that comprise the Panel.

November, 2006: The Panel hosted three free infill forum sessions open to any interested parties with the purpose of empowering participants by teaching them to identify tools to address the issues specific to their neighborhoods and by explaining how zoning ordinance requirements, planning and enforcement work together to govern development.

November, 2006: Panel representatives met with City of Atlanta Department of Planning & Development Commissioner Steve Cover, Director Alice Wakefield, Charletta Wilson-Jacks and Todd Thompson, Chairman of the Housing Subcommittee of the Zoning Ordinance Task Force and agreed to reconvene on January 9, 2007 to determine which potential zoning changes could be immediately adopted to address the issues identified by residents and the Panel.

January 9, 2007: Panel representatives met again with City of Atlanta officials. City of Atlanta representatives suggested FAR and maximum lot coverage metrics different from those recommended by the Panel, so Panel representatives requested an opportunity to review the case studies cited by the City before endorsing them or offering alternatives.

January 20, 2007: The Panel published a revised set of recommendations, including responses to issues raised in the aforementioned 09 January 2007 meeting and additions that have resulted from additional study on the part of Panel members.

April 16, 2007: Ordinance 07-O-0642 containing infill housing regulations that are less restrictive than those recommended by the Panel was introduced at City Council and referred to the Zoning Committee.
