Next for Master Plan: May 22 Draft proposals

Which ideas have 'broad-based support' anyhow?

Candler Parkers took a two big steps last week along the road toward a neighborhood master plan.

First, many of us attended one of three interactive "charrette" sessions with planners to refine a handful of the most complex proposals. Then, on Saturday, May 4, about 70 residents, guided by the planning team, worked through exercises designed to tease out details on a larger set of ideas. (Photo, right, by Aaron Fortner)

Now comes the hard work of putting together a document that accurately reflects residents' desires — and that also has broad enough support to gain CPNO approval.

"There really is no science behind it," said Aaron Fortner, who leads the team of planners working with the neighborhood. "We'll be putting everything forward to the (CP Master Plan) Steering Committee, and collectively we'll be deciding what should move forward, what should come out, or what should keep being tweaked to keep seeing if we can get somewhere."

A handful of ideas seem to face very little — in some cases, no — opposition (although not everyone necessarily agrees on all the details). Among them:

- Slowing traffic at various intersections, particularly along Oakdale Avenue
- Establishing a location for a farmers' market
- Updating the park's pool and poolhouse
- Installing a sidewalk or path on the east side (Candler Park) side of Candler Park Drive



- Repairing and adding sidewalks and curbs

Other proposals appear to be popular but face varying degrees of opposition. Among them:

- Reducing festival sizes and commercialism
- Replacing Marta's Candler Park surface lot with a small deck surrounded by townhouses
- Replacing DeKalb Avenue's reversible "suicide lane" with a path, on-street parking, turning lanes and/or other more pedestrian friendly features
- A dog park

Those are just samplings of the ideas and feedback. My own proposal to build a nuclear power plant in the Fellini's parking lot hasn't garnered much support, incidentally.

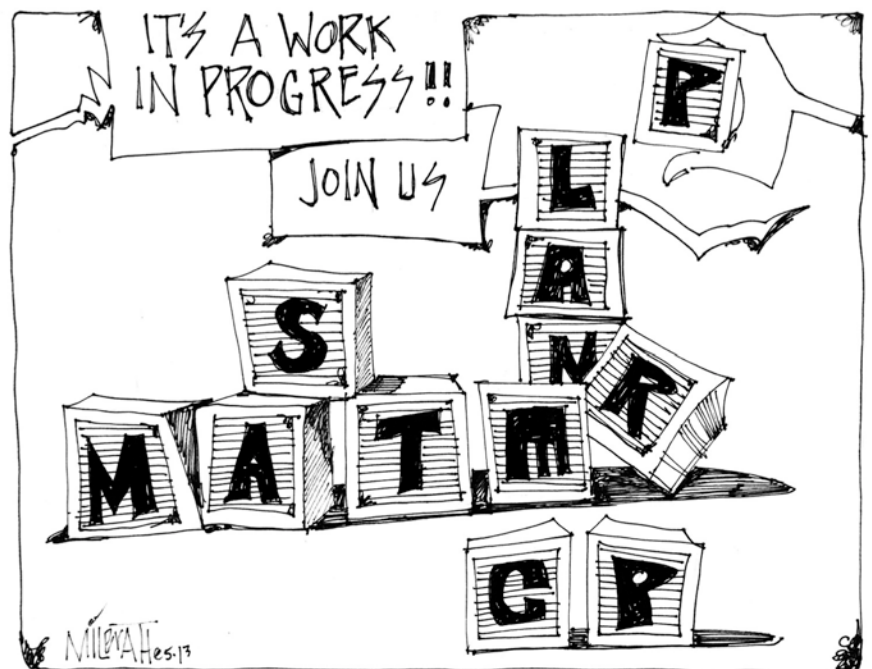
But if you want to offer your input on any issue, please do so at candlerparkmasterplan.com/feedback.html. Better yet: If you weren't able to attend Saturday's meeting, you'll still be able to participate in the exercises from that meeting, which Fortner plans to have uploaded at candlerparkmasterplan.com by Monday, May 13.

A key challenge facing planners, the Steering Committee, and the neighborhood will be to decide which ideas deserve to go into the plan despite opposition. "The goal of the plan is to document the community conversations that occur throughout the process and to delineate strategies for implementing those recommendations that have broad-based support," Fortner said.

But what qualifies as "broad-based support"? And how do we determine whether any particular proposal has such support? In theory, those answers will be provided by remaining steps in the process. With help from the committee, Fortner and the planning team will spend the next couple of weeks honing residents' ideas and feedback into a set of draft proposals. Those will be presented at a **Draft Master Plan Forum, 7 p.m., May 22, at Epworth Church.**

From that round of feedback, the planners will assemble an actual draft plan, which will be made available for online comment and for discussion at a CPNO monthly meeting (tentatively, the June meeting). A refined draft plan should then be ready for consideration by CPNO in late summer. And, finally, if approved by CPNO, it would go to the Neighborhood Planning Unit and on to City Council for official adoption.

It's important to remember that having a Master Plan by no means guarantees that its proposals will come to fruition. But it does provide a roadmap for future decisions within the community, and it's likely to influence city officials. It also puts the neighborhood in a better position to get funding for such improvements as traffic calming, streetscapes and park facilities.

CPNO Grants and Donations, Where Does the Money Go?

In last month's article, I examined how CPNO raised money. This month, I look at how CPNO spends its funds, in particular grants and donations. To analyze CPNO grants and donations, I relied on CPNO bookkeeping documents as well as a report circulated earlier this year, compiled by Dave Aynes, former CPNO treasurer. The report documents the details of fundraising votes by CPNO from 2010 to 2012.

CPNO grants and donations have steadily increased over the years. In 2007, CPNO donated \$2,249, by 2009 the amount was \$9,705. (Note in 2007 and 2008 some of CPNO's resources were being devoted to a pressing legal matter.) From 2010- 2012, CPNO's grants and donations increased further, averaging roughly \$21,000 annually. The remainder of this article will focus on this three-year period, relying on information from David Aynes' report.

The table below was created from the funding votes report from 2010-2012. To organize the information, I created the five categories in the table. I did not include items in the report I deemed were due to reoccurring CPNO operations and expenses, such as child-care, or the cost of fundraising, such as money paid to Zulu racing for the Sweetwater 420 5K road race.

From 2010 to 2012, CPNO gave grants and donations totaling \$52,869. The largest share of these funds was for CPNO events, totaling \$17,231 over three years. Movie night received the largest share of this funding, accounting for \$13,000. Other events include the Easter Egg hunt and various smaller social gatherings.

Park improvements and infrastructure was the next largest category, receiving \$15,674 over three years. The largest grant in this category was \$10,000 to Iverson Park improvements. Additionally, \$2,500 was donated to Olmstead Park, and \$2,000 to stump removal and cleanup on Oakdale and McClendon roads.

In the category of grants to organizations outside Candler Park, CPNO donated \$7,100 over three years. The largest of these grants was for \$4,000 to first E existentialist church for new handicap ramp. First E is where we have our monthly membership meeting. CPNO also donated to \$1,500 Inman Middle school technology fund and \$1,000 to the Grady High school Robotics club. I created a separate category for Clifton men's shelter, as they help CPNO and Friends of Candler Park with many events. CPNO donated \$7,764 over three years to Clifton men's shelter. The largest of these grants was \$5,000 for the shower renovation.


Finally, CPNO donated \$5,100 for public safety. CPNO donated \$5,000 to the Atlanta Police department Mini-precinct in Little Five Points.

As can be seen from the table, 73% CPNO's grants and donations from 2010-2012 went to CPNO's own events, neighborhood park and infrastructure improvement, and public safety. Only 13% of CPNO grants and donations went to outside organizations. (This does not include the Clifton men's shelter.) Total grants and donations from 2010-2012 accounted for approximately 40% of net revenue over the same three year period.

It has been suggested that CPNO develop a more comprehensive policy on grants and donations. I humbly submit that this table and the allocation shares of total funds might be a good place to start the discussion. But that discussion should wait until after our fund raising brain storming session and social event the evening of June 26 at Manuels Tavern. See you there.

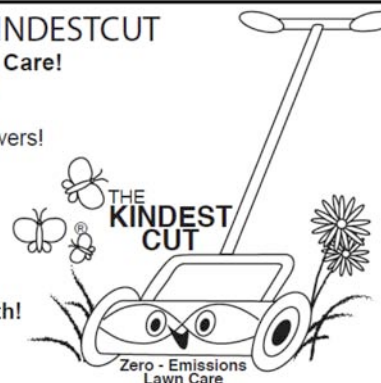

Candler Park Approves CDP Policies

Candler Park Neighborhood Organization has approved and submitted 15 new policies to be placed in the City of Atlanta's Comprehensive Development Plan (CDP). The CDP is meant to be a guide for the future growth and development of neighborhoods in the City of Atlanta as it relates to transportation, housing, parks, economic development and more. The plan is updated every three to five years, and Candler Park has not participated in this process in the recent past, so we had no policies.

After attending several community-wide meetings to learn more the CDP process and soliciting input from Candler Park residents through neighborhood meetings and via email, CPNO has drafted and approved 15 new policies to be added to the full list of NPU-N policies. These policies were voted on at the March CPNO membership meeting.

1. Preserve the single-family residential character of the Candler Park neighborhood
2. Promote the rezoning of non-residential properties fronting on DeKalb Avenue from Moreland Avenue to Clifton to Neighborhood Commercial or a quality of life zoning district in order to encourage destination oriented and pedestrian friendly activity through mixed use development.

Visitors:



Announcements:

Master Plan Update- Jimmy Bligh, Chair of the Steering Committee, reported on the Kickoff Meeting. He announced the dates for the Charrette as April 30, May 1, and May 2 in the Mary Lin Elementary Gymnasium. On Saturday May 4th there will be a presentation of the charrette results at the Frazer Center. A question about Focus Groups was raised by Amy Stout. The Focus Groups are not open to the public. They are designed to focus on certain neighborhood groups, for example, religious groups, MARTA, Police and Fire Department, and Business Owners.

-Sweetwater 420 5K- Russell Miller asked for volunteers for the day of the race.

-Sweetwater 420 Festival- Steve Cardwell reported that the parking permits would be handed out by Happy Ending Production Company. Questions were raised as to why permits were not already distributed. Steve could not answer other than they were at the printers.

-Iverson Block Party-May 5th at Mulberry Fields

-Candler Street Block Party- May 18th

-Church in the Park- Edie Kelman announced that on May 19th the Antioch East Baptist Church was holding "A Fellowship in the Park-Sharing a Partnership in History". -Storage Space- CPNO has had a free 10x10 storage space at City Storage. The company no longer wants to provide the space for free. CPNO must start to pay May 1st.

-A motion to approve the March Minutes with the addition of "Safety Officer-no report" passed.

New Business: The amendment to the bylaws written by Greg Leutscher was not discussed in the Board meeting because there was a miscommunication between the Vice President and the President.

- Environment**- Eric Rubenstein announced that CPNO won \$1000, second place, for the Publix Marathon Cheering Section competition. The task force has been given permission by the City of Atlanta and Golf America to remove the privet and the Bradford pear trees from the area around the beaver pond.
- Special Projects**- no report; chair not present
- Vice President**- no report; Dave Radlmann not present due to illness
- Communications**- Kate Sandhaus had no report.
- Zoning**- Mischa Uppelschoten had no report.

Requests for Funding-Information only:

- Fall Festival**- no one from the committee was present
- Master Plan Operations**-The Steering Committee has had unplanned expenses. Request for \$1500.
- General Liability Insurance**- Dave Radlmann, Vice President, has been investigating policies. A premium will cost \$3300/year. To this point CPNO has been paying for liability insurance by the event. It has been suggested that the neighborhood organizations might be able to get a 'group' rate if they banded together.

Request for Funding-Vote:

- Epworth Methodist Church** requested \$4000 for the construction of a new ramp. A motion was made to grant Epworth Methodist Church \$4000 for the construction of a ramp (No vote). A motion to amend a grant of \$4000 for the construction of a ramp contingent on their raising matching funds passed.
- Storage Space**- A motion to approve \$189 for the storage space for the month of May passed.

Events/Applications:

- Tour de Fat**- Matt Garbett, producer, explained and answered questions about the festival. A pre-festival questionnaire was submitted (see attached document). The main sponsor of the festival is New Belgium Brewing. Atlanta Bicycle Coalition is a partner. The festival was moved to Candler Park by the City of Atlanta due to new rules regarding the use of city parks. (A park may not have the same type activity within 60 days.) This festival will not be returning to Candler Park next year. A motion to support the permit application for the Tour de Fat May 11th passed.
- Midsummer Music and Food Festival**- Josh Antenucci, Rival Entertainment, explained and answered questions about the festival.

The pre-festival questionnaire was submitted (see attached document). The main sponsor of the festival is 790AM. A motion to support the permit application of the Midsummer Music and Food Festival June 14 and 15 passed.

-**299 Moreland Avenue**-A motion to support the special exception variance application for 299 Moreland Avenue failed.

The meeting was adjourned at 10:30pm.

NPU-N Meeting Notes, March 24, 2011

Public Reports

Sergeant Bruce and Officer Nicholas (COPS Unit) reported that crime has been down in Zone 6. Officer Nicholas also talked about the newly updated Community Liaison Unit meant to address non-emergencies. Their role is to create a better relationship between police and citizens, so residents should feel comfortable calling about any safety and quality of life issues. Phone number is 404-546-5650. Officer Layman has been the officer many have seen on bicycle around Little 5 Points, but he has been deployed to Afghanistan. APD is looking for a replacement.

MARTA crime system-wide is up 7% since last year. The most common crimes are that electronic devices are being snatched on trains as individuals are sitting near doors.

The Fire Department was recently awarded a safer grant from the federal government that will employ 75 new firefighters throughout the city. The Atlanta Citizen Fire Academy is meant for citizens who are interested in learning more about fighting fire, extinguisher use, fire drills, etc. Interested individuals should contact Mary McDaniel at 404-472-5680. The City of Atlanta also now has a tool called a flashover simulator that replicates flashovers in a safe environment so firefighters can learn how to be safe in these situations.

The City of Atlanta Department of Parks now has a Facebook page. Camp Best Friends is open for registration starting on March 28. There is an Urban Forestry Festival on April 2, and the Jazz Festival will be coming back to town in May.

There were no representatives present from Watershed or Code Compliance.

Land Use and Zoning Matters:

--The NPU Board voted unanimously to support a variance at **1233 McLendon Avenue** to allow a 7 ft. gate in the required side yard, to allow a 6 ft. 3 in. privacy fence in a portion of the required rear yard and to allow a 6 ft. 9 in. privacy fence along the west side yard property line.

--The NPU Board voted unanimously to support, with conditions upon site plans and elevation, a variance at **591 Linwood Avenue, NE** to reduce the required south side yard setback from 7 ft. to 2 ft. to make a second story addition to a single family dwelling.

--The NPU Board voted unanimously to support a variance at **534 Oakdale Road** to reduce the required north side yard setback from 7 ft. to 4 ft. to allow for an addition with deck to an existing single family dwelling (as per CON-10-029).
