Weekday Watering Now Prohibited

Due to drought conditions across Georgia, the Director of the Environmental Protection Division (EPD) has issued a "Level Two" drought declaration for the entire state. The declaration requires that Georgians immediately follow a more stringent outdoor water use schedule. In addition, the City of Atlanta's Department of Watershed Management has instituted further restrictions on watering for their service area.

City of Atlanta customers may only water outdoors on Saturdays and Sundays between midnight and 10 a.m. Even numbered addresses may water on Saturday, and odd numbered addresses on Sunday. No outdoor watering is allowed Monday through Friday until further notice. This service area includes the City of Atlanta, Sandy Springs and unincorporated South Fulton County.

However, the following are exempted from the City of Atlanta's new watering restrictions:

1. Personal Food Gardens
2. Newly-installed sod or landscapes

These may be watered any day of the week *between the hours of midnight and 10 a.m.* but only for a period of 30 days following installation. Call (404) 658-6500 for more information or to report violations--although I highly recommend that you *Speak* to your neighbor before calling the authorities. This is after all Candler Park not Buckhead! (Not that there's anything wrong with Buckhead...)

Water Saving Tips

So you've got those new flowers and plants that are dying of thirst but with the fierce watering restrictions what can you do? Plenty.

- Place a large bowl or bucket in your kitchen sink to catch the excess water generated when you wash your fruits and veggies.
- When you change the water bowls for your pets, toss the old water in your plants.
- Use a large storage container to capture those few gallons of cold water that fall from your shower while you wait for it to heat up.
- Turn off the water in your sink while you brush your teeth.
- Use dishwashers and clothes washers only when you have a full load.
- Use your imagination!

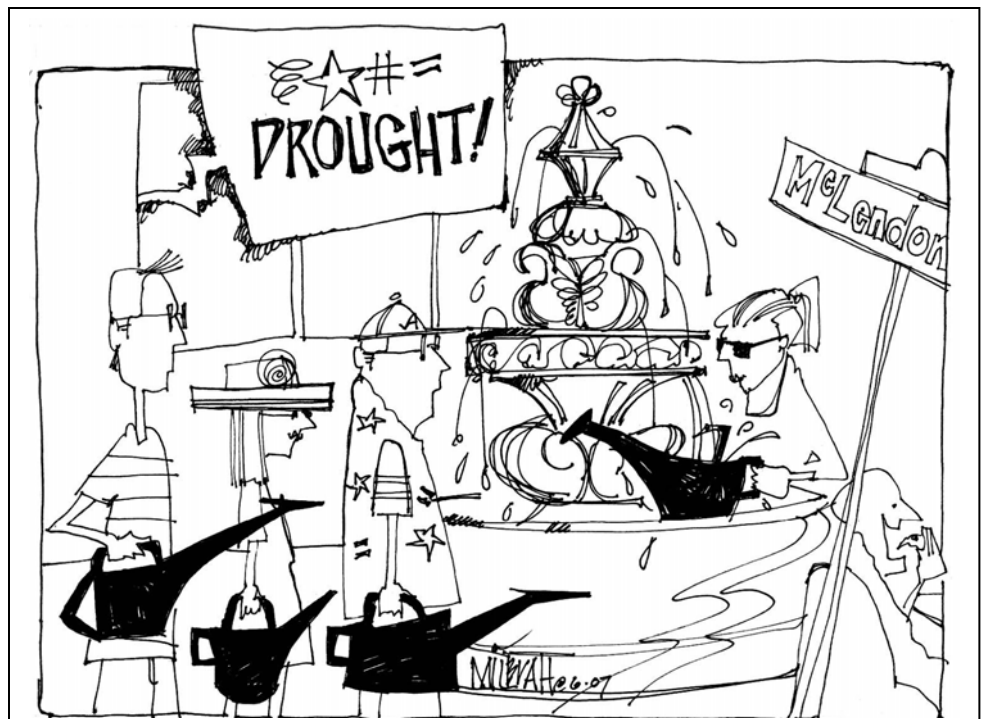

Les bulbouts! Les bulbouts!!

This first bulbout update is to describe the state of the 22 bulbouts and 3 curbside plantings along McLendon between Moreland and Clifton. This is based on a quick survey I did of these locations on Monday, 21 May, before the CPNO meeting. My survey was quite subjective, so be forewarned, but here are the results: All of the bulbouts and curbside plantings have something planted in them. About 18 of the bulbouts have some or only liriopie plants; 3 bulbouts look good to very good, several more are very to quite promising (many thanks to all neighbors who have taken on bulbouts), but 17 of the 22 bulbouts and at least one of the 3 curbside plantings in the McLendon/Clifton commercial area need work. Several look quite neglected. Most need to be weeded, empty spaces planted, trash and accumulated leaf litter removed, dead growth removed, and plants that are above the 2 foot height limit need to be trimmed. In general, the bulbouts need to be tidied up.

If you live near a bulbout and like to garden a bit, or would like to try your hand, please consider adopting or working with a neighbor or two to adopt and maintain one, and doing what you can to make it, your homey space, McLendon, and the neighborhood look better. It looks like about half of the bulbouts have not been adopted. You can begin by tidying up a bulbout near you if it needs attention. Then, if you decide to adopt and maintain one, the next most important thing you can is improve the soil quality. Once you have good dirt, your plantings are much more likely to survive and thrive. If you are interested, contact me at tcp2@cdc.gov AND tompainter2007@yahoo.com. When time allows, I will be contacting bulbout neighbors near McLendon to explore their interest in helping out. But don't wait for me. If you wish to try, go for it! Many thanks to June Deen for all she did during 2006 to promote interest in the bulbouts. I hope that she will remain a bulbout booster. One final thought: Given our drought, watering restrictions, and all the work it takes to establish new plants during the hot months, consider planting in good dirt in the fall, and give the plants a chance to get established during the fall and winter months. Also, consider plants that do not require much water, but provide different textures and colors. So take a stroll along McLendon near your home, look at the adopted bulbouts, and see if there is one that you can work with. And stay tuned for the next bulbout update!

Atlanta Young Singers of Callanwolde Summer Auditions

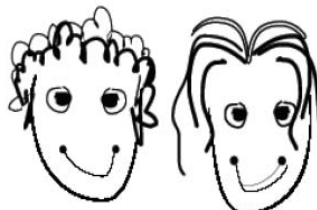

CPNO Meeting Minutes

The regular monthly meeting of the Candler Park Neighborhood Organization, Inc. was held on Monday, May 21, 2007, in the fellowship hall of the First Existentialist Church, 470 Candler Park Church, with president Amy Stout in the chair. A quorum being present, the meeting was called to order at 7:00 pm. Approximately twenty-five people were present at the meeting. The proposed agenda was adopted. The minutes for the April meeting were not presented and were not approved. No police department representatives were present at the meeting.

Committee Reports

The following votes were taken and approved unanimously: Mini Precinct Funding - \$ 500.00; CPNO Pool Lawsuit - \$ 2,500.00 (\$ 500.00 previously approved). The Freedom Park Conservancy Contribution was deferred, pending some input from that organization on how the funds might be spent as well as plans for the future of the organization.

Alonzo Church, CPNO treasurer reported that the organization has a current balance of \$26,527.00 in the checking account. In addition, Mr. Church noted there are ten thousand dollars allocated to the Fallfest and he expects an ongoing flow of money in and out of the


account over the next period of time.

The NPU N update was presented by Amy Stout, CPNO NPU representative. Bylaw amendments are under consideration at this time. For the most part there are not major changes being proposed. The vote to adopt the bylaws, at the NPU level is being proposed to take place at a constituent organization meeting, in the future. Additionally, proof of membership compliance by each constituent organization could be requested at any time. The vote to adopt the proposed bylaw amendment passed by a vote of sixteen to two.





Fallfest and Tour of Homes Committee meeting will take place on 05.20 at the Epworth Church. The tour of homes is looking for volunteers who might wish to have their home on tour. For further information please contact Mary Alice Bray at maryabray@aol.com. The Fallfest will take place the second weekend of October. It was noted that there are a variety of comment cards that could / should be brought back to the organization for review, following the event.

The Security Patrol provided an update at this meeting. The web site securitypatrol.com is up and running. A survey is on the website and the results will be updated in an ongoing manner. Positive feedback has been received on the information contained on the web site.

The parking safety committee presented responses from the article in the Messenger. Several issues of parking adjacent to residential buildings, and parking at fire hydrants were identified. Stop signs were requested along Page Avenue. Requested cross walks were discussed at Clifton at various locations. Signage concerns related to no turns on red were noted, and the suggestion was made to relocate the signs to a hanging position. In-the-street signs related to stopping for pedestrians, will be studied along Clifton Street. The recommendations related to the Flying Biscuit, yellow curbing, designated delivery parking spaces and no parking zones were agreed upon in a meeting with the city officials in April. Additional recommendations will be identified and presented to the neighborhood for further consideration. Davy Smith made this presentation and may be reached at davi33s@aol.com.

Land Use Matters

James Johnson presented an application for a change of owner / change of agent at the Star Bar in Little Five Points. There are two applications for this location as there is an upstairs and downstairs bar location. A motion was made and unanimously adopted to support the applications as presented.

Next month two applications will be heard: one at 630 Oakdale and a second application at 1526 Iverson. Both of these applications will be for variances.

The Bureau of Planning has submitted legislation for consideration that will modify zoning regulations related to infill housing issues. Numerous items will be modified including retaining wall heights, floor area ratio limitations, and definitions related to attics and basements. After discussion on the pros and cons of the proposed legislation, a motion was made to support the legislation. This motion carried by a majority of members present.

The issue of zoning regulation enforcement was discussed with a focus on improved enforcement being required of the city and its officials to handle zoning matters on a more consistent basis.

New Business

A safety issue has been raised related to the plant materials in the bulb outs along McLendon Avenue. It was suggested that the organization contact the folks who are maintaining the bulb outs for consideration of this maintenance item. Tom Painter has agreed to follow up to the extent possible.

Announcements / Open Forum

A representative of Dekalb County Soil and Water Conservation District was present at the meeting and discussed an upcoming conference, Erosion and Sediment Control Exposition, the morning of June 1st.

Next month a proposal to purchase Candler Park banners will be presented to the membership for consideration.

The Moreland Corridor Task Force is meeting to review several significant infrastructure improvements which have been proposed. The website www.morelandcorridor.net, contains information related to the proposed improvements.

THE SEARCH FOR THE PERFECT PANCAKE ROLLS ON

Recent personal events have motivated me to *try* to track down the tastiest pancake in Candler Park. So, after weeks of snarfing down short stacks at various local eateries, I've learned one important lesson...there are as many different types of pancakes in our neighborhood as there are different types of people. And thank god for that!

My first stop was the **Flying Biscuit** for a plate of organic oatmeal pancakes with a side of chicken sausage. The pancakes were hot and hearty, if a bit on the heavy side. Size wise they were quite generous. The short stack measured over 3 inches tall and they nearly covered the entire plate. The cakes were topped with a warm peach compote so I found absolutely no need for syrup. Now the chicken sausage was a delicious surprise. Who knew that a non-pork product in sausage form could have such flavor? (www.flyingbiscuit.com 404.687.8888)

Next, I visited the **Radial Café** where I encountered a dilemma...should I choose the regular pancakes or go for the buckwheat? Fortunately, I was dining with fellow food freaks--one of whom quipped "I don't even like buckwheat, but the Radial Café turned me around. I saw the buckwheat light!" Problem solved. We ordered both. The regular cakes were sprinkled with a bit of confectioner's sugar and had beautiful lacy brown edges. They were nice and warm and took the butter and table syrup with ease. (You can opt for real maple syrup, for an extra buck-95.) The buckwheats were indeed some of the best buckwheat cakes on the planet. They were a cool shade of blue with a light, almost earthy flavor. Yum. (www.radial.us 404.659.6594)

Gato Bisco was next on the pancake adventure. They also offer two types of hot cakes: regular and the amazing sweet potato variety. Both are quite tasty and beautiful to look at, but the sweet potato was outstanding. The fragrance alone started my mouth to watering. (404-371-0889)

The last restaurant on the pancake trail was **Stone Soup Kitchen** – now before you start, I know it's not actually located *in* the neighborhood, but chief cook and bottle washer Sarah Rick has been a long time Candler Park resident, so I figure it counts. These were truly *hot* cakes... piping hot. They had an incredibly rich batter and were very light and fluffy. A small bowl of freshly cut kiwi, red grapes and pineapple chunks was served on the side. Oh, and be sure to order the killer smoked bacon. (404.524.1222)

May 2007 NPU-N Report

The following items from the May 24, 2007 meeting of NPU-N are those most likely to be of interest to Candler Park residents.

The NPU-N board voted in favor of a special exception to reduce the number of required on-site parking spaces (from 5 to 0) and in favor of a special use permit to allow after school day care at 1448 Iverson, consistent with previous approval by CPNO. These approvals were made with the contingency that they would only apply as long as the applicant Shannon Smith remained owner and operator of the facility.

The board voted in favor of an application for a change of ownership for the alcohol license for The Flying Biscuit restaurant at 1655 McLendon, with the condition that the applicant continue to work with the neighborhood and the city to address concerns about illegal parking, truck unloading, and related issues. This approval was consistent with CPNO's previous vote of approval.

The board also voted in favor of an application for a change of ownership for the alcohol license for The Star Community Bar at 437 Moreland with no conditions, consistent with CPNO's previous vote of approval.

The board voted to recommend adoption of the proposed Residential Scale Ordinance with the additional recommendations that the legislation be amended 1) to reduce the maximum lot coverage for the R-5 and R-4A zoning categories to 50% and 2) to use the definitions of attic and basement that were originally proposed by the AIA Infill Development Panel.

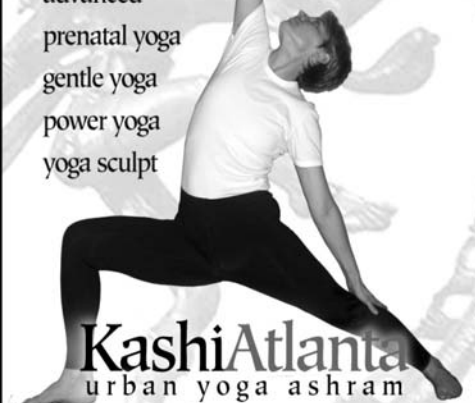

Tragic Shooting on Seminole Avenue

On Monday night, May 21st at about midnight, our neighbor, Terry Williams, was shot in the head on the sidewalk in front of the house where he lives on Seminole Avenue, near the intersection of Sinclair Avenue. Terry and an acquaintance were walking home from Little 5 Points along Seminole Avenue when they were approached by a man who asked for a light. The man then pulled a handgun, put it to the acquaintance's head and demanded their money. According to police, Terry tried to defuse the situation saying that there was no need to point the gun. The man then turned and shot Terry in the face. He then escaped into the neighborhood running down Sinclair Avenue. He did not take anything.

When medical help arrived, Terry was not breathing. He underwent two surgeries at Grady Hospital, and was in critical condition while he fought for life. The bullet had entered the left side of Terry's face and lodged in the right side of his head, severing his carotid artery which essentially destroyed the right lobe of his brain, which had he survived, would have left him severely debilitated. Sadly, Terry Williams lost his struggle to overcome the injuries sustained in this terrible ordeal, and died on May 29th.

The suspect is described as a black male, late 20s to early 30s, with shoulder length dread locks, about 6 feet tall, 165 lbs, thin, with a medium complexion and slight mustache, wearing a black and blue speckled shirt. Anyone that might have any information on this senseless crime or suspect should contact the Atlanta Police department at (404) 371-5002 (Zone 6) or Homicide at (404) 853-4235. This includes anyone that might have seen someone that matches this description that was in the area, or if they may know of someone that fits the description or anyone at all with any information.

Many of you know Terry and are still reeling at how this tragic and senseless violence could happen to him – and in our own neighborhood. Terry is uniformly regarded as a truly remarkable person – with a unique blend of exceptional intelligence, quick wit and genuine kindness towards people. He has been a sculptor, set designer for television and movies, artisan for the Smithsonian and Carlos museums, writer of stories and screenplays, bartender at the Yacht Club, and regularly attends Epworth Methodist Church in Candler Park.

As many have said, "Terry never met a stranger." Some young children in the neighborhood are very close to 'Uncle Terry'" and have not yet been told what has happened. 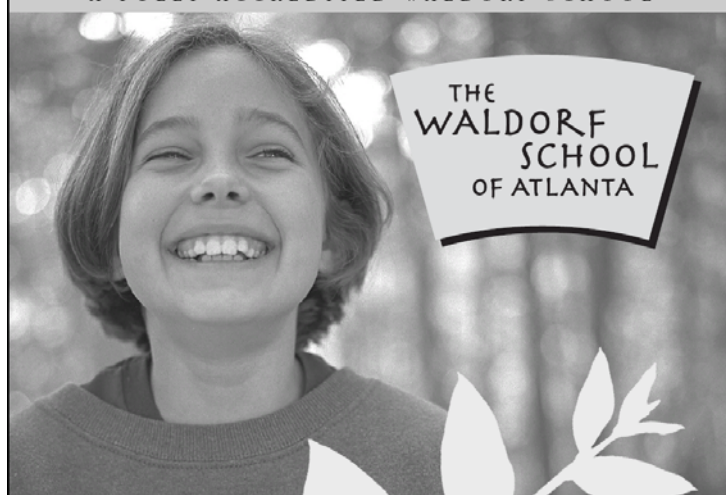
