Developing 1240 Euclid...A Neighbors Point-of-View

There have been several articles about the 1240 Euclid Ave. church property. From architect David Green (who has been acting as a representative for the five developers) we've heard about the desired rezoning, the demolition of our 1920's era church, the building of a two level parking deck, and a high-density mixed-use compound that is to be, in places, 4 stories high, contain live-work space, retail on the ground level and 60-odd 1 and 2 bedroom condos.

Each time David has released something to the Messenger or spoken in meetings he's assured Candler Park residents that he wants the neighborhood's support and will work with residents to design something that will marry with the style of the established homes and neighborhood. He's also assured us that the builders also hope to gain our support.

The church was built in the 1920's. The house I live in was built for the minister of the Church. It continued as a successful place of worship until much more recently. The church has had a disreputable reputation for the past several years, as there have been constant disturbances and allegations of illegal activities. It had also been allowed to fall into a state of disrepair.


Just recently, the church has been re-established as a place of worship and holds a very popular service on Sunday, at which you can hear the congregation celebrate their spirituality in song for hours. It's wonderful!

Being one of the residents who will forevermore face the proposed structure I naturally feel very strongly about the plans for our church and its adjoining land. I've heard many of my fellow neighbors voice their concerns. I've also heard mentioned the demolition of the Church and its greenspace, which we've had in our neighborhood for ages longer than most can remember.

Many fear retail extending further into our community. This would draw more noise and traffic, into our neighborhood, which is uniquely quiet considering the proximity of the shops, bars, and restaurants of Little Five Points. There is also the fear that the retail space could fail and become an eyesore in a few years or, conversely, that it would house a very popular bar/restaurant or a drycleaner. Some have mentioned the idea of small, high-density condos that would give us a huge influx of traffic, and possibly lower our home values.

I've also heard many neighbors say looking onto a parking deck or multi-level loft would detract from the look and feel of our neighborhood. Others are concerned about pollution and water run-off, which could cause washouts of existing properties as well as stress on our water and sewer systems.

I'm hoping I'm right in putting faith in David Green and the developers' stated intention of working with us and designing a building project that fits in our neighborhood. I ask that as fellow residents you join in and help decide what the future of our Candler Park looks like. Join us again for another discussion on this topic at the zoning committee meeting on September 5th at Epworth United Methodist Church.



So come join the Deep People in the Shallow End[©] as we finish out our inaugural season of fun! Hecklers and innocent bystanders are also welcome.


Candler Park in the Running for Park of the Year!!



Candler Park residents can help Candler Park receive this honor by doing there best to put trash in the receptacles and keep the park clear of litter.










Candler Park Zoning Committee Meeting

The Candler Park Zoning Committee met 11 July and reviewed three items.

- The first item was the front and sideyard setback variances for the renovation of 354 Clifton Road. The project involves building out the attic space of an existing single family residence. The committee recommended approval of the variances. This item was also approved at the CPNO Regular Meeting on 16 July.
- The second item was the rear and sideyard setback variance for the construction of a shed at 571 Terrace
 Avenue. The committee recommended approval of the variances and the item was heard and approved at the
 CPNO Regular Meeting.
- The committee and the neighbors in attendance also heard for information and comment, the proposal to rezone 1240 Euclid Avenue (currently the New Vision Church) from its current zoning of R4 Residential to NC Neighborhood Commercial. The project architect presented the schematic plan and a discussion of the proposal followed. The architect and owners are going to incorporate the comments and prepare four concepts for the redevelopment of the property. The concepts will be presented and reviewed at the September Zoning Committee meeting scheduled for September 5, 2007. If you are interested or have concerns about the proposal to rezone please attend this meeting.

The zoning committee meets regularly the first Wednesday of every month at the Epworth United Methodist Church. Meetings are open to the public and neighbors are encouraged to attend to voice their opinion regarding zoning issues.



Peace Pie for the Summer of Love

Good Neighbor Pedro gave me a sack of home-grown peaches a week ago and I used them to create a heavenly pie to celebrate the birthdays of my beloved niece and nephew. My family is used to acting as my culinary guinea pigs, and quite often has consumed some weird concoctions, but this time, well...you be the judge. I recommend that you serve this pie to your loved ones to celebrate the 40th anniversary of the Summer of Love.

Crust:

9 whole graham crackers (1 sleeve from a 14.4 oz box) A handful of roasted almonds* 1/4 cup of sugar Dash of salt 1 stick of melted butter

Filling:

2-3 large fresh peaches 1 cup fresh blueberries ½ cup sugar 8 ounces of softened cream cheese 1/3 cup sweetened condensed milk Pinch of cayenne (optional, but intriguing)

Start by preheating the oven to 350. Use the paper from the stick of melted butter to grease the bottom and sides of an 11 inch tart pan with a removable bottom. You can also use a springform pan, but it won't have those pretty fluted edges.

Using a food processor, a blender or a mortal and pestle grind the crackers, ¼ cup of sugar and salt until it resembles coarse sand. Add the roasted almonds and pulse or grind until they are about the size of peas. Now, dribble in the melted butter and pulse or stir until it the butter is incorporated. Don't go hog wild or you'll have a mushy paste. Press the cracker mixture into the prepared tart or springform pan taking care to build up a little on the sides. Now, bake it for about 10 to 12 minutes or until it smells nice and is a bit more toasty in color. Remove the crust from the oven and set it aside to cool completely.

While the crust bakes and cools, get the filling and fruit ready. Fill a large sauce pan half way with water and place it over high heat to boil. Assemble an ice bath by placing a few cubes of ice in a medium bowl and filling it half way with water. Use a sharp knife to cut an X in the bottom of the peaches. Drop the peaches into the boiling water and let them float around for about 15 to 30 seconds. You'll notice the skin flapping from around the X-mark you made. Use a slotted spoon to fish out the peaches and plunge them into the ice bath. Now slip of the skins and cut the peaches into chunks. Place peaches and blueberries in separate bowls and divide the ½ cup sugar between them. (If you think you'll be a while, sprinkle a few tablespoons of lemon juice on the peaches to prevent discoloration. Also, adjust the amount of sugar if necessary. Sometimes, the freshest peak-of-summer peaches or blueberries may not need any extra sugar.) At this point you can sprinkle the cayenne on the peaches if you are using it.

To make the filling, place the softened cream cheese and condensed milk in a medium bowl. Use a hand mixer to beat them until they are nice and fluffy. (Note that beating cream cheese is *not* considered torture by the current administration.)

When everything is ready, assemble the peace pie by spreading the cream cheese mixture in the bottom of the cooled crust...leaving about a half-inch of the crust showing around the edge. Now fashion the peace sign using the blueberries. Fill in the middle of peace sign with the peaches. Cover the pie with plastic wrap and refrigerate for at least 2 hours. Yum! *To roast almonds, simply preheat your oven to 350, pour a bunch of almonds (I buy the ones with the skins on) onto a dry baking sheet with sides and pop them in the oven. In about 15 minutes or so, you should be able to smell them. Turn the oven off and leave them until they are cool enough to handle and are toasty brown through and through. I sometimes do this at night and let them rest in the oven until I get up the next day. Keep then stored in the freezer in an airtight container. These are also a tasty addition to summertime salads!



Alonzo Church, CPNO treasurer reported that the CPNO has a current balance of \$18,554.00 in the checking account.

Voting items related to spending funds, were presented and voted on, including:



As you can see, the majority of the neighbors who responded to our survey do believe that crime is a problem in our neighborhood. Unfortunately, after our fieldwork, we've found that organizing and running an effective security patrol year-round will be costly. Given the stats above, the current estimated support level is \$18,400/yr. The needed support level is \$45,000 - \$50,000.

If you have not responded yet but would support a patrol there is still time! Visit www.CandlerParkPatrol.com ASAP! We'll continue to collect and tally the survey results for the next several weeks. In mid-August, the Security Patrol Committee will make a decision on next steps. Even if there is not enough support to get a formal Security Patrol up and running at this time, we will investigate other possible ways to help lower crime in our neighborhood.


