## An Open Appeal to Candler Park Neighbors

Summer is the time of year when preparations for the upcoming annual Candler Park Fall Festival begin to shift into high gear. A city-wide attraction, the Fall Fest is a much anticipated event. Folks look forward to having a good time in a great park. This year's Festival planners are framing the event with an historical marketing theme, "Candler Park 09 Fall Fest - 100 Year Anniversary."

Using an historic stamp for this year's festival begs the history questions. What else have we discovered about Candler Park's past? How do we acknowledge deeper truths unveiled?



There is a complex history of African American pioneering settlement on the grounds of The Park itself that dates back to the 1870s. The Black subdivision of Rose Hill, with its home-owners and fraternal Edgewood Evening Star Lodge, thrived on land that now holds the festival. Segregation efforts in this area included the city-owned, Caucasian-only Candler Park Golf Course next to Rose Hill in the mid- 1920s, the construction of Mary Lin Elementary for Caucasian-only children, and the construction of homes on Callan Circle and Page Ave. that had Caucasian-only restrictions.

During Fall Fest, let us make respectful acknowledgement of this local African American community, their legacy and sacrifice upon which we literally stand as we toast our neighborhood history.

## NPU-N Report for the July 2009 Meeting

### Proposed City Ordinances:

-We received an introduction to the proposed Atlanta Sustainable Building Ordinance. The full text has only recently become available and was not distributed at the meeting, but you can download the 68 page document from [www.sustainableatlanta.org](http://www.sustainableatlanta.org). There will also be a series of public workshops hosted August 3-6 to educate interested parties.

In summary, the legislation will create new requirements for all new construction in Atlanta (with the exception of single-family homes and multi-family homes of less than 4 stories – at least for now). All new buildings will have to be built to either LEED, Earthcraft, Green Globes, or the alternate Atlanta Sustainable Building Standards specifications established in the ordinance.

We will be voting on this at an upcoming meeting, so let me know if you have concerns.

-The board voted in favor of an ordinance that would allow "Vehicle Immobilization Services" that boot cars on private property to increase their fees from \$50 per day to \$75, although I voted against it. The increased fees would not go into City of Atlanta coffers but would simply benefit the private companies that have contracts for this work.

### According to City of Atlanta representatives...

-The furloughs are over!

-Our ladder truck at Fire Station 12 is back in service. We may occasionally have brown-outs when there are too many absences to man all trucks, but the permanent shut down of that vehicle that was in effect for the last 6-8 months has been reversed.

-We will return to weekly pick up of recyclables in mid-September.

### Land Use and Zoning Matters:

-There were no Candler Park cases on the agenda.

### Special Event Permit Applications:

We voted to approve one for the Candler Park Fall Fest to be held in Candler Park on October 10<sup>th</sup> and 11<sup>th</sup>.

### Other:

-The next NPU-N meeting will be August 27<sup>th</sup>.

The regular monthly meeting of the Candler Park Neighborhood Organization, Inc. was held on Monday, July 20, 2009 in the fellowship hall of the First Existentialist Church, 470 Candler Park Church, with Amy Stout in the chair. Approximately 32 members were present. The meeting was called to order at 7:00 pm.

The agenda was modified to have officer reports moved to earlier in the agenda.

### Announcements:

Teri Stewart updated us on the Dekalb Avenue green space. Another tree removal appeal is underway. An article will follow in *The Messenger*.

Epworth Church will have demonstration gardens for "smart landscapes." Workshops will held August 8<sup>th</sup>, and include a "green" fair.

Amir Farokhi returned to CPNO to remind us that he is a candidate for the City Council at-large position.

**Officer Reports:** Mary Alice Bray announced 5 houses have been selected for the Candler Park tour of Homes so far. 2-3 additional living spaces are sought.

Amy Stout, as representative to NPU for CPNO, announced that at the next NPU meeting there will be a vote on a sustainable building ordinance. Please send her any concerns.

Meeting minutes were unanimously adopted.

Alonzo Church, Treasurer, reported that the organization has \$81,221 in funds.

Doug Wetzel announced that neighborhood watch meetings are beginning to be held. The Josephine watch has already been active and has cleared out the debris from the area between Josephine and Little Five Points. Other watches will be meeting soon. The plan is to be active by the second Friday in August, which is the National Night Out. Please contact Doug with any questions.

Mark Clement requested that a formal vote for support for Fall Fest to be added to next month's CPNO agenda. Regarding Fall Fest seed funding for \$5,000, which was tabled in June a unanimous voted brought the issue to the floor. Questions and discussion centered around the use of the funds, and Mark explained funds will support deposits for production, sanitation, safety, and EMTs. \$4,500 of sponsorship has been obtained so far. The festival did not make money last year, due to size limits necessitated by the drought. Some questions regarding the extent of financial risk were not answered, however others noted that this is a small amount given the general success of the festival. A vote to approve funding for the seed money was 20 to 2.

Mid Summer Music Fest's donation of \$5,000 was presented to the organization.

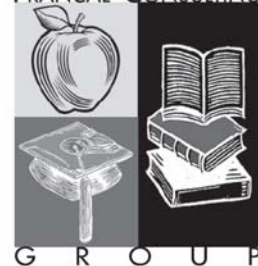

Lynn Irvin presented on the Campaign for Atlanta. This group is reaching out to neighborhoods to support three main goals 1) to vet candidates for mayor and raise the level of debate, 2) to have the candidates make commitments to the neighborhoods and 3) to bring neighborhood leaders together. Four major candidates participated in a forum last weekend focusing on major issues facing the City. The forum is videotaped and available through the web. The next forum will be August 15<sup>th</sup> and 16<sup>th</sup>. Please see [campaignforatlanta.org](http://campaignforatlanta.org) to learn more. To become more active, one can attend the upcoming forum. Lynn also requested that Candler Park, as a neighborhood consider becoming a formal supporter of the coalition. To allow members more time learn issues, a vote on formally supporting the Campaign will be held at a later meeting.

George Dusenbury requested \$890 to finish the wall in Candler Park. It was unanimously approved.

Amy Stout provided an update from the Freedom Park Conservancy meeting. A lot near Candler Street is proposed for development, and while the Conservancy is concerned, the City has already approved 1 day access for utility installation. The Conservancy is not willing to set a policy regarding these types of lots. Richard Ford reported that the vision of the Conservancy is being decided. Water fountains will be added to the park at Poncey Highlands. The sculpture project and water installation will be completed next month. The sidewalks will be repaired once this is complete.

**New Business:** Randy Pimsler reported that the Little Five Points Community Center is having a capital campaign to improve accessibility of the facility. They hope to begin construction in September. He will ask for a matching grant donation at next month's meeting.

Mark Clement requested a non-binding vote to support Fall Fest to take to the upcoming NPU meeting. During discussion, a question was raised about where funds in CPNO's Treasury comes from, Amy explained funds come from road races, festivals, *The Messenger* revenues, Tour of Homes, and donations. Other targeted grants have also been received. She also noted that a budget committee is reforming to help develop a plan to allocate funds. The vote was held and passed with no opposition.


The meeting adjourned at 8:50.

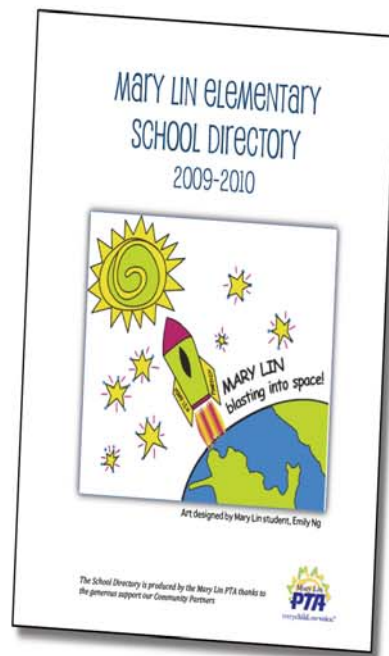

*At 4:30pm I walked my dogs over to the park and was surprised to see 50+ folks drinking alcohol in glass containers and having cars and SUVs parked on the grass near the pavilion. I have never seen anything like this in the 10 years I have lived here. I was glad to see your presence there trying to get the cars removed and the alcohol placed in cups.*

*I noticed the volume of music was acceptable and was glad to see folks enjoying the park. When I returned Sunday morning for my walk, the area was a mess. The area near the pavilion was mostly cleaned up but there were stacks of cases of bottles. The worst was the condition of the parking lot and the area near their portable restroom. The lot was littered with many cups, wrappers, cigarette boxes, bones, and other trash. All of the neighbors I saw were also disturbed about how the park was left.*

*I wanted to thank you for your follow up to this unsanitary and dangerous condition. The area was cleaned up promptly soon after. It has been tough this year with the pool closed and folks looking for other recreation. Your efforts (and those of your department) make a difference in the quality of life for those of us who enjoy this park many times a day.*
