APS Superintendent Releases Plan for Inman Overcrowding

In a July 26 letter, APS Superintendent Erroll Davis announced his proposed solution to Inman Middle School overcrowding. “At this point,” Davis wrote, “I believe we have a solution that will work for the planning period [through the 2021-22 school year].”

Davis’ proposed plan entails adding 6-8 classrooms to Inman, which will add capacity for roughly 200 students, while also converting Centennial Elementary into K-8 by the 2014-15 school year, which would reduce the middle school’s population by another 200 students -- a net increase of roughly 400 students to the school’s current capacity.

With one less feeder elementary and the new classrooms, Davis said, Inman could get rid of its portable classrooms and restore its playing fields. The now-closed Walden school in the Old Fourth Ward would be used to make room for more fields for the cluster.

Davis said he expects to have more news soon about the Old Fourth Ward’s now-shuttered, historic Howard school. “We are optimistic,” he wrote, “that the facility will be more fully utilized than it is today.”

Candler Park parents have worked for two years to keep Mary Lin students in the successful Inman / Grady cluster that our community helped to build. Davis’ proposed plan is both aligned with

what CPNO Education Committee members have advocated for, and it is also a solution that is fair and equitable for the entire cluster.

The next step is for Davis’ proposal to go to the Atlanta Board of Education for a vote, which is likely to happen in the next 1-2 months.

The meeting was called to order by Steve Cardwell, President, at 7:05 pm.

Thank you to Front News Page for providing refreshments.

The motion to adopt the agenda as amended passed.

Visitors: Major Meadows and Captain Shaw, representing APD Zone 6, answered questions concerning the apparent increase in crime. APD has identified 9 or 10 juveniles who seem to be the main perpetrators. Five plain clothes officers with vests have been added to each watch to patrol a defined area (includes Candler Park neighborhood). Zone 4 And Zone 6 are participating in a pilot using a new program entitled Predictive Analytics. APD is also working with APS mapping truancy and crime.

Announcements:

1. NPU-N – Mark Clement has resigned as an alternate. He apologized to the membership for not following the zoning process.
2. David Rotenstein has been appointed by the Board as the new Editor of the Messenger. He is a historical writer by profession. His plan is to add more writers and create a product that is more than just news and crime.
3. Jeff Elrod has been appointed by the Board to be the new CPNO webmaster. He will coordinate with David to provide more editorial content.
4. "Love Your Block" grant- Amy Stout was awarded the full \$1,000 to use for the golf course beaver pond improvements.
5. New Belgium Brewing gifted CPNO the sum of \$240 from their Bicycle program.
6. Messenger Ads and Distribution- Peter Bluestone has assumed the responsibility for selling ads and for the distribution system.
7. Friends of the Candler Park Golf Course- Michael Short reported that the golf course master plan is complete and he has applied for a grant from Park Pride for the improvements. The group must show that it can match the funds. He is also developing a program of golf instruction for children (ages 8-12). The program will

start as soon as he has complied with City of Atlanta requirements.

8. Little Five Points Business Association plans to attend our meeting next month to field questions about The Halloween Festival.
 9. Master Plan- A hard copy of the Master Plan is available. Bonnie Palter will be responsible for loaning the copy to anyone who requests it. A copy of the draft is also available by email.
 10. Mark Leech- Mark has an organization for international students called Mark's Home Stay. He is looking for volunteer families to host students. The website is MarksHomestay.com; email is markshomestay@gmail.com.
- Motion to adopt the minutes of the June membership meeting passed.
- Master Plan Discussion- Aaron Fortner, Market and Main, announced that the next draft of the Master Plan will be ready July 26th. He solicited comments from the members regarding the accuracy of the document. There is still time to provide feedback on line. He is encouraging us to vote on the Plan at the next meeting so that we will be able to present it to the City Council by September. He reminded the members that the implementation of the plan is our responsibility and it is best to prioritize the projects. His recommendation is to start with the

Oakdale and McLendon intersection traffic calming recommendations.

Officer and Committee Reports:

1. Membership- Lexa King summarized the results of the June 26th FUNdraising Meeting at Manuel's. There are five 'ideas' that have owners; there are eight that need owners. All 'ideas' will be posted on the website.
2. Treasurer- Peter Bluestone reviewed the Profit/Loss report. We have \$77,777.00 on hand. We have realized some income from the Messenger.
3. Zoning- Fox Brothers Restaurant is requesting neighborhood input on the deposition of the corner lot which they have purchased.
4. Public Safety- Report was given by Steve Cardwell in the absence of Jimmy Bligh.
 - a) July 10th Meeting- Lexa King and Bonnie Palter summarized the meeting content. Lexa was surprised that some of the neighborhoods had off duty police officers patrolling. Four concepts that were emphasized: Call 911; Neighborhood Watch; Clean Car Campaign; Surveillance Cameras.
 - b) Off Duty Police Officer- Discussion about whether the neighborhood wants to fund an off duty police officer to patrol 3 hours 3 days of the week. The rate

quoted is \$35/hour. The officer would patrol (walk) according to a plan he develops from crime statistics. The police officer has full authority to make arrests. He will carry his radio and be on the same frequency as 911. The motion to fund up to \$499 for an off duty officer with a plan to analyze data during the trial period was defeated.

c) Crime Prevention Expert- Christian Russell has approached the organization regarding his expertise on crime prevention. Lexa King and Bonnie Palter will meet with him as soon as possible.

5. Environment- Eric Rubenstein reported that Southface Institute will, free of charge, assist us in forming a conservancy for the park. He is still awaiting more information from the Georgia Marathon regarding which mile will be assigned to us. We will need at least 30 volunteers, not runners, for the cheering section.

6. Special Projects- Mark Clement reported that FallFest plans are going well. The dates for the Fallfest are September 28 and 29, 2013. Sponsorships are still in the beginning stages of solicitation.

7. Vice President- Dave Radlmann

continues to work on obtaining funds for sidewalks around Goldsboro Park.

8. Communication-no report

9. Education- Kate Sandhaus reports that there is a very good possibility that the Mary Lin expansion will not start as scheduled. The major obstacle is land use stemming from a portion of Freedom Park.

Mary Lin's scores are now in the 90th percentile which is a decline from past years. The biggest drop was 5th grade math scores. Inman Middle School issues will be resolved before Superintendent Davis leaves his position.

10. Master Plan-no report

11. Events-no report/chair unable to attend

12. Sidewalk- Clifton Mack reported on the progress of the sidewalk replacement in front of the park entrance. In addition to this, the committee has surveyed all the sidewalks in the neighborhood. Twenty five percent of the 15 miles of sidewalk are damaged. Colin Heydt, co-chair, will step down due to out of state commitments during the next school year. Anyone interested in helping Cliff is

welcome.

Requests for funding:

The sheep will be in the park July 27 to work on ravine B. In conjunction with their visit, Mark Clement requested funds for "Meet the Sheep" and an ice cream social. Motion for \$200 for the 'petting sheep' and ice cream passed. The working sheep are funded by Sweetwater and Trees Atlanta.

Zoning Presentation-

a) 1445 Benning Place- Application for a variance to reduce west side and front yard setbacks for a porch. Motion to support the application passed.

b) 296 Josephine- This application is made for splitting of the lot back to the original two lots. The owner wants to sell the second lot (300 Josephine). The motion to consider and review the request to separate the lots into 296 and 300 Josephine passed.

The meeting was adjourned at 9:15pm.

Candler Park Streetscape Improvement

McLendon Avenue between Candler Park Drive and Callan Circle is getting an upgrade. In February, the Atlanta City Council awarded B.E. Guthrie Construction, Inc., a \$198,643 contract for streetscape improvements that include repairs to one of Candler Park's most heavily traveled and most visible sidewalks.

The city's scope of work for the sidewalk adjacent to the park included the removal of the deteriorated sidewalk, construction of a new concrete sidewalk, ADA-compliant cut-outs and ramps, a granite seat wall, granite curbs, and a new concrete gutter.

Work began in July and about half of the sidewalk repairs had been completed by mid-August. The contract, which is managed by the Atlanta Department of Parks, Recreation, and Cultural Affairs, requires work to be completed within six months.

Mary Lin Renovation Slated for Late September

The long-awaited Mary Lin renovation and expansion is somewhat delayed, but is still a go! It is tentatively scheduled to break ground on September 23. This is contingent on completion of the permitting process.

The project phasing is as follows:

Phase 1- Site Utilities (Storm Drainage System, Fire Line, Water Line)
Sep 23, 2013 - Dec 18, 2013

Phase 2A - Construction of New 2-Story Classrooms and Support Spaces, Paving and Landscaping Improvements
Nov 4, 2013 – Jul 18, 2014

Phase 2B - Renovation of Cafeteria/ Kitchen, and Classrooms
March 1, 2014 – July 18, 2014

Phase 3 - Select Renovations on Main and Upper Levels, Classrooms and Restrooms, Gym Renovations
May 28, 2014 - Jul 30, 2014

Phase 4A - Construction of New Administration, Media Center, and Connecting Corridor, Site Utilities, Paving and Landscaping Improvements
Jul 21, 2014 – Feb 23, 2015

Phase 4B - Select Renovations on the Main Level, Chorus, Band, and Classrooms
Oct 6, 2014 – Feb 23, 2015

The Mary Lin Building Committee met several times over the summer, including

most recently in late July with APS administrators, architects from Goode Van Slyke, and key team members from Hogan Construction.

The school year will begin with the school just as we left it; there will be no changes on day one. We will not lose the cafeteria until March of next year, and it will be back online for the fall of 2014. That means less time dealing with alternative lunch and PE arrangements. We will also still have use of the Hall House for this year.

When construction begins in September, we will lose use of the back parking lot. Teachers will then be parking on the streets surrounding the building, so parents accustomed to parking on the street nearby and walking children into the building should keep this in mind. Parents will be encouraged to use the carpool drop-off drive during this time.

When Phase 1 gets underway, the stretch of Candler Park Drive from the school down to North Avenue will become one lane (due

to work on utilities). Plans are still being worked out for whether there will be traffic in two directions with flag people directing cars, or if that street will become one way for some period of time. Please stay tuned as this will have a significant impact on morning drop-off.

Look for project updates at candlerpark.org and via The Rocket (the Mary Lin email blast). Our entire fourth and fifth grades have been in trailers for years, and our neighborhood school is in major need of updates to bring it in line with modern school standards. This project will fix all of that! There will inevitably be some bumps and inconveniences along the way, but in the end it will all be worth it.

Business Spotlight: The Cult of CrossFit

The neighborhood gym team advanced to worldwide competition this year.

If you frequent Candler Park Connection—the business complex located at DeKalb and Mell avenues—or have reason to drive on Mell regularly, chances are you have seen people sprinting up and down the street, carrying heavy objects, or pulling tires attached to ropes in the alley that leads to Pat Murphy Electric.

These people aren't crazy—well, yes, they are—but they're also clients of CrossFit Rx, the CrossFit affiliate gym that started out sharing space with Wall Crawler Rock Club and has since occupied three increasingly bigger spaces over the last six years. Now inhabiting the former warehouse that faces the alley, the gym has exploded in recent months with more than 200 members, from the fittest of competitive athletes to regular people who just want to get or stay in shape. (Disclaimer, and true story: I was a CrossFit Rx client for four years, during which my body fat dropped nearly 10 percent.)

"We attract people of all different shapes and sizes, all ages, all walks of life," says Kelly Levens, co-owner of the gym along with Michael King. "Everybody who

comes in is looking for something different, but most people just want to look better and feel better, to be more functional human beings."

CrossFit Rx has a gated kids' space to help busy parents find the time to work out, and recently completed a climbing wall on its upper floor. But like most CrossFit gyms, it doesn't offer a lot of fancy equipment—just pull-up bars, some rowing machines, boxes for jumping, and weights. Lots of weights.



Levens, who grew up in a family of seven kids and has always been "good at playing," discovered CrossFit when he moved to Atlanta a few years ago and visited

CFRX. He was given a hallmark CrossFit workout, "Cindy"—20 minutes of five pull-ups, ten pushups, and 15 squats, repeated as many times as you can. He got an impressive 17 rounds, after which he threw up. "It was awesome," he says. "I couldn't wait to sign up."

King, too, is a believer in all-around physical fitness. A CDC researcher by day, King is a rock climbing and outdoor enthusiast and "works out to play."

According to Levens, 95 percent of CrossFit Rx clients are ordinary folks who enjoy the challenge and effectiveness of the gym's classes. But then there's that other 5 percent—elite athletes who work out two hours every day in order to compete in CrossFit competitions. For the first time this year, the CrossFit Rx team advanced to the worldwide CrossFit Games, one of three teams from Atlanta to make the cut. The Rx team, which included Levens, placed 28th out of 43 teams, which Levens views as not bad for their first time out.

"Getting there was amazing," he says, "but realizing we actually belonged was the real reward. I hope to get back there someday." Like next year, maybe.

Atlanta's False Alarm Ordinance Amended

Atlanta District 6 Councilmember Alex Wan notified constituents that new penalties would begin for Atlanta Police Department responses to false alarms.

Councilmember Wan's August newsletter reported:

In an effort to improve public safety and better allocate resources, the City of Atlanta has enacted a series of amendments to the existing False Alarm Ordinance. In 2012, the Atlanta Police Department responded to 65,000 alarm system activations, 95% of which were false alarms or alarms that were cancelled en route. These calls represent more than 6% of the total 911 dispatches. With every call taking an average of 20-30 minutes, the equivalent of 8-12 full-time police officers were dedicated to responding to false alarms, thereby taking away valuable public safety resources from more pressing matters.

Under the amended ordinance, City of Atlanta residents and businesses are now required to register their security and burglar alarm systems. The new ordinance will take effect on September 15, 2013 and residents will have until February 1, 2014 to register without incurring an unregistered alarm penalty:

Registered Alarms

- 1st False Alarm: no fine
- 2nd False Alarm*: \$50 fine
- 3rd False Alarm: \$100
- 4th - 6th False Alarms: \$200
- 7+ False Alarms: \$500

* can be waived upon successful completion of an online alarm awareness class (limit one per 365 day period)

Unregistered Alarms

- \$150 penalty

Residents can register their alarm system for free online at www.crywolf.us/atlantaga or by calling 1.855.725.7102. Make a note of your permit# upon successful registration. You will need to give your permit# to your alarm company.

Friends of Candler Park Golf Course

Founder Michael Short announced that the Friends of Candler Park Golf Course has been working with Councilmember Kwanza Hall and the Department of Parks and Recreation on a new youth program.

Michael plans to submit a \$100,000 grant application this fall to Park Pride. The grant would cover the new youth program and fund other golf course projects. Among the items to be funded:

- clubhouse renovation, to include a new roof and new electrical wiring.
- construction of a new pond off of the fourth fairway, upstream of the existing beaver dam complex. A well and a pump are proposed for keeping the pond full, for keeping the downstream ponds fresh, and for supplying all of the golf course water needs.
- construction of a chipping/putting area to be used for the youth program's practice area.

According to Michael, last year Park Pride awarded nearly \$500,000 to projects and most applicants who sought funding were accepted.

The application deadline is September 27 and awards will be announced on December 1. This grant would have to be completed within 18 months.
