The Candler Park Tour of Homes will take place on Sunday, October 14, 2007 from noon to 6 pm. This year's 10-stop tour promises to have something for nearly everyone. The tour will feature seven houses, two lofts on Dekalb Avenue and a community garden with whimsical yard art.

The homes range from classic Craftsman bungalows to modern lofts. The construction dates span 107 years. Several renovations have used the latest "green" construction techniques including sourcing construction material locally, recycling all waste material and utilizing spray foam insulation. Security Patrol Update

The Security Patrol Committee met in mid-August to tally the results of our advertising efforts over the last six months. Roughly 10% of the neighborhood weighed in on the issue via our website survey at www.CandlerParkPatrol.com.

The majority of responders are concerned about crime in our neighborhood and would be willing to financially support a patrol (at varying price levels between \$50 - \$400/yr). However, based on the results of our survey, we estimate that a membership drive at this point in time would produce only about half of the total cost needed for a full year of patrol coverage. To put it another way, based on current estimated participation, we could only afford 10 hours per week. Our goal was at least 20 hours of coverage per week.

At this time, we don't feel we have the critical mass of support needed to launch a Security Patrol. However, we do believe there are other less expensive or free things we can do to improve security in Candler Park.

For instance, many neighbors are interested in the crime watch program, and 18 neighbors have indicated they may be willing to be captains.

The Security Patrol Committee will be working to get the ball rolling on the Crime Watches. We also plan to enhance the website with other security ideas, tips, information, etc. The survey on the website will remain in place and will continue to measure interest. This way, we can re-address the idea at some point in the future if the interest level increases.

2007 Fall Electronics Recycling Day

On Saturday, Oct. 27th from 9 a.m.-1 p.m, the Decatur Electronics Recycling Day will be held at the Decatur High School Parking Lot on the corner of N. McDonough Street and Howard Avenue. Don't throw away that old PC or printer—recycle it! The semi-annual recycling event has been hugely successful at diverting electronic equipment from landfills, where they may contaminate soil and water. Electronics dropped off that day will be sorted and disassembled into raw materials and sent to recyclers for reuse.

Desktop computers, telephones, mini-towers, telephony equipment, laptop computers, adding machines, monitors, calculators, servers, typewriters, workstations, label makers, keyboards, copiers, mice, fax machines, joystick game controllers, answering machines, printers, printer cartridges, digital cameras, zip drives, batteries, speakers, PDAs, pagers, VCRs, hubs, DVD players, routers, cable converter boxes, scanners, remote controls, digital projectors, stereo equipment UPS units, radios, main frames, portable CD players, component parts, portable game players, cables, GPS receivers, 3-in-1 devices, printer/copier/fax machines. Mercury thermometers and thermostats, clean Styrofoam (peanuts, packing blocks) free of foreign objects, and any kind of battery will also be accepted.


Volunteers needed for October 13th Paideia/Lullwater Creek Cleanup

Trying to Make "Gasoline Alley" a Bit Greener

It was nearly five years ago and the Edgewood, Candler Park, Reynoldstown and Inman Park neighborhoods had gotten their first glimpse at the proposed Moreland Avenue entrance lanes into the Edgewood Retail District. They weren't happy with what they saw. The proposed design looked like a suburban mall dropped in the middle of a very urban area, and the changes suggested for Moreland Avenue appeared more appropriate on Buford Highway. While NPU "0" was focused on the rezoning effort and cutthrough traffic concerns, the neighborhoods also banded together to form the Moreland Avenue Task Force to be more proactive about transportation impacts along the corridor.

In their proposal, the developer estimated the new retail district would generate 41,000 trips per day and 39% of those trips would be non-motorized. But the plans they created, with their double-left turn lanes, did anything but encourage non-motorized access. The Task Force developed a counter-proposal for a walkable street design with wide sidewalks, street trees, planted medians with pedestrian friendly islands, and other elements which were more likely to create better safety and bike/ped connections to the surrounding neighborhood. At the 11th hour and only after a lengthy, political process, the Georgia Department of Transportation (GDOT) agreed to the implement of the neighborhood plan.

Concurrently, Don Bender representing the Little Five Points Business Association and Candler Park resident Walter Brown, knowing that more comprehensive changes needed to be made along Moreland Avenue, had been lobbying for a corridor study. The Ponce/Moreland Corridor Study, jointly funded by several local neighborhood entities and the ARC, and managed by the City of Atlanta, officially began in late 2004 with representatives of more than ten neighborhood and business organizations. Covering Moreland from I-20 north to Ponce de Leon, and then west along Ponce de Leon to Peachtree Street neighbors met for six months fine-tuning recommendations for land use, zoning and transportation improvements along the 4 mile long combined stretch of busy collectors that bisect nearly ten historic register neighborhoods. In August 2005, the corridor study land use and transportation findings were adopted by the City in its CDP.

By early 2006, Brown and Bender began worrying about progress moving the study results forward - "If we don't keep this thing going, the recommendations will sit and gather dust." In the spring of 2006, they worked with Councilmembers Natalyn Archibong, Anne Fauver and Kwanzaa Hall to reconstitute the Moreland Avenue "Implementation" Task Force and this time the Task Force expanded to include the neighborhoods of Atkins Park and Poncey-Highland.

Atlanta City Council Approves Limits on "McMansions"

Excerpts from a Press Release submitted by The Atlanta City Council

In an effort to provide oversight for appropriate and orderly neighborhood development, the Atlanta City Council unanimously approved an amendment to the 1982 Zoning Ordinance to provide new limits on infill housing, an issue that has plagued city neighborhoods as Atlanta experiences an influx in new residents and property values soar.

For a variety of reasons old homes are torn down only to be replaced with a new and often larger building. This process of building new homes in established neighborhoods is referred to as "infill housing".


The compromise, approved by a vote of 14 to 0 (*Legislative Reference # 07-O-0642*), includes only those recommendations that were agreed upon by the following: The Infill Development Panel of Professionals (consisting of architects, homebuilders, realtors, planners and preservationists), the Mayor's Zoning Ordinance Rewrite Committee, and the City's Department of Planning and Development.


The legislation addresses the following elements of infill housing:

- Topographical issues by establishing the current grade of the land and restrictions on retaining walls;
- The inclusion of above-grade basements and attics with livable space counting toward the size of the home;
- And the insertion of Floor Area Ratios in the intermediate zoning categories where they had been inadvertently omitted from the Zoning Code.

The Rain in Maine

A few weeks ago, I was standing in the rain for an hour and a half beside a busy highway in Wiscasset Maine waiting for a lobster shack known as Red's Eats to open for business. I'm here to tell you friends, it was worth every minute. As I stood 10th in line watching the dump trucks and Volvos splashing by, I thought to myself "What kind of an idiot would do this?" With a perfectly fine looking sea bug establishment right across the street—and no waiting!—why was I and close to 75 or 80 other food freaks standing in this particular line? Because for 17-bucks, we were able to purchase one of the world's most magnificent sandwiches…a perfectly prepared Maine lobster roll. I'm talking huge hunks of sweet lobster, presented on a beautifully toasted hotdog bun, along with a small container of clarified butter. Yum.

My sweet baboo and I were traveling all over the coastline of what the Yankee's call "down east", stopping at lobster pounds and local eateries that we'd found listed in guide books or from surfing the web. We even stopped at that Mecca of catalog shopping, the hallowed halls of L.L. Bean. Although I much preferred the little Mexican restaurant on Deer Isle called EI EI Frijoles. Good lobster tacos there.

Even in Maine, lobsters aren't cheap. As noted above, we spent \$17 for a lobster roll at Red's Eats. Most places were advertising them around 10 to 15 dollars and a New England dinner (a 2 pound lobster, a dozen steamed clams, an ear of corn and some boiled taters) was in the \$30 to \$40 range. But hey, we were on vacation and getting things fresh is one of the key elements of truly good eating. So, what if we eat el el frijoles for a month? It was worth it. I highly recommend that you do a bit of research before heading out on any road trip. Then, you too can sit down (or remain standing) for some amazing meals.

Another food freak travel hint is to try local brews when you're on the road. I don't mean that you should try the local brews and then *get on* the road. Safety first. But, quite often you'll find that the food and beverages from a region compliment each other nicely. Washing down our lobster rolls with ice cold bottles of Shipyard was truly a fine thing.

During our travels, I also picked up a few good cookbooks. Browsing through used book stores and junk shops is a good way to build an appetite and find treasures you didn't even *know* you needed. 




















Join CPNO in 2007

August 23, 2007 NPU-N Report

The following items are those most likely to be of interest to Candler Park residents.

The board voted to defer consideration of a variance application for 1526 Iverson as the applicant continues to work with the neighborhood on mutually acceptable plans for redevelopment of the property. We also deferred a vote on a variance application for 354 Clifton Rd despite previous approval at the neighborhood level because the applicant did not appear at the meeting.

The board approved two special event permits: one for the 7th annual Candler Park Fall Festival to be held on Saturday and Sunday, October 13th and 14th, 2007 and one for the 7th annual Little Five Points Halloween Festival and Parade to be held Friday and Saturday, October 19th and 20th, 2007.

Lt Brady from the Atlanta Police Department indicated that overall crime is up in Zone 6 this year by 16%.

We voted to recommend adoption of a proposed ordinance that would clarify the requirements for approval as a historical lot of record, require public posting of intent to seek such status, and automatically disqualify properties in which structures have previously been built over the historical lot line.

We heard a report from the Mayor's office on a planned public-private partnership that will purchase Wayne Mason's property in the Northeast quadrant of the BeltLine. When the deal is finalized, the City will have 69% ownership in this limited liability corporation and will have acquired 20% of the BeltLine rail/trail right of way.

The board approved an application for Cameli's Pizza (located in Ford Factory Square on Ponce) to expand from beer only to a full beer, wine, and liquor license. Cameli's will be expanding their dining space and hours of operation too.

We deferred consideration of a proposed ordinance that would regulate the size of retaining walls in anticipation of receiving a revised version of the legislation.

Fast forward to today:

With the help of design professionals Cooper Pierce of Pierce Jones, David Green of Lord Aeck & Sargeant and Megan Holder of HOK, the Task Force worked for a year to refine specific recommendation that were adopted in the study for each intersection from Ponce de Leon to I-20.

The recommendations range from simple signal changes that would allow left-turning motion for southbound traffic at Briarcliff and Ponce de Leon to more substantive changes such as a mid-block crossing light between Euclid and Mansfield in conjunction with closing curb cuts in that area. Changes are proposed for every segment of the corridor, so log onto www.morelandcorridor.net to see what's been suggested, and to meet the members of the Task Force.

Brown has continued to lead the push to have these recommendations adopted. GDOT's Fast Forward program has agreed to do a comprehensive traffic study of the corridor beginning in September. Once they've analyzed how the corridor currently functions, they'll use computer modeling to plug in the Task Force recommendations and gauge their impact. They will be looking for minimal structural adjustments like changes in traffic signalization and lane striping to make Moreland Avenue function more smoothly. As part of the lead up to the DOT study, each constituent neighborhood representative has been tasked with communicating the Corridor recommendations to their respective neighborhood organizations. Walter Brown will be presenting to CPNO at the regularly scheduled CPNO meeting in September.

How will all this be paid for?

The city has \$160,000 in Quality of Life bond funds earmarked for proposed changes to Moreland Avenue, but that's certainly not enough to implement the many improvements that are needed. The Atlanta Regional Commission has added the recommendations to its LCI plan so federal funds can be sought to implement the changes, especially in and around the two MARTA rail stations covered in the study. There may be enough money soon to do the engineering studies that are needed to make implementation a reality. The next step would be to apply for LCI funding for the implementation of first phase recommendations, which could run to a million dollars or more.

Brown and Bender will tell you that it takes an extraordinary amount of patience to keep plugging away at a major project like this. They hope that as they continue to push it along, it will gather more and more of the mantle of "official" status and it will be harder for state and city officials to ignore. As Brown said, "I just told Don I hope we'll change the 'gasoline alley' nature of Moreland Avenue before I die. And hey, I'm 50 years old!"



The Wonderful Windows of Candler Park

Do you remember the "Doors of..." craze? Posters with the Doors of Georgetown, the Doors of Dublin, the Doors of Santa Fe? We can boast many fine doors in Candler Park, but the place of pride goes to our windows. The bungalows of CP display an array of double-hung windows that glorify the houses and illustrate the various window styles of 1900-1925 or 1930.

After owning four successive houses in Candler Park--built between 1900 and 1930—I admit it: most of my windows have been painted shut. In one house they were even painted *open*—just a crack. But all were original and I wouldn't have had it any other way.

The bungalows of CP display an array of double-hung windows that glorify the houses and illustrate the various window styles of the early 20th Century. The most common were double-hung wood windows with a single pane on the bottom and decorative divisions on the top sash. Vertical bars, diamonds, lozenges—wooden muntins cut the upper sash into these patterns and more. Some architectural historians even describe such windows as defining features of bungalow/Craftsman style.

Candler Park has been lucky—most original houses seem to have escaped the bane of mismatching replacement windows. Experts strongly admonish owners to avoid these. The specialists say the ads for vinyl replacements are—as one writer put it—obfuscations. The new windows save very little on energy bills compared with the large outlay of cash to buy them. Get storm windows instead, the experts say.


What about the new Craftsman-style houses in CP, and the additions to old houses? The new houses seem to keep to the period in spirit but not in strict detail. Often their windows lack muntins, but do feature pleasing proportions. Many of the old homes with additions, such as those on Candler Drive, use reproduction windows on the second floor to mimic the originals at ground level. In both cases, there's visual harmony with the neighborhood.

As for old homes that have been "updated" by interim occupants, someday you may see a homeowner prying a new improved vinyl window out, and fitting a fine old double-hung wood window in.

CPNO Meeting Minutes 08.20.07



Committee Reports

Alonzo Church, CPNO treasurer reported that the organization has a current balance of \$ 18,245.00 in the checking account.

Proposed funding discussed at this meeting included additional funding for the attorney representing CPNO in the lawsuit with American Pools. An additional three thousand dollar expenditure was proposed for this activity. A motion was made, seconded and carried unanimously.

Kashi Yoga, on McLendon Avenue is having an annual event on September 8th, with door prizes, etc. from eleven am to two pm.


