The construction dates span 106 years. Several renovations have used the latest "green" construction techniques including solar panels, sourcing construction material locally, recycling all waste material and using energy efficient cellulose insulation. The tour booklet also includes the popular article, "How to Research the History of Your Home" by Robert Craig, Professor, College of Architecture, Georgia Tech.

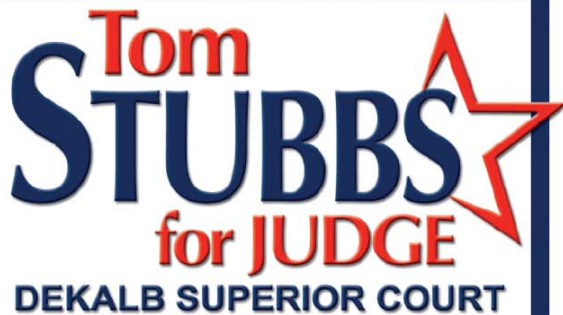

Swim Suit Settlement Proposed

The civil suit filed against CPNO and Candler Park Pool Association by American Pools earlier this year has reached a potential compromise, based on discussions between CPNO's attorney Steve Gibbs, and the plaintiffs, who settled with CPPA previously for ~ \$2500. Following case evaluation involving the parties, their counsel and a court-appointed outside consultant, held as part of pretrial procedures imposed by Dekalb County State Court during the summer, CPNO received an offer from the plaintiff to settle all outstanding claims for \$9000, about one-third of the amount originally sought. CPNO's earlier motion for summary judgment, dismissing all claims and seeking attorney's fees, was unsuccessful, while subsequent settlement offers by the respective parties at lower or higher amounts failed to result in any prospective agreement.

Although well-prepared to vigorously defend its case at trial, CPNO's board has considered advice of its outside counsel, and conditionally agreed to approve a proposed settlement, subject to a vote of the organization's general members in September. Such action would resolve the case without admission of liability by CPNO, while avoiding the uncertainty and expense of further litigation. Current pool operations by the City of Atlanta, which resumed during the 2007 season, are not affected by the litigation or proposed settlement. CPNO's own regularly-scheduled meetings and all 2008 organizational and committee activities, despite the contingent financial liability associated with the case, should continue regardless of its outcome, with no long-term impacts to insurability, corporation status or other material aspects of operations.

CPNO's board, together with our outside counsel (if available, and subject to confidentiality requirements), will attend September's general meeting to review the anticipated costs and benefits of settlement, hear concerns and gather input from members regarding disposition of the case. If approved as recommended by the board, and duly executed by plaintiff, settlement funds would be paid out of CPNO's treasury, which the board has confirmed will remain sufficiently and readily available, as early as September. If not approved, or further conditioned (pending acceptance by plaintiff), the case would likely proceed to a jury trial tentatively scheduled for January or later, and expected to last two or three days, followed by a judgment and award, if applicable. Please join your neighbors at our next CPNO general meeting to help positively determine the most appropriate course for CPNO in response to this settlement offer, and to better understand all aspects of the possible outcomes to the case.

- The McLendon bulbouts and curbside plantings – Ahh, our beloved bulbouts! Last fall, the CPNO initiated an incentive program to encourage Candler Park residents who live near bulbouts to adopt, maintain, and beautify them. CPNO offers up to \$50 per bulbout or curbside planting, based on a plan and receipts, to help defray the costs of soil amendments and plants. Alas, the outside watering ban went into effect about the same time. **But the offer still stands**, the watering restrictions have eased some, gray water works just fine, and the fall and early winter months are the best time to plant perennials so they can get established before spring. - Granmaw Gordon's greenspace at the corner of Gordon and DeKalb Avenue, Lake Claire – A group of neighbors on Gordon Avenue aim to transform a vacant lot into a community greenspace along busy DeKalb avenue, prevent the destruction of Granmaw Gordon, a uniquely valuable and very old pecan tree, and many other trees on the lot, and stop a planned development of condos. The Gordon Avenue neighborhood needs help with legal fees, among other things. Support the Granmaw Gordon greenspace and help these fine neighbors protect and develop a greenspace for the community. Don't Let Your Guard Down

I have lived on Euclid Ave. for over a year with no issues. However, last week, while walking the three blocks between my current residence and the residence I will move into in another month (also on Euclid Ave), I was mugged in broad daylight at approximately noon. A young African-American male (18-20 years), approximately 5'9 or 5'10" 170-180 pounds with unique medium length hair (thick corn-rows which had been undone), was standing at the corner of Mansfield and Euclid on the left side of the road. I passed him, acknowledged his presence, he acknowledged mine with a "hello" and I kept walking on the same side of the road. He proceeded to walk behind me, though at a normal distance, many feet back- nothing that felt threatening. He had nothing in his hands.

Many people were out running, walking their dogs, etc. We must have passed at least 4 or 5 people. Right before my home, I took a left to walk up the hill and get a better look at my parking space. He proceeded to follow me up the hill, increasing his gate and then I knew that I was in trouble but there was nobody around. The mugging took place essentially right outside my kitchen window behind the building. He then showed me tucked in the waistband of his shorts what could have been (though who knows what it was really) the handle of a revolver and said over and over "Don't do anything stupid" and "Give me your bag."

I had my car keys in my hand, a notebook, my phone in my back pocket and luckily just my camera bag- no purse. I was too shaken up to follow him and called 911 immediately, even as he was walking (not running) away. He walked back down the hill the same way he came up, which is somewhat surprising since so many people were on the main road. My gut impression is that he was a potentially reluctant participant in an initiation- that he had somehow been forced to do the dirty work, as he did not have a threatening way about him and spoke quietly and timidly. I almost asked if he was really serious because it just didn't seem possible in the middle of the afternoon with so many people close by, but I didn't want to risk it.

The responding police officer said this was highly unusual in the middle of the day with so many people in close proximity. I also learned from other members of Candler Parkside Condos that a violent attack occurred within the last month at the condos just to the left of Candler Parkside at 11 pm in the parking lot. The police suspect that it was an (unsuccessful) attempt at bringing the victim to an ATM machine, though two people were assaulted in the process.

My goal in writing this is simply to remind everyone to listen to your instincts and pay attention if something just doesn't seem right. Random crime is apparently a part of our community unfortunately. I know that I will be more vigilant. Because I acknowledged his presence, and he mine, I let my guard down. I didn't think about the fact that he was not walking anywhere (just loitering) when I passed him and that once I passed, he was then on the move. That should have been enough for me to stay on the main road or at least move toward any people I noticed walking or mowing their yards but I didn't. I know better next time.

Budget Committee Wants To Hear From You

The latest meeting of the CPNO budget committee was held on Thursday August 21st at Epworth, chaired by CPNO treasurer Alonzo Church and attended by seven of the 9 members, including Mike Brandt, Mark Clement, Jason Key, Greg Luetscher, Silvia Medrano, Destiny Ronay and Walt Weimar. The committee worked to better define its process for assessing funding priorities for 2009, and considered a number of specific ideas including retaining a website administrator; funding a program for sidewalk improvements; supporting a proposed Candler Park pavilion; a trails system within Candler Park; installing bi-racial historic markers in Candler Park; and development of a communal oven facility to hold neighborhood cooking events. A survey to solicit additional feedback from a broad spectrum of community residents and property owners, developed by committee member JoJo Ross, was reviewed and will be circulated to CPNO meeting attendants in September for more ideas and comments on issues of highest priority.

Some discussion by Greg Luetscher, Mike Brandt and other members focused on ways in which CPNO bylaws could be adapted to allow for annual budget committee formation and procedures, including whether the CPNO treasurer would automatically chair the committee. A process and schedule by which proposed spending would be established each December, and recommended for board and general membership approval each January, was proposed to improve efficiency and consistency in routine spending (e.g., meeting space rental, annual liability insurance, NPU dues and newsletter printing costs), while conserving discretionary funds unless approved for specific projects or purposes. The amount of funds to reserve against contingencies such as litigation or long-term objectives was also discussed, as well as means by which unanticipated ad hoc funding requests might be submitted and reviewed prior to any approval by general CPNO members.

Anticipated agenda items for the budget committee's next meeting, proposed for Thursday September 18th, include review of CPNO's comprehensive full-year cash flow and operations; a draft form and process for committee review and action on non-recurring funding requests; proposed bylaw revisions to implement committee formation and powers; and clarification of relationships between CPNO and other organizations which serve or support Candler Park's community's infrastructure, environment or culture, including Friends of Candler Park, Freedom Park Conservancy, PATH Foundation, Freedom Park Conservancy, Park Pride, Trees Atlanta, Peavine Watershed Alliance, "sister" neighborhoods (Inman Park, L5P, Lake Claire), governmental agencies, and others. Please contact Alonzo Church or any committee member to provide your input, or to learn more about their efforts to define best practices by which CPNO can manage and protect its growing resources, while at the same time identifying and applying available funds most effectively, to improve or promote the issues of broadest community concern or opportunity.

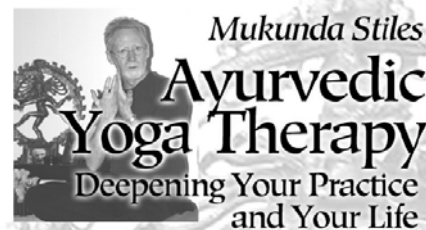

The Freedom Park Bird and Butterfly Garden continues to go Native

The Atlanta Audubon and the DeKalb Master Gardeners now has about 35 native plants in the garden located at the corner of North Ave. and Candler Park Drive. Several are in bloom now including Wild Senna, Joe Pye Weed, Cardinal Flower and Black-eyed Susan. Others have finished blooming: St John's Wort, Gayfeather, Celandine Poppy, Rosemary, Milkweed and Crossvine.

We planted a butterfly area at one end of the garden in May, with species that could provide nectar for butterflies as well as food for caterpillars. Species include Butterfly Weed (not Butterfly Bush which is not a native), Bee Balm, Fennel and Parsley. We've had several butterflies visit the garden, including Silver Spotted Skipper (see photo on page 13), Gulf Fritillary and Cabbage White, as well as Tiger and Black Swallowtails. Many of the latter's caterpillars have feasted on the Fennel and Parsley.

The bluebird box was active again this year (see photo on page 13). The nesting pair has since left the Garden box and moved across the street to neighbor Jim Satcher's bluebird house-we're hoping that next year there'll be two families of bluebirds in the area! Also seen in the Garden: a Chipping Sparrow, American Robin, House Finch, Northern Cardinal, those ole European Starlings, Northern Mockingbird, Red-headed Woodpecker and, overhead, two Red-tailed Hawks.

If you've thought about going native yourself, fall is a great time to start a native plant garden. This gives the plants enough time to set in their roots before winter arrives. If you're looking for native plants (which can be hard to find) check out the Georgia Perimeter College Native Plant Botanical Gardens website for their fall sales or try the Georgia Native Plant Society web page for a list of nurseries who've contributed native plants to the GNPS plant sale. Also come by and look at the Freedom Park Garden to get some ideas. We're in the process of labeling everything with planting requirements as well as with information about wildlife benefits. Keep in mind that the Garden is an evolutionary process. It will be several years before it fully matures.

We hope to fill in the Garden with more plants this fall-hopefully with the help of Mary Lin students. Skillet Lickin' Good

The Food Freak

A few years ago, the folks in Kennesaw made national headlines by passing a law that required all residents to own a gun. The idea was to put criminals on notice that the citizens of the town were armed and willing to defend their abodes with deadly force. I have a better idea. Why not make cast iron skillets mandatory for all households? Not only do they make the best fried chicken, they also make a formidable weapon. For instance, suppose you hear an assailant breaking into your space. If you own a well seasoned cast iron skillet, all you need to do is grab it and whack 'em up side the head. There's even evidence that cooking in an iron skillet increases the iron in your diet. Now how many items do you have around your house that can meet so many of your personal needs? You *could* use a brick to subdue your perpetrator, but you can't cook with one. Or can you...?

Here's a favorite recipe for a home style chicken dish featuring a cast iron skillet and a couple of bricks. Be sure to give yourself time to brine the bird.

4 large chicken breasts with skin and bones	½ cup kosher salt
2 cloves garlic	1 teaspoon sea salt
1 or 2 sprigs of fresh rosemary	3 tablespoons butter, softened
1 teaspoon freshly ground black pepper	2 tablespoons olive oil

Pour 8 cups of water into a large bowl. Add kosher salt and stir to dissolve. Add chicken to brine, making sure each piece is completely submerged. If it won't fit, you'll have to move things around from time-to-time. Cover the bowl, and then place it in the fridge for at least 8 hours, but no more than 12.

Remove chicken from brine and pat dry.

Wrap the bricks in several layers of foil. (Of course, you'll need *new* bricks. Used bricks are just not sanitary.)

Peel garlic, then mash with sea salt to make a paste. Stir in chopped rosemary leaves, butter and black pepper.

Divide the herb butter into 4 pieces. Gently run your finger between the chicken skin and the meat and then slide in a piece of herb butter.

Heat olive oil in a large cast iron skillet over moderately high heat. Place chicken in hot oil - skin side down - and cover with sturdy plate. Now place the bricks on top of the plate. Once you get things balanced, leave it alone for about 10 to 15 minutes. This makes a yummy crust.

Remove bricks and plate, and then carefully turn chicken taking care not to rip off the yummy crust. Cover the chicken with the plate again, and then add the bricks. Allow it to cook for another 10 or 15 minutes. If the pieces are fairly thick, give the sides a few minutes in the oil to add color and crust. Remove chicken from skillet. Cover with foil and allow it to rest for about 10 minutes. Enjoy!

Creating a Pool House Plaza for Candler Park

Many Candler Park residents have had the opportunity to enjoy Fall Fest band performances and movies in the park in front of the Candler Park Pool House. To help support these activities, provide a comfortable gathering spot, and support other creative programs in the park, the Friends of Candler Park want to build a plaza in front of the pool house.

One immediate benefit of the plaza is that it will allow the Fall Fest to continue to have its stage in front of the pool house. The drought has forced the Atlanta Parks Department to prohibit the placement of any temporary structures (like a stage) on grass. The plaza is designed to accommodate a stage big enough for Fall Fest. It also ensures that movie nights can continue (while the August showing of "Goonies" was rained out, we hope to have more movie nights in the not-too-distant future).

The plaza would be about 35' wide and 12' deep and would be located in front of the entrance to the pool house. An 18" high seating wall would enclose the plaza on three sides, helping to define the space and provide a place for folks to interact while enjoying the park. Already, volunteers from The Home Depot have install pavers as a first step toward constructing the plaza.

The Friends of Candler Park is seeking the endorsement of the Candler Park Neighborhood Organization for the plaza and particularly the sitting wall. We will make a presentation at the September CPNO meeting and ask for a vote supporting the plans. We are in the process of raising funds to build the sitting wall, having raised more than \$2,000 to date. We hope to raise the remaining funds through grants and a wine tasting dinner and fundraiser at the Flying Biscuit (more to come on that!).

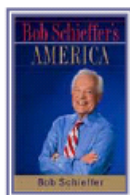

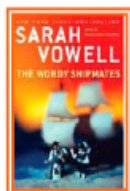

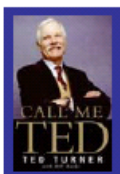

The regular monthly meeting of the Candler Park Neighborhood Organization, Inc. was held on Monday, August 18, 2008 at the First Existentialist Church, 470 Candler Park Church, with president Amy Stout in the chair. 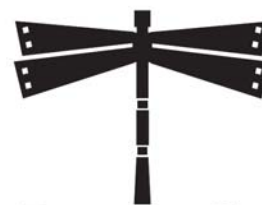
