# CPNO General Meetings Notes, August 16, 2010 Compiled by Lauren Welsh, Membership Secretary


### I. Welcome

The meeting was called to order by CPNO President Doug Wetzel at 7:10 PM with approximately 30 members and guests present.

### II. Public Officials/Announcements

- a) Mayoral Forum: Lauren Welsh made an announcement about the Intown Alliance group hosting a Mayoral forum on September 30 for District 6 residents. A request was made for \$50 to contribute to the cost of renting the facility. CPNO voted unanimously to support the \$50 contribution.
- b) Georgia State University: Georgia State announced their arts season and programming available to the student body and to all city of Atlanta residents. They encouraged members to visit the campus and sign up for monthly emails about arts updates.
- c) Fall Ball: Cherie King announced Fall Ball occurring again this year on the Friday before FallFest. There was some discussion around making money from the event, and Cherie let members know that volunteer group has downsized their budget quite a bit from the previous year using volunteers and minimizing the food. CPNO voted to support the event with the requested \$1100 by a vote of 15 in favor and one against.
- d) Atlanta Police: Lt. Schierbaum from the Atlanta Police Department came to discuss a few indicents in the areas. Neighborhood crime has been down over the last few months, but this past week there have been several incidents of hubcaps being removed from cars and a couple of cars broken into. The cars had a laptop and iPod in them. There were also two robberies in Inman Park one at 10:30 PM and one at midnight. The one at midnight fired at a group of individuals in a van as they came upon the

robbery and tried to drive away. Major Dalton met with Councilmember Wan and members of Inman Park to talk further about the issues. There was some discussion about graffiti in the neighborhood, and CPNO was reminded to call 911 if they see anything and to contact City Council and express concerned. Doug reminded CPNO of the graffiti kits that Trey has created to remove the paint. Graffiti kits are available at the Candler Park Market for check out. There was discussion around aggressive panhandling. Lt. Schiedbaum reminded CPNO that it used to be a crime to ask for money within 15 feet within a certain area but instead the city ordinance now focuses on aggressive panhandling. He reminded CPNO members that if their safety is threatened or they're being imposed upon then they should call 911.

- e) *Messenger*. The deadline for Messenger articles has been moved to the 23<sup>rd</sup> of the month in an effort to get the publication in the hands of residents earlier in the month.
- f) *Minutes*: The meeting minutes from the previous meeting were unanimously approved.

### **III. Officer Reports**

- a) Special Projects: The next Candler Park movie night is Saturday, August 28 and the movie is The Princess and the Frog. Cherie King made announcements about FallFest. They recently received approval from the city for the event application with very little changes to the site plan. Their next step is to present at the NPU meeting. Ken Edelstien has volunteered to help with PR. Recently the group brainstormed around themes to get media publicity, and the focus of the event will be on Halloween since FallFest is in between the Little 5 Points parade and Halloween weekend. Sponsorships are coming along well and are close to \$10,000. The deadline is being extended to the end of August.
- b) NPU-N: no report.
- c) Public Safety: No report. Doug reminded people about the importance of neighborhood watch and getting to know your neighbors. Park Atlanta is now ticketing for cars facing the wrong way on streets. Inman Park has many resident only areas. Replacing no parking signs should be done through City of Atlanta.
- d) Environment: In the next month will need another group of people to help replant some of the creeping fig along the MARTA wall.
- e) Zoning: There were four zoning issues brought to the CPNO meeting.

- 1. 325 Oakdale Road. Applicant was requesting to reduce required side yard setback from 7 ft to 6 ft to allow for a two story expansion of the home. The Zoning Committee reviewed and recommended support. CPNO unanimously approved the variance.
- 2. 442 Oakdale Avenue. Applicant was requesting to reduce required front yard from 35 ft to 23.7 ft, reduce half front yard from 17.5 ft. to 4.3 and reduce side yard set back from 7 ft to 2.2 ft to add a second story and a deck. The Zoning Committee reviewed and recommended support. CPNO unanimously approved the variances.
- 3. 1230 McLendon. Applicant was requested to reduce required side yards from 7 ft to 3.2 and 6.3 ft to add a second story. The Zoning Committee reviewed and recommended support. CPNO unanimously approved the variances.
- 4. 1320 Iverson. Applicant was requesting to reduce half depth front yard from 15 ft to 7.5 ft for a new home. The Zoning Committee reviewed and recommended support. There was discussion around the issue of trees being removed, and the applicant agreed to review the trees further with the city. The was discussion around water retention, and Randy informed CPNO that requests were made to the builder to water spouts that would move the drainage to the street instead of in the back yard. There was discussion around why a key neighbor nearby, the Brandts, chose not to sign. Regina abstained from voting on the Zoning Committee because she felt she couldn't be objective. She indicated that she recognizes the idea that the

area has to be developed but wishes it weren't quite so large to have 40 feet of house across the street from her home. Randy reminded residents that the Zoning Committee has no regulations about the look of a house and encouraged interested residents to consider Historic District status to get at issues like these. CPNO supporting the variance with 13 in favor and 4 against.

Randy also announced that Trey Long is joining Zoning Committee and David Aynes is taking a break. There was discussion about sharing additional information about Zoning with residents and Randy indicated he would email any interested residents with the information.

- f) Treasury: David Aynes reported that at the end of July, CPNO has \$84,900 total cash in funds with \$3,400 committed and \$81,500 uncommitted.
- g) *Membership:* Lauren Welsh announced that the Board had approved \$2500 for block parties for residents. The announcement will be in the September issue of the Messenger and will be voted on at the September CPNO meeting.

# IV. New Business

Trey Long on Josephine Street requested a \$250 reimbursement for the block party they recently held. Receipts will be provided to Membership Secretary. CPNO unanimously approved the reimbursement.

A representative from 112 Gallery announced an opening reception on Friday, August 20.

V. Adjournment The meeting was adjourned at 8:33 PM.

# Mary Lin Foundation Seeks CPNO Grant By Christie Kuropatwa


The Mary Lin Foundation submitted a grant application to the CPNO board in August 2010. The application was voted on and approved during the August board meeting. Voting by the general membership will take place at the September CPNO General meeting. This grant is to support an initiative called Project Green Learning on the Whiteboard or Project GLOW. The primary goal of Project GLOW is to raise student achievement by kindergarten and first grade students at Mary Lin Elementary using interactive technology. The secondary goal is to create a more environmentally conscious and sustainable learning environment in the classroom.

We are requesting a grant in the amount of \$5,000 to underwrite one-third of the total cost of purchasing and installing five interactive whiteboards and one set of 32 ActivExpression handheld student response devices to cover the Kindergarten portion of Project GLOW. Additional sources of funding for the rest of Project GLOW include parent donations, fundraising events, as well as grants from local neighborhood organizations and family foundations. The Mary Lin Foundation has already successfully completed the purchase and installation of interactive whiteboards for the second through fifth grade classrooms. Project GLOW brings state-of-the-art technology to Mary Lin and allows our local elementary school to continue to excel and compete among the top public schools in Atlanta.


Okay, there are a few more requirements than that, but CPNO wants to make it easy for people to gather, she here's how it can be done:

# CPNO General Meeting Notes July 19, 2010

### I. Welcome

The meeting was called to order by CPNO President Doug Wetzel at 7:10 p.m. with approximately 30 members and guests present.

### II. Public Officials/Announcements

- a). Atlanta Police: Sergeant Sinks and Lt. Schierbaum noted that a new police chief has been appointed and that changes at Zone 6 are underway. There have been car break-ins near the Little 5 Points area during the past month. There have also been a number of scooters stolen. Witnesses have seen a white van and a black El Camino during the times crimes occurred. Lt. Schierbaum cautioned residents to lock up scooters in garages or backyards to keep them safe. Parking enforcement has been turned over to Park Atlanta. Call 911 if you have concerns about illegal parking.
- b). November Election: Denise Warner introduced herself. She is running for Superior Court in DeKalb County. More information on her platform and qualifications can be obtained from her website: <a href="https://www.denisewarner.com">www.denisewarner.com</a>
- c). City Council: District 6 Representative Alex Wan apologized for not attending CPNO meetings recently. He explained that Council has been meeting on Monday evenings to hammer out the City's budget. He updated CPNO on the City budget, new appointments and other topics. He noted that recycling costs perhousehold will increase from \$30 to \$88 this year. The rate had not been increased since 1994. The increase will allow the City to continue to provide weekly recycling services. trimming pick up will move to a bi-weekly schedule. A resident questioned why City pools are closing on August 1. Councilman Wan said neighborhoods could form cooperatives to keep pools open longer and that he would be willing to work with CPNO on this. To contact him please write to awan@atlantaga.gov.

- d). Bike Raffle: Dave Aynes announced that the Candler Park Market is raffling a hand-painted, limited-edition bike, the proceeds of which will go to CPNO.
- e). Funds for Counsel Review: Dave Aynes, CPNO Treasurer, has been coordinating the organization's efforts to develop a formal process and application for groups requesting funds from CPNO. He requested up to \$499 to hire a lawyer to review a draft application form. This motion was approved by a show of hands. After it is reviewed by counsel, the application will be made available to the community for comments.
- f). Grandmaw Gordon. Teri Stewart reported that her group went to Superior Court July 13 to stop development on a property along DeKalb Avenue. A ruling is expected by October 25. Teri asked neighbors to contribute to ongoing legal costs. She is making a presentation on the history of the Gordon property during Battle of Atlanta festivities July 24.
- g). Movies in the Park: Mark Clement reported that the next movie is scheduled for Saturday, July 24. The City may require the hiring of one or two security guards to patrol the event due to concerns about events at a recent Piedmont Park "Screen on the Green." Mark requested up to \$200 to pay security guards if they are required. After a discussion, this was approved with a show of hands. Neighbors asked for an accounting of Movie Night funds. explained that these are managed by Park Pride, a fiscal intermediary, which provides monthly reports on how the funds are used. interested in the reports should contact Dave Aynes at treasurer@candlerpark.org.

## **III. Officer Reports**

- a). Fall Fest. Kate Sandhaus and Cherie King have volunteered to chair Fall Fest. Neighbors greeted this news with vigorous applause. Kate noted that this is the 10th annual Fall Fest and that volunteers are needed for the festival. 5K and tour of homes. Fall Fest is scheduled for October 23-24. Dave Aynes noted that the Fall Fest Committee has set as a goal \$20,000 in sponsorships and \$13,500 in artist market fees. In his analysis, under a "worst case" scenario CPNO could lose up to \$10,000 on the event. Under a "best case" scenario CPNO would make up to \$20,000. After discussion about liability and other issues, members unanimously approved moving forward on Fall Fest by a show of hands.
- b) Midsummer Music Festival. Sponsors of the MMF wish to donate \$4,000 to CPNO. Mark Clement stated that he had been told by

City officials that it was not legal for CPNO to accept these or similar funds. City Council Representative Alex Wan said that it was legal and that he would provide further information on this topic to those interested. A motion to establish a CPNO Committee to explore the legality of the issue was not seconded and was withdrawn. A motion to accept the donation was approved by a show of hands with one person opposed.

- c). Environment: Trey Long reported on his efforts to plant creeping fig along DeKalb Avenue June 26. For most of the morning he and his wife were the only volunteers. They were joined by a few others later in the morning. Half of the plants have not been planted and a second planting will be scheduled this fall. Those wishing to help should contact Trey at environment@candlerpark.org.
- d). NPU-N: Amy Stout told CPNO members her report is available in the Messenger. In addition, she noted that an application for a pub in the former Salon Red premises on Clifton Road had been withdrawn.
- e). Public safety: no report.
- f). Zoning. Randy Pimsler introduced the owners of 325 Oakdale Road, who have requested a variance for a reduction of the side yard setback. Randy noted that CPNO's Zoning Committee voted not to approve the variance (5 persons opposed, 1 abstention). The property owners requested that CPNO vote on the variance rather than deferring their vote. CPNO voted to support the Zoning Committee's recommendation 13 to 4 with one abstention.
- g). Treasury: Dave Aynes reported that, as of the end of June, CPNO has \$79,400 in funds with \$3,000 committed and \$76,400 uncommitted.
- h). Membership: Lauren Welsh thanked Kay and Jay Sandhaus for their work on the CPNO website. A proposal for block parties will be voted upon by the CPNO Board during its August meeting.

Sarah Wynn, Clifton Ministries' Community Representative, thanked CPNO for its \$3,000 donation.


Donna Palmer announced that the Candler Park Water Ballet will put on a free concert at the Candler Park Pool July 31 at 5:30 p.m.


### Food Trucks Coming to Candler Park Fall Fest!
