NPU Update By Jay Sandhaus, CPNO President

Our NPU (neighborhood planning unit) met on September 22nd to discuss zoning, upcoming events, and other issues that impact our neighborhoods. As a reminder, the City of Atlanta is divided into twenty-five Neighborhood Planning Units or NPUs, which are citizen advisory councils that make recommendations to the Mayor and City Council on zoning, land use, and other planning issues (as described by the City). We are in NPU-N along with Lake Claire, Reynoldstown, Inman Park, Poncey-Highlands, Druid Hills, and Cabbagetown.

The NPU received visitors from various city departments. The Police Department said that 100 new officers will be hired this year and they are actively looking for recruits. The Fire Department reported that the entire fleet of trucks will be replaced in the next few years. Both Parks and Code Compliance talked about graffitti; the City has a dedicated police officer and the Parks department has set up a hotline at 404.546.4288. Apparently our part of the city has the most graffitti.

There were no Candler Park zoning or liquor license matters on the NPU agenda this month. The NPU did vote to recommend the application for the Clips of Faith Beer & Film Tour in Candler Park on September 30th. The CPNO also introduced our proposed process for vetting events that take place in our neighborhood.



Changes Slated for Lullwater Bridge By Jennifer J. Richardson

The Georgia Department of Transportation has determined that changes are needed in the bridge over Lullwater Creek on Ponce de Leon. Ponce de Leon Avenue is also known as State roads 10 and 8, and US Highways 29, 278, 23 and 78, and Federal funds will be involved in any work done on the project. The bridge, built in 1922, will be the subject of upcoming load testing to determine if it needs to be replaced entirely, or can be renovated. These tests will likely occur in mid to late October, from 9:30 a.m. to 1:30 p.m., and may disrupt traffic for up to four days. Watch for additional information on the DHCA web site or in an E-Alert.

The Lullwater Bridge is considered an historic structure, and is located within the Druid Hills Landmark District and is eligible for National Register designation. Therefore, extraordinary means will be taken to protect the historic integrity of the bridge. A group of stakeholder organizations met for the first time on September 13 with representatives from the GaDOT, and from the Arcadis Project Team. Some of the groups represented included Olmsted Linear Park Alliance, Lullwater Garden Club, NPU-N, Ponce Corridor East. Lullwater Estate Homeowners Association, DeKalb History Center, and The Paideia School. The purpose of the stakeholders meeting is to solicit neighborhood input and advice into the planning process, and for each group to keep their members informed. The stakeholder group is expected to meet at least three more times.

After tests are completed in October, the GaDOT is expected to announce whether the bridge must be completely replaced, or if it can be renovated and strengthened. Additional information will be covered in upcoming editions of the DHCA news. Whatever is decided, actual work on the bridge will not begin until 2014. Historians have been unable so far to find any construction plans for the current bridge. The present bridge replaced a bridge that was designed by the Olmsted Firm, and was presumably built, though no known photographs of the first bridge exist. It's not known why the original bridge was removed, or who designed or built the 1922 bridge. 

CPNO General Meeting, September 19, 2011 Submitted by Cherie King, CPNO Secretary

- -Meeting was called to order at 7:01 p.m.
- -Welcoming remarks. President Jay Sandhaus welcomed approximately 30 members and guests to the meeting. A motion to adopt the agenda was approved by a show of hands.

-City Officials & Other Visitors

- 1. Major John Dalton, Atlanta Police Department (jdalton@atlantaga.gov) Officer White stated that compared to last year pedestrian robberies are down. There was one residential robbery on DeKalb Avenue which happened between 3 p.m. and 11 p.m. Vehicle robberies are up. Residents are leaving things in their car that is visible from the outside. Officer White encouraged residents to not leave valuables in their vehicles. If you witness someone tampering with a car, keep your eyes on the person while you are calling 911. Stay on the phone with the police and give them updates. Auto thefts are happening on morning watch which is between 11 p.m. to 7 a.m. Day watch crimes are up 70% from last year. Morning watch up 10% from last year. A neighbor asked about the homeless campers who were staying behind Sherwin Williams. Officer White did not have additional information about this situation. Officer White suggested that the neighbor call 911 if they see the homeless campers. A neighbor asked if there were any characters we should be looking for? Officer White stated that there is not just one person to look out for in this area. A neighbor asked about the speed trap on Freedom Parkway. Officer White stated that it was not in our beat. A neighbor stated that with police in such need that it seems to be a waste to have these resources focused on writing speeding tickets. Officer White stated that these officers are only for writing traffic tickets. Officer White stated that if they can catch speeders, they will sit there. A neighbor stated that the 35 MPH on Freedom Park is not realistic. Officer White stated a couple of people have been killed by speeding cars on Freedom Parkway. Officer White stated that you can only do lasers on certain streets. A neighbor asked about who they should call for graffiti on back of a speed limit sign. Officer White stated that there is an officer assigned to graffiti. This officer will take photos and will monitor the situation. Traffic signs are City property.
- 2. Councilman Alex Wan, Atlanta City Council (awan@atlantaga.gov) Alex apologized for not being able to make some of our meetings. Unfortunately, our meetings are on the same night as the council meetings and NPU-F meetings. His lack of attendance was purely schedule conflicts and not because he does not love us. Alex stressed that if anyone has questions or issues to just email him. Public Works has moved the trash pickup days. They are starting to work out the issues. Email Alex if there are issues with trash pickup. Alex has received a couple of emails about Candler Park and what are the proposed changes for the golf course. Alex has been assured by the Parks Commissioner that nothing is going to happen until after the visioning sessions. The visioning sessions will be taking a comprehensive look at the park. The ultimate decision on what happens to the park and golf course is the Parks Department. The timing of the visioning project is good because the City Council has asked the Parks Department to look at park assets and determine the capacity of parks to make sure they are not overburdened by events. Analysis will start this fall after the heavy park season. Some parks are getting hit hard and there are other parks that could accommodate events that are not being used. The current hot issue is redistricting. The 2010 census results are back and they show a shift in the population. There is a wide variance between small and large districts. The City Council approved Sunday alcohol sales to be on the ballot. Alex helped bring this legislation forward. A neighbor asked who decides how long traffic lights last. Alex replied Public Works. A neighbor stated that the Moreland lights do not stay green very long. The Mayor has talked about retiming the lights in the city. Price tag is \$1 million or more to do that.
- 3. Aaron Bastian (abastian@atlantaga.gov) and Taylor Carson (tcarson@atlantaga.gov), City of Atlanta, to discuss SHINE (Sustainable Home Initiative in the New Economy) shineatlanta.com There are rebates available for weatherproofing your house. The steps are simple first you must get a home energy assessment. Georgia Pacific is offering 50% back on assessment costs. Once you get an assessment, you will get a report of the findings. This report will tell you what you can do to your home to make it more energy efficient 20% savings are the average. Great time to take advantage of rebates. The rebates are funded with federal money. They are doing a special promotion in our neighborhood. If you go through a home assessment and make some of the improvements, SHINE will pay for the other 50% of the assessment costs.

The rebate program is available to anyone who is a City of Atlanta homeowner. The property does not have to be owner occupied. The contractor who will be making the improvements will complete the rebate paperwork for the homeowner. The contractor will do the work and sign off on the paperwork. SHINE will verify that the work done was reasonable. Average cost of assessment (varies by contractor) is \$400 (based on age and SF of home). The federal government wants to understand how many people are going to take advantage of this program. Work must be done by a qualified contractor. Homeowner selects what they want to undertake. A neighbor asked how SHINE knows the contractors are reputable. SHINE evaluated the contractors that are on the list. A neighbor asked what the ballpark was for repairs. The average for our neighborhood was between \$5,000 and \$6,000. SHINE does quality assurance on all the contractors. They make sure the work was done and done correctly. A neighbor asked about gas rebates. Atlanta Gas Light has rebates for gas customers.

-SHINE is a residential weatherization rebate program offering City of Atlanta homeowners (single-family) the ability to receive up to \$3,500 in rebates towards qualifying improvements. Improvements include, but are not limited to, duct and air sealing, insulation improvement, caulking, weather-stripping, and window replacement. Additional incentives are available for high efficiency domestic hot water heaters. Georgia Power customers may also participate in the Georgia Power Home Energy Improvement program, a residential program promoting a comprehensive, whole-house approach to improving the energy efficiency and comfort of existing homes. Customers may qualify for up to \$2,200 in rebates depending on recommended improvements made. Residents may also qualify for a potential \$500 federal income tax credit if they make certain home energy improvements during 2011.
