# CPNA Takes Over Officially

In an amazingly swift power play, the Candler Park Neighborhood Association (CPNA) annexed the Lake Claire neighborhood as well as the Druid Hills neighborhood. The CPNA, not to be confused with the longstanding Candler Park Neighborhood Organization(CPNO), "put the pressure on" as one onlooker described it during the contentious City Hall meeting. "It was just like that movie 'The Godfather' except it was a lot quicker and nobody got kissed or 'whacked' or whatever you know." said Kent Faogelby, a Candler Park resident and secret volunteer with the former CPNO. Apparently, the adjoining neighborhoods never knew what hit them.

CPNA leader and lord gaud almighty, Hester "sidewalk" Faith-Healy, said she was just getting tired of carrying everyone else's burden and decided it was time to put up or shut up. Faced with the indomitable task of the latter she decided to put up and proposed "the" idea to City Council floater rep Mary Neitherwood. The idea -take 'em out and reap the accrued membership dues to build bike lanes everywhere. "I don't ride, lord knows, but I always wanted to and it just makes me feel good to know I did something." said Faith-Healy. Former CPNO participants Georgina and Olli Garke were on

hand. When asked what were they to do, they responded "We will thwart her at every turn. Like a mighty oak in a lonely corner we will work quietly but strongly to block her vision." Asked why Druid Hills was included, Faith-Healy responded "It was there and they weren't looking so we just did it. There's a lot of money on those streets you know."

Fern Mussolini, of the now defunct CPNO, said he sensed that change was coming. "Well, you know, we just have to work with our new partners and do our best." said Fern. Surprisingly, no one from Lake Claire or the Druid Hills neighborhood would comment.

In other news, Candler Park, the namesake of the neighborhood, has been sold to local mogul and developer, Brent Burgerfellar. Plans aren't solid but initial word is that a "WhiteWater" like theme park will replace the golf course/swimming pool area. "The playground will be spared" said Burgerfellar. "It'll be my legacy to the neighborhood... But the pool is mine." Local hackers, whiffers and bobbers are up in arms about the sale but there's little to be done now. Look for the website soon.

#### What CPNO Does

This is the first of several brief Messenger articles in which I plan to describe what CPNO does and how it does it.

One function of the organization that is crucial to our quality of life and continued liveabilty of our neighborhood is dealing with major issues immediately impacting Candler Park. These include the Sembler Project, the Ponce/ Moreland Avenue Corridors Study, Freedom Park, and the Candler Park Brook Project. CPNO deals also with other issues that are not so close and critical, such as the Belt Line and the parking deck in Piedmont Park. Votes taken at CPNO meetings are recognized by the City of Atlanta as the official voice of the neighborhood. CPNO's role involves informing residents, being a forum for discussion, and making an effort to reach consensus on these

major issues.

CPNO has representatives on area and citywide bodies such as NPU-N, Freedom Park Conservancy, and Police Zone 6 Citizens Advisory Council. Their role is communicating with CPNO regarding issues being addressed by these bodies, as well as conveying to these bodies and advocating positions taken by CPNO.

In addition, CPNO addresses ongoing, quality of life issues internal to our neighborhood. These include dealing with variance issues, the block captain program, and sign toppers. In the future we hope to emphasize sidewalk improvement and tree planting. These efforts are spearheaded by our vice presidents for zoning, safety, and environment. To make some of these improvements more easily fundable, our

vice president for finance/treasurer is taking the lead on establishing the Candler Park Foundation as a 501(c)3 tax exempt organization to provide a conduit for tax exempt contributions to fund specific neighborhood improvements. (Neighborhood Organizations, such as CPNO, cannot receive tax exempt status from the IRS.)

We also have an annual cycle of events primarily for the enjoyment of Candler Park residents and our neighbors. Our vice president for special events has important responsibility here. FallFest weekend (in 2005 on October 15 and 16) is the largest. There is also the Candler Park Pool, operated by the Candler Park Pool Association. CPNO has representation on the CPPA Board of Directors. Finally there is the annual election of CPNO officers. The election takes place at our November meeting with the terms beginning January 1.

The monthly cycle that keeps the wheels of CPNO moving includes publication of the Messenger and our monthly General and Executive Board meetings (both open to all members).

Finally I'm pleased to announce that Matt Bolch (404-523-9123, mbolch@mindspring.com) has agreed to be Chair of our 2005 Tour of Homes which will be on Sunday afternoon October 16. Please contact Matt if you wish to volunteer for the Tour's Committee, open your home to your neighbors, or volunteer to help out on October 16.

As always, I appreciate any input you may have for me on CPNO and issues affecting Candler Park.

# Who's That Knocking On My Door?

Candler Park has its share of panhandlers and transients. There have also been many reports over the years of unknown people knocking on doors at various times of day and night. The reasons vary but it frequently involves some sort of request for money. Recently there was an incident in our neighborhood in which a man was woken up by a knock on his door around 4:00 AM. The knock persisted so the man called the police. The police came in time to question the man doing the knocking, and he was able to provide identification and a plausible explanation. The police had to let him go and there wasn't a police report. It is not illegal to knock on someone's door at any time of day!

So what are the laws? There is an Atlanta city ordinance that requires door-to-door sales people to obtain a permit from the APD. There is a fee unless they qualify to exempt out of the fee. You are within your rights to request to see the permit. If they don't have a permit, they are in violation of city ordinance 30-611. If you call the police about such behavior, they will be escorted out of the neighborhood.

It is not against the law to beg or ask for money. City ordinance 106-85 prohibits begging if it is "in such a manner as would cause a reasonable person to fear imminent bodily harm..." or when "continuing to request, beg, or solicit alms to whom the request is directed has made negative response, or blocks the passage of the individual addressed."

Candler Park has its share of people who go door to door looking for work. They frequently offer to do yard work, some even come with rake in hand, and ready to do the job. The Atlanta Police have strongly urged us to never hire people on this basis. There have been many incidents where items are stolen during the time the work is done or very soon afterward

So what does one do when solicited? That is largely a personal decision but one that needs to made in a way that protects yourself and your property. There are many people who legitimately need help or a hand up. There are many ways to be a good neighbor and help the needy. Please carefully consider where your charity will do the most good.





# Art In Freedom Park -- One Month To Go.

As I write this article there are only 38 days until the official opening of Art in Freedom Park. Art in Freedom Park is a temporary public art exhibit within the boundaries of Freedom Park. artworks, performances and events, the goal is to encourage neighbors, area residents and visitors to explore the park frequently, as each visit should bring a new experience.



# Rediscover Kirkwood This Spring --Festival and Tour of Homes

Relish a beautiful spring day in Kirkwood while enjoying an artists' market, local food and beer, music, and ~a glimpse of Atlanta's historical past and present. All this and much more awaits you at the Kirkwood Spring Fling and ~Tour of Homes on May 14-15.

There is a broad scope of activities planned for the Spring Fling including a field day (think egg toss, three-legged race, relays, and other games you haven't played since childhood) and a designated kid's activity area in addition to festival standards such as live entertainment, food, beer, and artists. # **Green Space**

It's that time of year again: Spring. Flowers bloom. Birds sing. Weeds grow.

Weeds can be a problem in a lot of ways. They can crowd out desirable plants and use up precious water, soil nutrients and space. They can be poisonous to you or your pets. They can provide shelter for pests and diseases. They can aggravate human allergies. Some weeds cause fire hazards when they die. Others cause erosion problems. And some weeds just plain look or smell bad.

Weeds are a fact of life in our neighborhood, but did you know that all neighbors have a legal duty to control them? That's because Section 158-4 of the Atlanta Code of Ordinances makes it unlawful "for the owner or occupant of any lot, tract, parcel of land or premises in the city to permit the growth thereon of weeds or vegetative overgrowth which endanger the public health, safety or welfare."

The weed ordinance obviously isn't intended to turn every dandelion into a major crime, but it can help when friendly attempts to resolve serious weed problems are not successful. If there's an overgrown yard near you, call the Atlanta Department of Public Works (404-330-6240 or 404-330-6254). The weed ordinance makes the Commissioner of Public Works responsible for enforcement.

Getting the city to enforce the ordinance might not be easy, and you may have to be persistent. Keep records of your calls, and make sure you get the name of the person you talk to. If you have trouble getting a response on your own, try asking your city councilmember (Anne Fauver) for help. The CPNO may also be able to help by making a request for enforcement on behalf of the neighborhood. Feel free to contact me for more information and assistance.

We will never rid the neighborhood of all noxious weeds, but together we can make overgrown yards a thing of the past.

#### LAND USE ISSUES

The following land use issues are scheduled to be heard and voted on at the April CPNO meeting. Land use issues to be voted on at the May meeting must be submitted prior to April 26.

292 Oakdale Road - (V-05-97) - John and Colleen Heflin, owners of a single-family structure at 292 Oakdale Road (zoned R-5) seek a variance from zoning regulations to reduce north side vard setback from the required 7 feet to 2.6 feet to allow for the alteration of the roof line and construction of an attached garage. Applicant has advised that the proposed project will intrude no further into the northerly side yard setback than currently occupied by the existing principal structure. Applicant has also advised that efforts will be made to incorporate stormwater mitigation features in the project design, including pervious paving to extend an existing driveway. This application will be heard by NPU-N at 7PM on Thursday 28th at Epworth Methodist Church, and by the Atlanta Board of Zoning Adjustment at 1 PM on Friday, May 20th at Atlanta City Hall, 2nd Floor Council Chambers.
