Candler Park Brook Project Construction Begins Soon

If you have been reading our pages closely – and we can't imagine why you wouldn't – you have read about a significant project in the park that would restore Candler Park Brook back to a naturalized streambanks. And now – May 15, 2006 -- is the scheduled time for the project to begin.

The key word, unfortunately, is "scheduled". As we go to press, not all permits have been issued. Therefore, a firm construction start date is difficult to predict. The contractors have indicated that they will need 10 days to 2 weeks to start, after all approvals are received.

The project involves significant amounts of construction. Old concrete banks have to be removed, and a new pipe installed under the Candler Park cul de sac. The full project is expected to take 12 weeks, though some

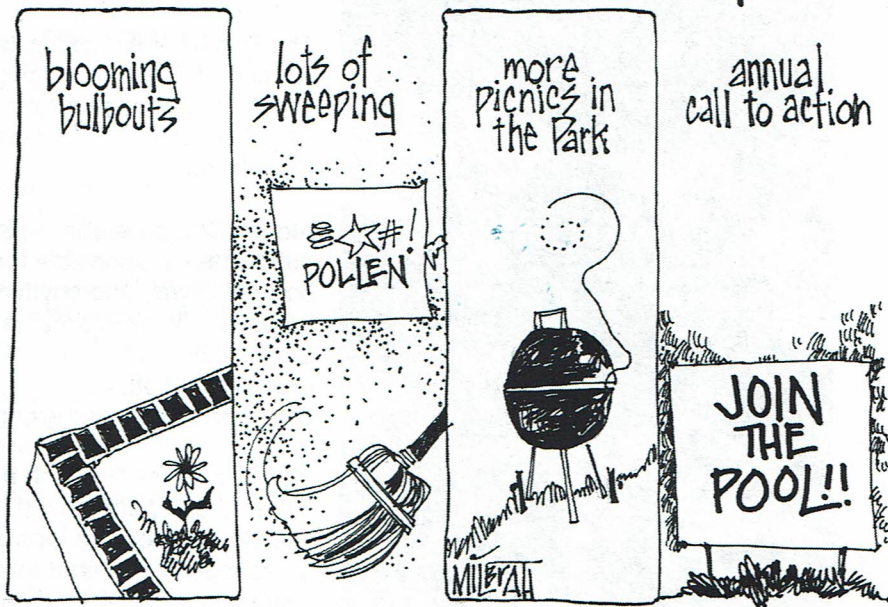
planting is expected to be completed this fall, inclusive of time to complete landscaping.

At about the same time the brook project commences, Candler Park Golf Course will be closed in order to install a new sprinkler system. The course is expected to reopen by November.

Additionally, between May 15th and approximately June 5th, the playground and adjoining sidewalks will have to be closed. While every effort will be expended to keep the disruption caused by construction at a minimum, there may be times when parts of the park will look like – a construction site. This is a temporary situation, and the reward at the end will be a greener golf course and natural stream in place of today's concrete culvert by Terrace Ave.

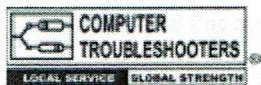

In Memoriam: Carol Frances Cummings, Former Candler Park Resident

Carol Frances Cummings, nee Riemer, died suddenly the 10th of April in Suchitoto, El Salvador four days short of her 68th birthday. She was born in Rochester, New York in 1938 of Ernest, a Presbyterian minister, and Helen, a kindergarten teacher, growing up in Wyoming and Scottsville and Auburn New York. She graduated in 1960 from the College of Wooster inclusive of a year at the International Christian University in Tokyo. She then earned a Masters in New Testament Studies in 1964 from Union Theological Seminary - Columbia University. There she was an active participant in St. Marks in the Bowerie Episcopal Church and worked for the Presbyterian Junior Year Abroad program. In the 1964 she moved to Cambridge where she worked for the Journal of Biological Chemistry and became a part of the Old Cambridge Baptist Church community where she met her future husband Frank Cummings. The day of their marriage in 1967 they began the journey to Atlanta, GA where Frank joined the faculty of Atlanta University and where they lived the next 34 years.

Much of the first years in Atlanta were devoted to their two boys, Andrew and Mark. Carol took an active role in the Atlanta Cooperative Pre-school, one of the few truly

integrated preschools in Atlanta at that time. Frank and Carol soon began attending the Atlanta Friends Meeting, which helped channel Carol's activities to end the Vietnam War through non-violent action. This opposition to war and use of violence to resolve conflicts was to continue throughout her life, especially during a sabbatical year in Halifax, Canada where the Canadian Mounted Police captured her image numerous times in vigils of the peace group, Voice of Women.

As the two boys grew Carol began working under the Title I program in Mary Lin Elementary School in Candler Park where she soon was president of the PTA helping to start an artists-in-the-school program. She worked for Atlantans for International Education and later Physicians for Social Responsibility while constantly trying to change US policy on nuclear weapons. Starting in 1985 she held a succession of secretarial and administrative assistant positions in the School of Public Health until her retirement in 2001 including several years with the Southeast AIDS Training and Education Center. To her great surprise she became the condom lady for teenagers throughout Candler Park as the understanding of AIDS spread. During the last

decade of her time at Emory she worked closely with the now Associate Dean, Dr. Kathy Miner. She was remembered by a colleague at her retirement party as the conscience of the school.

In the mid-80s, Carol took a key role in moving the Friends meeting to declare Sanctuary for refugees from the wars in Central America. The Cumming's home became a way station for numerous Central American refugees and Carol took on the practically full-time role of social worker, organizer of events, political advocacy, and host to speakers. The human bonds formed led her to El Salvador in March 1991, before the end of the war, to visit a small community, El Sitio Cenícero, formed of Salvadoran refugees returning from UN camps in Honduras leading to the creation of a sister community relation between El Sitio and the Friends Meeting. Over the next 10 years the Cummings visited this community yearly.

Realizing their Quaker prudence allowed them to retire early, the Cummings moved to El Salvador in 2001 to finish their active working life using their talents to help development. They soon settled in Suchitoto, a small colonial town, where Carol helped in the kindergarten of one of the public schools, served on

the neighborhood committee and various environmental committees of the municipality and served up refreshments for Frank's 9th grade English classes getting to know a whole generation of students in the town. But, her favorite role was as playmate with her grandchildren.

Throughout her life Carol sought to build community and to end the use of violence as a means to solve problems. She gave endlessly in her quiet but determined way to heal the wounds of the afflicted.

She is survived by her husband Frank; sister and brother, Barbara Guy and Richard Riemer; son Andrew and daughter-in-law Aracely Mendez de Cummings and their children, Ricardo Francisco and Laura Carolina; and son Mark and his son Bryson.

A service of remembrance in the manner of Friends will be held at the Atlanta Friends Meeting 13 May, 2006 at 3:00 pm. In lieu of flowers, the family encourages contributions to the Atlanta Friends Meeting (memo "El Sitio Scholarship Fund").

Vote on Zoning Amendment This Month

The Zoning Committee has proposed a change in the bylaws of the Candler Park Neighborhood Organization to remove the exclusive authority of the committee to decide land use matters and make their decisions into recommendations to the organization instead.

The current bylaws state, "There shall be a zoning committee which shall be responsible for reviewing and making recommendations to the neighborhood organization on land use and zoning issues. All applications for zoning variances and special exceptions and rezonings related to properties within the neighborhood shall be automatically referred to the zoning committee, which shall have the authority to act on behalf of the neighborhood organization with regard to such matters without notice as otherwise required. The zoning committee shall have no fewer than three members and no more than seven members. The zoning officer shall chair the zoning committee, and the board of directors shall appoint the other committee members. All meetings of the zoning committee shall be open to

any member and to nonmembers at the discretion of the chair."

With the proposed amendment, the second part of the second sentence would be deleted (starting at "which shall have...") and replaced with "prior to being brought before the general membership. The zoning committee shall present the application and its recommendation as to the appropriate action to be taken on the application to the general membership for approval. After such presentation, the general membership shall vote whether to adopt or reject the recommendation of the zoning committee."

In addition, the final sentence would be changed to read, "All meetings of the zoning committee shall be open to any member and, at the discretion of the chair, to nonmembers."

Please attend the May 15 meeting to vote on this proposal.

Highlights of the April CPNO Meeting

Lt. Davidson from the Atlanta Police Dept reminded residents (1) that a permit is required for dumpsters located on the street and (2) do not to leave valuables in cars.

CPNO has \$13,874 in the bank. The Candler Bark Fun Run made \$612. If two remaining sponsors honor their agreement, the net will be \$1,112.

Turnout was low for the Fun Run due to rainy weather, but the Pet Parade was a success. Extra T-shirts from the Candler Bark are available from Mark Clement.

Rumors of a rape in Candler Park on March 25 cannot be verified with police.

The pool will open soon. First weekend is free admission. Memberships are encouraged.

The zoning committee met to discuss a request for rezoning to Planned Development Housing on McLendon (at Ferguson) at their May 3 meeting.

A large part of the meeting was dedicated to an update on the Candler Park Brook Project. Contractors have been hired

(Heavy Constructors Inc., along with Environmental Services Inc), and they will break ground as soon as they acquire all the necessary permits. Park Pride is managing the project and will post weekly updates on their website. The channelized creek will be replaced with an aboveground waterway featuring turns, rocks and appropriate plantings. It is going to get messy. Be prepared for the messiness associated with construction.

The pool will stay open throughout the project. The playground will be closed during certain phases of the work.

Currently the golf course is scheduled to be closed May 1 to November 1 for improvements to the irrigation system.

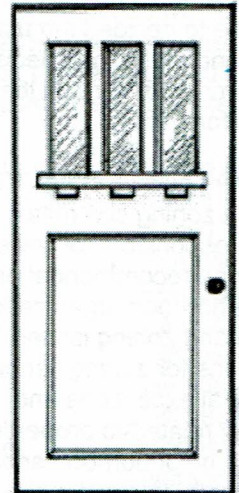
At next month's meeting there will be a vote on an amendment to the bylaws that will redefine the authority of the zoning committee.

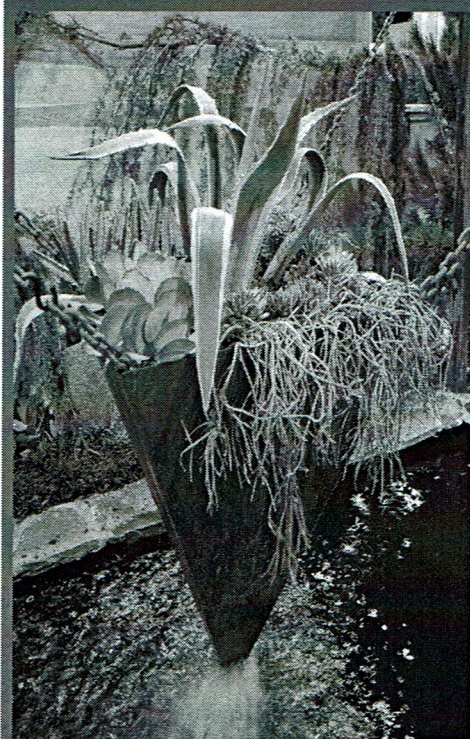

Public use of right-of-way for "storage bins"

Zone 6 APD Commander Propes advises CPNO that City of Atlanta Ordinance 138-61 (excerpt below) governs public right-of-way use for storage containers placement:

"Dumpster" means any container or storage box used for collection or removal of construction debris, demolition debris, or other discarded material. It shall be unlawful for any person to place a dumpster in the public right-of-way unless first obtaining a dumpster permit from the department of public works, which shall not be for more than six months. Applicant requesting an extension of time shall apply for a new permit.

Applicant must demonstrate to the commissioner of public works that dumpster cannot be accommodated on private property, present proof of insurance, and pay a permit fee of \$20, plus fee of \$10 - \$25 per calendar day (depending on linear footage used along adjacent curb lane), costs of blocked parking meters, signs or other traffic control measures. Dumpsters must clearly display provider's name and phone number, and maintain reflective marking on all four corners.

No dumpster shall be permitted within: 40' of bus stops; 20' of parking spaces for disabled persons; 20' of crosswalks; 30' of intersections; 15' of fire hydrants; or on any sidewalk unless alternative location is not feasible, would not create a safety hazard, or disrupt pedestrian or vehicular traffic, or damage property. Violators may incur revocation, fines up to \$1000 per day, and/or imprisonment up to six months.

APD encourages all Candler Park residents to become familiar with and take appropriate steps to ensure compliance with provisions of this ordinance.

NPU Report

At the April meeting of NPU-N, the board
voted

1) To approve a substitute ordinance by
Councilmember Anne Fauver that
would change the procedures for
neighborhood petitioning for the
installation of traffic calming devices
(06-O-0558). (While other NPUs have
voted to oppose this ordinance, many
of the concerns they raised in
opposition to the proposal were
related to portions of the ordinance
that are already in force instead of
addressing the proposed changes.)
The changes proposed would allow for
broader participation of neighbors in
petitions submitted for traffic calming
measures. The intent would be to
encourage more comprehensive traffic
calming plans endorsed the larger
community instead of piecemeal
measures endorsed by a small group
of neighbors on a small street
segment that might not be in the
overall best interest of the
neighborhood.

2) In opposition of a substitute
ordinance by Councilmember Natalyn
Archibong that would change the
procedures for obtaining a demolition
permit for a residential structure (06-
O-0470). While the new legislation
would require posting of demolition
permits for residential structures, it
would not provide any means of
appealing or blocking the issuance
of such permits. Therefore the proposed
ordinance was deemed meaningless,
and potentially harmful even, because
its adoption might give the impression
that real problems with the demolition
process had been addressed.

3) To approve an application for a liquor
license for Pacific Kitchen, a new
restaurant moving into the space
formerly occupied by Lush, 913
Bernina Avenue.

4) To approve an application for a
special exception to reduce the
number of required parking spaces
from 178 to 131 for a new restaurant
by Kevin Rathbun planned for the
Inman Alley project at 154 Krog Street
(Rathbones, a steakhouse).

We also learned that the City of Atlanta
has created a new Integrity Line.
Residents can call 1-800-884-0911 any
time 24/7/365 to report unethical,
fraudulent, or illegal acts by City of
Atlanta officials, employees, and
contractors. Reports can be made
anonymously, and complaints will be
received and investigated by an
independent company.
