New Pool Coming to Candler Park in 2007 !!!

On Friday, July 28, Karyl Clayton from the City of Atlanta Department of Parks, Recreation and Cultural Affairs came to the Candler Park Pool to discuss impending improvements to the Pool. Thanks to the \$105 million Parks and Greenspace Opportunity Bonds passed by City Council last year, nearly every City pool will undergo major renovations.

Twenty residents shared their ideas for what improvements they would like to see. The bath house was a major issue for all involved and is a point of emphasis for the City.

Three employees of Lord, Aeck and Sargent were at the meeting and volunteered their firm's services to design and oversee renovation of the pool house. This is great news for the pool!

The primary focus of the renovation will be to make the pool house comply with the Americans with Disabilities Act, while making the space cleaner and more inviting. The pool itself will undergo a nearly complete renovation, with the shell, gutters, pump, pool deck and chlorination system being replaced.

The city insists on these improvements, and those in attendance were only too happy to hear that Candler Park would have a rebuilt, good-as-new pool come next year.

There was consensus among those in attendance that the pool area would be greatly improved by the addition of shade and kiddie features. Karyl had a similar

assessment from the City's perspective and proposed moving the fence back toward the parking lot to accommodate a shaded picnic area and "spray features" for kids.

The spray features are similar to the fountain at Centennial Park and the flowers in the kids section of the botanical garden. They would provide a safe place for the very young to play, as well as a place for all kids to stay cool during adult swim.

To ensure continuing input from the community, there will be a survey up on the Candler Park web site. Tell us what you want to see at your pool. After all, the goal is to get YOU out to the pool.

The Candler Park Pool Association also is looking for some residents to get involved. Long-time pool stalwart Bert Bellinson is moving to Ohio where Robin will be going to graduate school. Now more than ever, the pool needs your help!

To help prepare for all these changes, the CPPA board will develop a new business plan and seek partnerships with community businesses. Take the survey and look for future notices on how you can help create the pool you want. For more information, visit the web site <http://www.candlerparkpool.com>.

You are going to be amazed at the changes to your pool. Come 2007, you will be able to walk just a few blocks to one of the newest, coolest, safest, and most enjoyable pools in Atlanta.

Ballots may be cast by current residents or property owner within one of the following neighborhoods: Reynoldstown, Cabbagetown, Candler Park, Lake Claire, Poncey-Highland, Inman Park, Little Five Points or Druid Hills (City of Atlanta).

Is Your Lightpost Damaged? Report It!

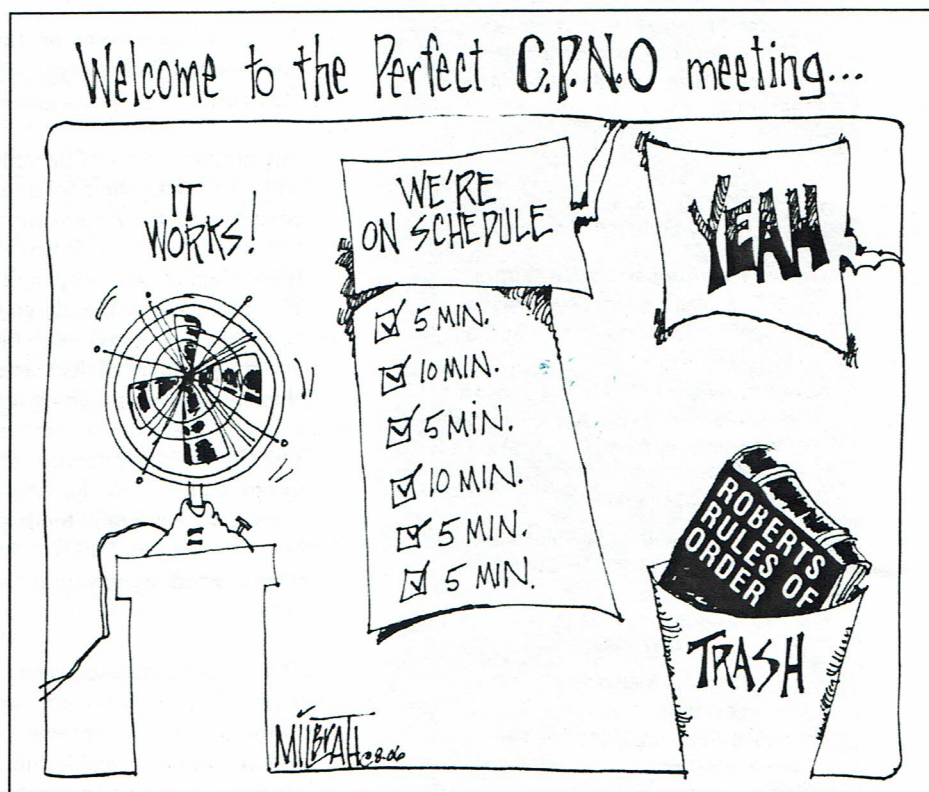

DeKalb County Soil and Water Conservation District – SSO Information

The DeKalb County Soil & Water Conservation District, a Georgia agency dedicated toward educating citizens on the protection of DeKalb county's natural resources, has produced a webpage to educate citizens on sanitary sewer overflows (SSO's).

The webpage is in a "frequently asked questions" format. Causes of SSO's, health impacts, and how to report SSO's are a few of the topics addressed at www.dekalbcountysso.com.

From a health perspective, it's critical that citizens recognize warning signs of SSO's, promptly document, and report sanitary sewer overflows to the local government.

Urban creeks tend to exceed federal Clean Water Act standards for fecal contaminants. Such levels of contaminants are detectable through laboratory testing. It's important that citizens are aware that a clear creek doesn't necessarily mean a creek is clean.

Children are at particular risk of adverse health effects associated with SSO's because of their natural curiosity around creeks, according to the webpage.

ARC Transportation News

An Atlanta Regional Commission bulletin reports that a Clifton Road corridor study is underway to explore transit alternatives.

In response to planned development and intense employment growth, Clifton Corridor Transportation Management Association (CCTMA) will begin a year-long Transit Feasibility and Connectivity Study later this summer. CCTMA received \$500,000 in federal funding for the study and will evaluate transit alternatives developed as part of an earlier transportation study of the corridor.

The study will assess feasibility of new transit service, including streetcar lines and a DMU commuter rail-type transit service within the CSX rail line. The study is a critical step in CCTMA's process to implement transportation alternatives and transit options in the corridor. Motions and More Motions – Minutes of the July CPNO meeting

The following are selected highlights from the minutes of the July 17, 2006 meeting of the Candler Park Neighborhood Organization. The complete minutes are available on the Candler Park website or by contacting the recording secretary.

The group discussed changing the official neighborhood boundary line between Candler Park and Lake Claire from the center line of Clifton Rd to the rear property line of the houses on the east side of Clifton Rd. One resident from the east side of Clifton spoke against the proposed change. No one spoke in favor of the change.

Two motions were approved: that CPNO communicate to the city, and that the CPNO representative report to the NPU, that Candler Park requests the center line of Clifton Rd remain as the official boundary line between the two neighborhoods.

Several voiced their concerns about having a decision of this magnitude decided by such a small group and/or without much input by the affected parties. One member pointed out that residents on the east side of Clifton would still be eligible to join CPNO under the current bylaws.

The group considered a variance application for 521 Terrace Ave to reduce the side yard setback from 7 ft to 3 ft to build a detached garage.

The applicants could have obtained a building permit for the structure without a variance but wished to shift the building over a few feet to decrease the impact on the roots of a tree.

The chairman of the zoning committee Randy Pimsler indicated that the committee's recommendation was approval of the variance contingent of the applicant obtaining approval signatures from additional neighbors.

There was discussion about procedure since the vote had not been officially advertised, and since the zoning committee no longer had the authority to make decisions on behalf of CPNO (after last month's vote to change the bylaws).

Ultimately, the application received a favorable if unofficial vote.

David Bruce stated that APD crime reports indicate quite a bit of crime on Caroline St and reminded neighbors to be alert when visiting the new Edgewood retail district.

NPU-N Report – July 2006

The following items from the July 27, 2006 meeting of NPU-N are those deemed most likely to be of interest to Candler Park residents.

The board voted to approve a variance application for 521 Terrace Ave to reduce the side yard setback from 7 ft to 3 ft to build a detached garage. The applicant indicated they would only need a 4 ft setback as they would be moving the structure over by one foot in response to suggestions from the next door neighbor.

When I informed the group that CPNO voted **not** to request that the city change the official neighborhood boundary line between Lake Claire and Candler Park from the center line of Clifton Rd to the rear property line of the houses on the east side of Clifton Rd, the City of Atlanta planner indicated CPNO would need to amend its bylaws to reflect this.

We approved a liquor license application for Shaun's, a small bistro opening at 1027-1029 Edgewood Ave (formerly The Patio).

We again deferred voting on the rezoning applications for the Northeast Beltline Parcels 4 and 5 as the adjacent neighborhoods continue negotiations with the developer.

The City of Atlanta raised water and sewer rates by 10% on July 1. In addition, some residents have recently received shockingly high bills as the Watershed Dept is apparently trying to recoup costs due to underestimating past charges for those with nonfunctional meters. The Dept allegedly knew meters were not functioning but did not fix them or notify the property owners. Contact Melinda Langston at 404-330-6773 for assistance if this happens to you.

We approved a rezoning application for 850 Euclid Avenue (in Inman Park) that would allow the conversion of the Lizzie Chapel into a three-story, ten-unit condominium complex, supposedly only the second such conversion in the city.

We were informed that, in order to comply with state law, City Council is working on legislation that will allow an interested party to receive a Cemetery or Burial Ground Disturbance Permit for the purpose of developing such land.

CPNO By-Law Revision Pending

According to City of Atlanta officials, Candler Park Neighborhood Organization has a limited period of time to consider how to conform its own bylaws to the most recent interpretation of NPU-N by-laws requirements, which are intended to permit all NPU-N eligible members to participate in its constituent member organizations in matters to be referred to City of Atlanta agencies, including land use matters, ordinance amendments and licensing matters.

CPNO board members will strive to recommend in September changes to relevant portions of CPNO's current bylaws, in an effort to comply with NPU-N's request and City of Atlanta guidelines, while preserving the benefits of amendments adopted in late 2005 intended to ensure that CPNO was in compliance with State of Georgia laws of corporations, and to stabilize and enhance annual funding of key initiatives through membership dues.

Major Propes reported they caught a man on Sterling who has a history of breaking into cars in East Lake. She indicated the police do sweeps of Candler Park nearly every night when the park is closed after 11 pm.

She reported that the suspect in a recent purse snatching near the corner of Oakdale Rd and North Ave (black male, 5'9", 160 lb) is still at large.

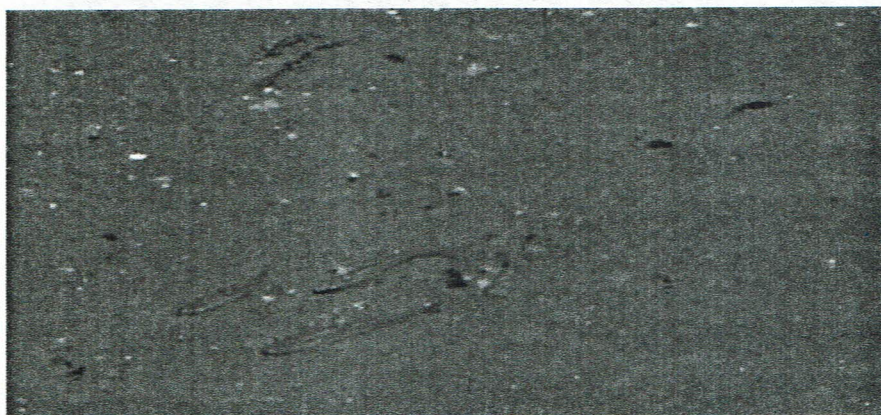

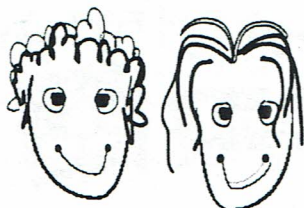

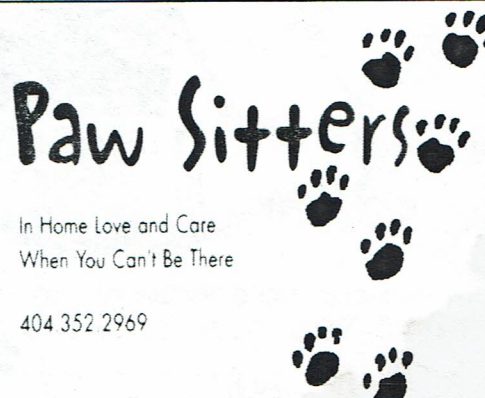

Carter Center Events in August – Authors and Pictures

Coming in August are two exciting photographic exhibitions. "Diana Walker: Photojournalist" opens on Saturday, August 26th. For twenty-five years, Diana Walker covered the White House, photographing five Presidents and their family in public and private moments. The exhibition includes 83 selected photographs and nine magazine covers from Walker's vast collection.



Show Me The Money --- The Treasurer Makes His 6-Month Report

The Candler Park Neighborhood Organization, from November 15, 2006 to the end of June, has been running in the black. But, as has been the case with our organization for a number of years, the financial health of the organization is dependent on the success of the Fall Festivals.

CPNO began the year in fairly good shape. We had \$13,838.30 in the bank (as a result of a successful 2005 Fall Festival season.) As of June 30, we were in even better shape, if you just look at our bank account. The amount resting in our account at that time was \$15,586.21. Not included in this number is the \$7,000 owed to CPNO by the Candler Park Pool Association.

The Fall Festival Committee, whose financial records are not a part of this report, has indicated their belief that they will not be required to tap into CPNO's general fund to run the Fall Festivals. At this time, it is anticipated that sponsorships and booth rentals for the Festival will provide all the necessary up-front funding for the Festival's expenses. But, circumstances do change, and it is quite possible that the membership will be asked to make a contribution to fund some FallFest costs at the September meeting.

How has CPNO managed to increase its account balance during the past six months? Part of the answer is the institution of

membership dues. Dues netted the organization \$2,375 up until June 30. But, a bigger factor in our financial success has been that *The Messenger* has been unusually profitable. The cost of printing *The Messenger* is a fairly high \$3,570.43 (and that cost is high enough for the publisher to consider other printing options). But the ad revenue is a very healthy \$7,494.50. This has netted the organization revenue on *The Messenger* of \$3,924.07.

Other sources of revenue are listed below:

During the first part of the year, we held one fundraiser – the second annual Candler Bark. A good time was had by all and everyone loved the event. The problem was that the morning of the event dawned with a series of thunderstorms. While the weather cleared by the time of the event, all the folks who would ordinarily have entered on the day of the event did not turn up. Result? Our fundraiser ended up raising

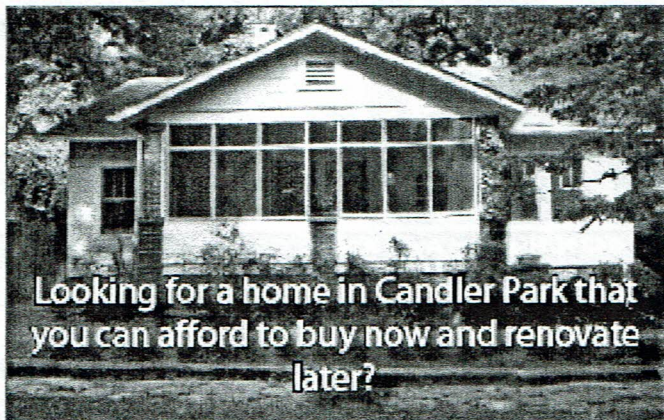
a modest \$461.80. The event proved a lesson in one respect – beware of depending too much on an outdoor event as a fundraising source.

So, where does CPNO spend its money? Exclusive of expenses for the Candler Bark and *The Messenger*, it breaks down as follows:

The membership, as can be seen, has not been profligate with its expenditures. Nevertheless, because of its limited income, and a requirement to keep amounts in reserve to fund FallFest expenses, CPNO has not been able to spend as much as would be desirable on things in the neighborhood that need fixing, such as sidewalks and the like. Most of our expenditures seem to be administrative or for fundraising.

Dog Waste Is Raw Sewage: Scoop The Poop, Bag It, Place It In The Trash

Over the past few years, the topic of dog poop has come up in CPNO meetings, usually causing embarrassed giggles from some, frustrated eye-rolling among others. After all, the subject is pretty disgusting, and everybody whose Momma raised them right knows that what they are supposed to do with what their best friend leaves behind them.

Apparently, however, some walking their friends in Candler Park or Freedom Park have not been listening to their Momma. The result, according to some City of Atlanta officials, is runoff that is causing the creek pollution noted in last month's *Messenger*. Not everyone is convinced that's the only cause of the problem. Nevertheless, it might be helpful to remind folks of the goodies that might be found in Rover's deposits:

Roundworms, Toxocariasis – Causes VLM (visceral larva migrans) leading to hepatomegaly, myocarditis, nephritis, pulmonary inflammation, and blindness, usually in children.

Roundworms – Causes severe neurological form of VLM, especially in young children.

Hookworms—Causes spreading lesions and severe pruritis. In rare instances can cause

symptoms like VLM.

Cryptosporidium parvum -- Self-limiting gastroenteritis, protracted in susceptible individuals.

Campylobacter spp.-- Mild to severe, bloody diarrhea.

E. coli, Fecal coliform bacteria-- Bloody diarrhea, severe cramps, HUS (leading to kidney failure), and TPC.

Giardia, Giardiasis -- Diarrhea, cramps, flatulence, nausea, steatorrhea. Can be protracted and debilitating.

Salmonella spp. -- Usually mild gastroenteritis within 6-48 hours.

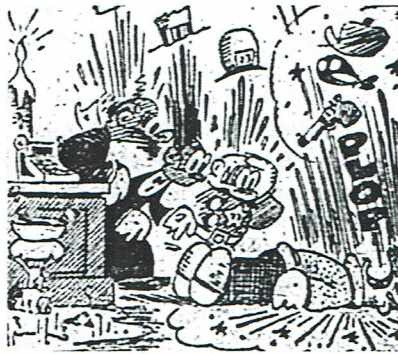
Yersinia enterocolitica -- Gastroenteritis.

Leptospirosis -- Usually mild fever but complications can be serious, including hepatitis, jaundice, meningitis, and kidney failure.

Yes, scooping it up is a pain. But leaving all these bacteria and bugs for unsuspecting children is worse. Please scoop it up. - *Alonzo Church III*

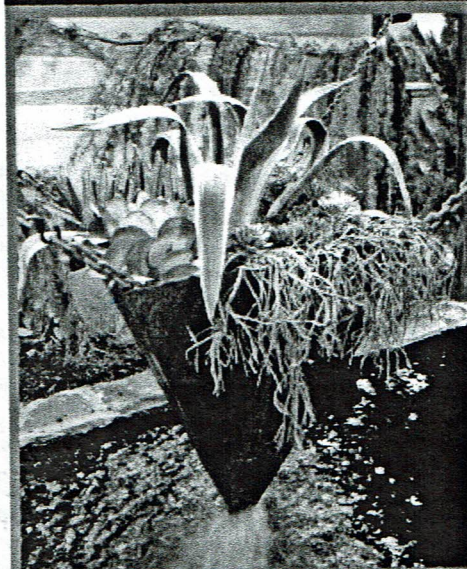
