This month we have several organizations making presentations to CPNO. The first group is the PATH Foundation. Construction is scheduled to begin November 1st on the bike path, previously approved by CPNO, that will run through the Freedom Parkway land. The path will start at Moreland Ave. and run to through the new park land south of North Ave to S. Ponce de Leon Ave. PATH representatives will be able to answer any questions we have at the meeting.

Second on the agenda, Hands On Atlanta will present a plan for a new partnership between HOA, Park Pride and CPNO. The partnership will kick-off with projects in the park on Hands On Atlanta Day in October. We have approximately \$1550 from this year's race and last year's golf tournament to put towards refurbishing the volleyball courts, building stairs to the courts, etc. We will be looking for ideas, volunteers to organize the day and volunteers to show up for the day. 

Tensions Rise In L5P

By now, most of you are aware of the growing tensions in L5P between some of the business owners an a loosely associated group the business owners have dubbed the 'Bubble Gum Posse'. The BGP has been referred to as a gang, but is NOT one in the organized sense of the Bloods or the Crips. They are a loose group of roughly 25 people ranging in age from teens to 50s, of different races, some homeless, some not, who spend the vast majority of their time hanging out in L5P. These tensions were brought to the forefront by the July shooting in Fellini's.

Several business owners have been concerned about the changes in the milieu of L5P as the BGP has made a stronger presence there. These business owners' complaints include harassment of patrons, loitering, drug trafficking, burglary, public drunkenness, bongo playing, retaliation against law enforcement, but mostly of the creation of an environment they feel is threatening, hostile and uninviting to their customers.

The business owners' efforts at using current laws to have offending parties arrested (many have been arrested numerous times for charges such as public drunkenness, violations of noise ordinances, drug trafficking, burglary and assault) have been stymied by the limited availability of jail space for non-violent offenders.

Currently, a group of the business owners, CPNO, Inman Park Neighborhood Organization, City Councilwomen Mary Davis and Debi Starnes, Atlanta Police Department's Major Banda and State Representative Mike Polak are investigating possible changes in laws and enforcement to make the atmosphere more inviting in L5P to the residents of the surrounding neighborhoods.

Candler Park is obviously negatively affected by crime, and positively affected by the proximity of a thriving business district. Thus, these issues directly affects all of us in the neighborhood. 
