Attention: Page Avenue Residents

In the past several months. Page Avenue residents have lost beloved pets, adding to the numbers of cats and dogs already killed by speeding cars on ours street. Clearly, w must continue our pursuit of a way to deter excess traffic and slow cars down on Page Ave. In accordance with the neighborhood consensus, residents investigated installing stop signs at each intersection along the street. According to a letter from the City of Atlanta Public Works sent on Aug. 19th to resident Mike Miller, Page does 'not meet the conditions' for all-way stop signs at its intersections with Muriel Ave., Harriet Ave., and Marlbrook Drive. Since our street does not meet the necessary criteria for stop signs, speed humps remain the only other viable option for controlling traffic. We remain committed to pursuing the possibility of having the humps installed on our

Once again, the entire length of Page Ave. will be evaluate for speed hump eligibility. The results will be published in the Messenger. If the results indicate that Page Ave. is still eligible for speed humps, the following additional steps, as outlined by the City of Atlanta, will take place:

- · Define the speed hump service area
- Identify specific speed hump locations
- Conduct a preliminary meeting with neighborhood representative(s)
- Notify neighbors within the defined service area of the scheduled meetings
- Conduct the neighborhood meeting
- Await receipt of the official petition
- from neighborhood representative(s) to proceed with the process
- Receive the petition from the neighborhood representative(s)
- Add street segment to spreadsheet for installation
- Conduct a post-installation evaluation
